Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Omaha Zoological Society Retirement Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

December 31, 2024 and 2023

1. Plan Description

The following brief description of the Omaha Zoological Society Retirement Plan and Trust (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits to the employees of the Omaha Zoological Society and the Omaha Zoo Foundation (collectively, the Company).

Employees are eligible to make voluntary pre-tax and Roth after-tax salary deferral contributions after attaining 21 years of age and completing one month of service. Eligible employees may become participants on the first day of the month following the date on which eligibility requirements were fulfilled. Participants are also eligible for safe harbor contributions after attaining 21 years of age and completing one year of service with 1,000 hours. Participants are also eligible for discretionary matching contributions and discretionary profit-sharing contributions after attaining 21 years of age and completing one year of service regardless of hours (prior to January 1, 2024, participants were required to have 1,000 hours).

Also, effective January 1, 2024, the discretionary matching contributions are limited to a maximum of 4%.

Contributions

Participating employees may make voluntary salary deferral contributions up to the maximum dollar limits allowable by law. Participants may also contribute amounts representing distributions from other qualified plans. All participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions.

The Plan is a “safe harbor 401(k) plan” whereby the Company will make safe harbor contributions equal to 3% of eligible compensation. The Company may also make additional discretionary matching contributions and discretionary profit-sharing contributions. The discretionary profit-sharing contributions are based on the percentage of the participant’s compensation determined by the participants’ years of service as follows:

<u>Years of Service</u>	<u>Percentage Contributed</u>
1 to 4	0%
5 to 9	1%
10 or more	2%

Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of a) the Company's safe harbor contributions, b) the Company's discretionary matching contributions and discretionary profit-sharing contributions and c) Plan earnings or losses. The Company's safe harbor contributions are allocated among participants based upon eligible compensation of participants. The Company's discretionary matching contributions are allocated based on each participant's elected salary deferral. The Company's discretionary profit-sharing contributions are allocated among participants based upon a years of vesting service formula and eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Lincoln Financial Group Trust Company, Inc. (Lincoln Financial), the current custodian, and United of Omaha Life Insurance Company (United), the former custodian. See Note 9 for the description of the custodial change.

Vesting

Participants are vested immediately in their contributions and Company safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions are credited to participants' accounts based on years of continuous service. Participants are 20% vested after one year of credited service and vesting increases 20% per year until a participant is 100% vested after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest payments are made through payroll deductions.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive a lump sum payment equal to the value of the vested funds allocated to the participant's account. The Plan requires that distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Participants can also receive in-service distributions, as permitted by the Plan document. Benefits are recorded when paid.

Deposits with Insurance Company

The guaranteed investment contracts, which are part of the investment contract with Lincoln Financial as of December 31, 2024 and United as of December 31, 2023, credit interest daily. The average crediting interest rates during the years ended December 31, 2024 and 2023 were 2.30% and 2.80%, respectively. The crediting interest rate is reset upon the maturity of the contract. See Note 9.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of their Company discretionary contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to pay Plan expenses or reduce future Company contributions. During 2024 and 2023, administrative expenses were reduced by \$0 and \$253, respectively. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plan*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Company invests in investment contracts through guaranteed investment contracts with United and a stable value option with Lincoln Financial.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration of notes receivable from participants and other account activity are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 22, 2025, noting no items requiring disclosure.

3. Information Certified by Lincoln Financial and United (See Note 9)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Lincoln Financial and United, except for comparing such information certified by the custodians to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurement and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
 - Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the funds. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their Net Asset Value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at the NAV of their underlying investments. The accounts include investments in fixed securities, mutual funds, common stocks, or real estate which have observable Level 1 or Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. FASB ASC 820, *Fair Value Measurement*, allows NAV per share to estimate the fair value as long as certain requirements are met. It is the Plan’s assessment that these accounts meet those requirements. Since the participants have the ability to redeem the accounts at NAV, as of the measurement dates on a daily basis, the accounts are properly categorized as a Level 2 fair value measurement. The accounts also have no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract with Lincoln Financial and United

At December 31, 2024, the Plan has a stable value fixed option investment contract with Lincoln Financial, with underlying investments of guaranteed investment contracts. This investment contract is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Lincoln Financial.

At December 31, 2023, the Plan had an investment contract with United. United maintained the contributions in pooled separate accounts and guaranteed investment contracts. The accounts were credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses charged by United.

As the guaranteed investment contracts with both Lincoln Financial and United are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by Lincoln Financial (2024) and United (2023), represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

6. Tax Status

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distribution of account balances to participants would be made as soon as practicable after the termination date.

8. Related-Party Transactions

At December 31, 2024, certain Plan investments are shares of mutual funds and guaranteed investment contracts managed by Lincoln Financial. Lincoln Financial is the current custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. At December 31, 2023, certain Plan investments were pooled separate accounts with underlying shares in mutual funds and guaranteed investment contracts managed by United. United was the former custodian as defined by the Plan, and therefore, these transactions qualified as party-in-interest transactions.

9. Change in Custodian and Asset Transfer

Effective June 17, 2024, Lincoln Financial was appointed as the new trustee and custodian of the Plan. The conversion initiated a "Black Out" period beginning June 7, 2024 and continued through July 12, 2024. During the Black Out period, funds could not be applied to the employee selected funds or withdrawn from the Plan until Lincoln Financial had time to accurately complete the conversion. Employee contributions continued to be made through payroll deductions, and contributions were held in the Company's bank account until completion of the Black Out period, at which those funds were wired to Lincoln Financial and invested as requested.
