NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Coastal Energy Corporation (the "Company") 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who have three months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions

Each year, participants may make contributions through elective deferrals based on their annual compensation and have the option to make contributions on a pre-tax or post-tax (Roth) basis. Employee deferrals are limited to the maximum allowable by Internal Revenue Service regulations related to defined contribution plans. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Each year, the Company may elect to make a matching contribution to be determined by the amount of participant contributions made during the plan year.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation at their discretion.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, if any; (b) plan earnings, and charged with an allocation of administrative expenses; and (c) forfeitures of terminated participants' non-vested accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral contributions plus earnings thereon. Vesting of the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of service. An employee is fully vested after six years of service, as detailed in the following vesting schedule:

The non-vested portion of participants' account balances, which is forfeited upon termination prior to retirement, death, or becoming fully vested, is used to reduce future employer contributions.

Payment of Benefits

The Plan provides that a participant will receive a lump-sum amount equal to the value of his or her account as soon as administratively practical.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan uses the accrual method of accounting. Accordingly, revenues are recognized when earned and expenses when incurred.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America may require management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation

(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

There were not excess contributions payable for the years ended December 31, 2024 and/or 2023.

Tax Status

The prototype plan, under which the Plan operates, obtained its latest determination letter on January 1, 2016 in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. The Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Subsequent Events

Subsequent events have been evaluated through October 3, 2025 which is the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of quoted prices for similar assets in active and/or inactive markets,

and Level 3 inputs consist of significant unobservable values and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Level 1 Fair Value Measurements

The fair values of common stocks, certain corporate bonds, and U.S. government securities are based on the closing price reported in the active market where the individual securities are traded, when available.

Level 2 Fair Value Measurements

Inputs to this valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in financial markets; inputs other than quoted prices that are observable for the asset(s); and inputs that are derived principally from (or corroborated by) observable market data by correlation or other means. If the asset has a term associated with it, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are not observable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Corporate bonds: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Mutual funds/exchange traded funds (ETFs): Valued at the daily closing price as reported by the fund. Mutual funds/ETFs held by the Plan are open-end mutual funds/ETFs that are registered

During the years ended December 31, 2024 and 2023, the Company paid for certain legal, accounting, and other services related to the Plan which are not reflected in the financial statements. Additionally, all of the Plan's investments were held by Capital Group American Funds, which represents a party-in-interest under ERISA.

NOTE 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions to the Plan at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested.

NOTE 8: DISTRIBUTION OF FORFEITURES

Forfeitures result from the non-vested portion of participant distributions and occur when an employee terminates before they are fully vested. Non-vested forfeitures are used to reduce any employer contributions. The amount of forfeitures were \$16,146 and \$9,766 for the plan year ended December 31, 2024 and 2023, respectively.

NOTE 9: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the participants account balances and the amounts reported in the statement of net assets available for plan benefits. Because investments are participant-directed, the Plan's exposure to losses is limited to the balances in the participants' accounts.

NOTE 10: UNCERTAIN TAX POSITIONS

The Internal Revenue Service (IRS) has determined and informed the Company that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan's Form 5500 filings are subject to possible examination by the taxing authorities until the expiration of the related statute of limitations on those returns. In general, each return has a three-year statute of limitations. The Plan's management is not aware of any other uncertain tax positions.

NOTE 11: INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The accompanying financial statements and supplemental schedule include information that was obtained from data that has been prepared and certified as complete and accurate by Reliance Trust Company. Information certified as complete and accurate includes investments at fair value as well as investment income as of and for the years ended December 31, 2024 and 2023.
