INDEPENDENT AUDITOR'S REPORT

To the Trustees and Management of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Employees' Profit Sharing Plan of Ace Hardware (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.



NOTE A – DESCRIPTION OF PLAN

The following description of the Employees' Profit-Sharing Plan of Ace Hardware Home Center (the "Plan") provides only general information. Participants and readers should refer to the Plan document and Summary Plan Description (SPD) for a more detailed description of the Plan provisions. The Plan is subject to the *Employee Retirement Income Security Act of 1974 (ERISA)*.

General and Eligibility

The Plan is a defined contribution plan covering all qualified employees of Ace Hardware Home Center and its related entities (collectively the "Plan Sponsor") (Ace Hardware of Mundelein, Inc., Ace Hardware of Libertyville, Inc., Ace Hardware of Gurnee, Inc., Ace Hardware of Wauconda, Inc., Ace Hardware of Waukegan North, Inc., Ace Hardware of Grayslake, Inc., Ace Hardware of Antioch and Ace Hardware of McHenry) who have completed one year of service and one thousand hours of service. Participants can begin the deferral of voluntary contributions when they have completed 1 year of service. Once the service requirement is met, participants may enter the Plan on the first day of the following quarter. The Plan became effective January 1, 1976, and has been periodically amended to conform to new laws and regulations under ERISA.

Contributions

Employee contributions are voluntary and limited to the maximum allowed under the Internal Revenue Code.

The Plan Sponsor may make a discretionary matching contribution equal to a uniform percentage of participant's salary deferrals. Each year, the Plan Sponsor will determine the amount of the discretionary percentage but will not exceed 5 percent of a participant's compensation. There was a discretionary matching contribution of \$94,273 and \$97,619 for the years ending December 31, 2024 and 2023, respectively.

The Plan Sponsor may make a discretionary profit-sharing contribution to eligible employees. There was no discretionary profit-sharing contribution for the years ending December 31, 2024 and 2023.

Additionally, the Plan may accept rollover contributions. Participants will always be 100% vested in their rollover accounts, though those funds will be affected by any investment gains or losses.

Participants' Accounts

Each participant's account is credited with the respective participant's contributions, any employer contributions (match and profit sharing), and allocated Plan earnings, as set forth in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Vesting

Participants are immediately vested in their voluntary and safe harbor matching contributions plus actual earnings thereon. Participants become 100% vested in the Plan Sponsor discretionary contributions (profit sharing and matches on elective deferrals) upon completion of 6 years of service.

The participant's vested percentage in their account attributable to profit sharing and matching contributions (non-safe harbor related) contributions are determined under the follow schedule:

Hardship Withdrawals

Hardship withdrawals may be made to satisfy certain immediate financial needs, according to specific types of costs and set conditions designated in the Plan. Hardship distributions can only be made from accounts which are 100% vested.

Investment Options

Participants may direct the investment of their account balances and future contributions and Employer contributions into various investment options offered by the Plan. Participants are allowed to change their investment options daily.

Payment of Benefits

Generally, benefits are paid to participants upon termination of service due to death, retirement, or separation of service. Account balances less than \$5,000 are subject to payment in a lump sum upon termination. While the account and timing of payments will vary depending on the option selected, the total payment will have the same dollar value equivalent to the value of the participant's account at retirement.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants are permitted to take loans from the Plan up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Related fees are charged directly to the borrowing participant's accounts and are included in administrative expenses when incurred. The loans are collateralized by the borrowers' respective vested account balance and bear interest rate of between 4.25% and 10.25%. Principal and interest are paid through payroll deductions over a period not to exceed five years, unless for the purchase of a primary residence. Related interest income totaled and \$8,999 and \$7,678 for the years ended December 31, 2024 and 2023, respectively.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Plan Sponsor, as provided by the plan document. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Certain administrative fees and expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Plan Termination

Although the Plan Sponsor has not expressed intent to terminate the Plan, it may do so at any time. If the Plan is terminated, participants become 100 percent vested in their accounts and the net assets would be distributed to the participants according to the balances in the participants' accounts.

Forfeitures

Forfeitures of non-vested discretionary contributions, when not used to reduce employer matching contributions, will be used to pay administrative costs of the Plan or reallocated amongst the remaining participants. There were \$1,993 and \$1,536 of forfeitures included in investments in the accompanying statements of net assets available for benefits for the years ended December 31, 2024 and 2023, respectively. No forfeitures were used to pay Plan expenses during the years ended December 31, 2024 and 2023.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires Management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that change in the value in investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value based on quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year, assets held during the year, and interest and dividend income.

Payment of Benefits

Benefits are recorded when paid.

Reclassifications

Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation with no effect on previously reported net increase in net assets available for benefits.

NOTE C – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under this provision of ERISA, investment information and related activity certified as accurate and complete by a qualified institution need not be subjected to independent audit.

The Plan administrator has obtained a certification from Empower Trust Company, as trustee of the Plan that the following information included in the Plan's financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participant accounts as of December 31, 2024 and 2023;
- Plan transactions related to investment income and securities transactions and interest income on notes receivable from participant accounts for the years ended December 31, 2024 and 2023;
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

Accordingly, at the request of the Plan administrator, the Plan's independent certified public accountants performed no procedures on investment information and related activity, other than to agree the information to the trust statements certified by the Plan's trustee and provided to them by the Plan administrator.

NOTE D – FAIR VALUE OF MARKET INVESTMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurement and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Variable Annuities: Prices/unit values are calculated daily by the annuity provider according to the methods described in the annuity contract. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation: dividing the net assets by the number of units outstanding. Any discrepancies between the two unit values are resolved to ensure the recordkeeping system reflects the accurate value for the day.

NOTE E – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered a fully benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Since this contract meets the fully benefit-responsive contract criteria, the contract is included in the financial statements at contract value as reported to the Plan by Empower. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rate was 2.80% and 1.35% as of December 31, 2024 and 2023, respectively.

Certain events may limit the ability of the Plan to transact at contract value with the participant. Such events include, but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification. The Plan Sponsor does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE F – TAX STATUS

Effective January 1, 2021, the Plan was restated with its then existing provisions to the Definiti LLC Non-Standardized Pre-Approved Profit-Sharing Plan with CODA Plan Document. The pre-approved Plan document utilized by the Plan obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan is acceptable for use by employers for the benefit of their employees under Internal Revenue Code Section 401.

The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believes the Plan is qualified and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax position taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain position taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. For federal purposes, the tax returns essentially remain open for possible examination for a period of three years after the respective filing deadlines of those returns. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE G –PARTY-IN-INTEREST TRANSACTIONS

Plan investments are held by Empower, which is the trustee and agent as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment. MML Investors Services, Inc. is the investment advisor, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Empower is the Plan record-keeper, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

NOTE H – SUBSEQUENT EVENTS

Management of the Plan has evaluated events subsequent to the statement of net assets available for benefits date of December 31, 2024, through September 30, 2025, the date the financial statements were available to be issued. It has been concluded that there are no effects that provide additional evidence about conditions that existed at the statement of net assets available for benefits date that require recognition in the financial or related note disclosures in accordance with FASB ASC 855, Subsequent Events.
