Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Carroll County Memorial Hospital Employees 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Carroll County Memorial Hospital Employees 401(k) Plan (the "Plan"), provides only general information. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Carroll County Memorial Hospital (the "Company" or "Plan Sponsor"), except for leased employees and employees subject to a collective bargaining agreement. The original effective date of the Plan is October 1, 1977. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Matrix Trust Company serves as the Plan's trustee and custodian. One America Retirement Services, LLC ("One America") serves as the Plan's recordkeeper and third-party administrator.

Eligibility – An individual is immediately eligible to participate in the Plan after attaining the age of 21. Employees must complete one year of service to become eligible for employer matching contributions, with entry for employer matching contributions the first day of the month coinciding with or next following the completion of the eligibility requirements.

Contributions – Participants may contribute up to certain limits prescribed by the Internal Revenue Code ("IRC"). Participants over age 50 are permitted to make catch-up contributions, as defined in the Plan.

The Company made a safe harbor matching contribution to the Plan in 2024. The Company matched 100% of the first 3% and 50% of the next 2% of each participant's pay contributed to the Plan. Additionally, in 2024, the Company contributed a discretionary matching contribution of 100% of the first 3% and 50% of the next 2% of each participant's pay contributed to the Plan.

Participants' Accounts – Each participant's account is credited with the participant's voluntary contribution, the employer contribution, and an allocation of investment earnings, and is charged with participant's withdrawals and distributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Options – Participants direct their elective contributions and Company contributions into any of the investment options offered by the Plan. The Plan offers mutual funds, a money market fund, and a group annuity contract as investment options.

Vesting – Participants' contributions and safe harbor contributions and earnings thereon are fully vested at all times. Vesting of the Company's discretionary matching contribution plus actual earnings thereon is based on years of continuous service. A participant vests in 20% increments, with 20% vested after 2 years of service, and is 100 percent vested after six years of service. In order to be credited with a year of service, a participant must complete a minimum of 1,000 hours of service during the Plan year. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, Company contributions become fully vested.

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeiture amounts are used to pay Plan administrative expenses and to reduce future Company match contributions. As of December 31, 2024 and 2023, there is \$1,329 and \$8,310 in the forfeitures account, respectively. During the year ended December 31, 2024, forfeitures in the amount of \$8,135 were used to reduce Company match contributions.

Payment of Benefits – Upon termination of service, the participant, or in the case of death, the participant's beneficiary, may elect to receive the vested value of the participant's account in either a lump-sum payment or as installments. If the vested portion of the account balance is less than \$5,000, the participant's vested account balance will be automatically distributed if the participant does not elect to roll-over the balance to another qualified plan. Balances between \$1,000 and \$5,000 will be automatically rolled over to an IRA account.

In-Service Withdrawals – The Plan allows in-service withdrawals for participants who are at least 59½ years old. The Plan also allows for hardship withdrawals to Plan participants meeting specific conditions, as defined in the Plan Document. Hardship withdrawals are limited to the participant's elective deferral account.

Notes Receivable from Participants – Participants may borrow a minimum of \$1,000 and a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years, but may be longer if the loan is for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear an interest rate comparable to the rates charged by lending institutions in the same geographic locale as the Plan Sponsor. Principal and interest is paid ratably through payroll deductions. Participants may have no more than one loan outstanding at any one time.

Administrative Expenses – Either the Plan or the Company may pay the administrative expenses of the Plan. In 2024, the Plan paid \$89,747 in administrative expenses.

Other Income – A revenue sharing agreement is in place whereby fees earned by the mutual fund companies are shared with the recordkeeper based upon a percentage of assets under management. These amounts are used for the benefit of the Plan to pay administrative expenses. During 2024, \$1,820 was received by the Plan under this revenue sharing agreement and this amount was used to pay a portion of the investment management fees.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. Upon such termination of the Plan, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Contributions – Contributions are recorded in the year service is rendered by the participant.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distribution based upon the terms of the Plan document. No allowance for doubtful account is considered necessary.

Payment of Benefits – Benefit payments are reported in the year paid.

Date of Management’s Review – Subsequent events have been evaluated through September 18, 2025, which is the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies at December 31, 2024 and 2023.

Mutual Funds and Money Market Fund – Valued at the net asset value (“NAV”) of shares held by the plan at year end based on published quoted prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan's investments are reported at fair value as follows at December 31, 2024 and 2023.

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Matrix Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value and contract value
- Net appreciation on fair value of investments
- Notes receivable from participants and related interest income
- Dividend and Interest income
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

6. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a group annuity contract with American United Life Insurance Company (“AUL”), a fully benefit-responsive investment contract issued by AUL. The group annuity contract is valued at contract value. Contract value is the sum of amounts invested, less withdrawals, plus interest computed at the fixed rate. The contract offers a fixed interest investment option through AUL’s general account. Interest rates for the AUL Stable Value Account are declared quarterly, and earn the declared rate until the end of the calendar year next following the current year. At the end of the calendar year next following the current year, the quarterly rates are converted to an annual interest rate, which is then adjusted on an annual basis. No more than 20% of a participant’s balance invested in the AUL Stable Value Account may be transferred during the year, unless the balance is less than \$2,500, in which case the entire amount may be transferred during the Plan year.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events may limit the ability of the Plan to transact at contract value with the issuer. The Plan administrator believes that any events that would limit the Plan’s ability to transact at contract value with participants are unlikely to occur.

7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Plan investments include a stable value account managed by AUL. AUL is a subsidiary of One America, and therefore, these transactions qualify as party-in-interest.

The Plan pays certain fees to One America to administer the Plan. These transactions qualify as party-in-interest. Notes receivable from participants are party-in-interest transactions.

8. TAX STATUS

The Company adopted a Non-Standardized Pre-Approved 401(k) Profit-Sharing Plan which received a favorable opinion letter from the IRS on August 19, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. SUBSEQUENT EVENT

The Plan was amended effective July 1, 2025. The Plan was amended to require employees to complete 30 days of service to become eligible to participate in the Plan. The eligibility age requirement remained age 21.
