## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants in the  
Sherloq Solutions, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Sherloq Solutions, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ## **1. DESCRIPTION OF PLAN**

The following description of the Sherloq Solutions, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the official Plan document for complete information.

### **General**

The Plan is a defined contribution plan covering substantially all employees of Sherloq Solutions, Inc. and any adopting affiliated company (the “Company” or “Sponsor”), except for union employees or nonresident alien employees, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

### **Eligibility and Participant Contributions**

Employees of the Company are eligible for participation in the Plan if they have attained age 21 and have completed 90 days of service, as defined. Participants may enter the Plan the first day of the Plan year quarter coinciding with or next following the date the eligibility requirements are satisfied. Participants may direct their contributions, as well as their allocable Company contributions into any investment option offered by the Plan.

Participants may elect to defer up to 100% of compensation, before taxes, subject to certain Internal Revenue Code (IRC) limitations. An employee may terminate his or her election to participate at any time. Participants may also elect to make supplemental catch-up contributions, subject to IRC limitations. Employees may roll over into the Plan amounts that represent a “qualified total distribution” or a complete distribution from an individual retirement account or individual retirement annuity, as defined by the IRC and the Plan.

The Plan also includes an automatic deferral feature. In the event a participant does not elect an alternative salary reduction rate or elects not to defer under the Plan, the Company will automatically withhold 1% of the participant’s eligible compensation, which will increase by 1% each Plan year up to the maximum of 6% unless the participant elects otherwise.

The increase in the amount automatically withheld from a participant’s pay will be effective on the first day of the Plan year, beginning with the first Plan year following the date deferrals were first automatically withheld from the participant’s pay.

### **Company Contributions**

All Company contributions are discretionary. The Company may elect to provide a matching contribution in an amount equal to a percentage of a participant’s elective deferrals. The elective deferral matching percentage for 2024 is 50% of the first 4% of compensation the participant contributes to the Plan.

The Company may also make a discretionary additional matching contribution. There were no discretionary contributions made to the Plan during the years ended December 31, 2024 and 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings, and is charged with withdrawals, recordkeeping fees, administrative fees, and an allocation of Plan losses. Allocations are based on participant earnings (losses) or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon, as well as the Company's matching contributions.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts up to a maximum of \$50,000, or 50% of their account balance, whichever is less. The minimum amount that can be borrowed is \$1,000. The loans are secured by the account balance. Repayments of the loans are made in substantially equal payroll deductions amortized over the life of the loan.

**Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. The Plan also provides for in-service distributions upon a qualified hardship, attainment of normal retirement age of 65, or at age 59-1/2. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Plan Administration**

The Plan is administered by the Company. Empower Annuity Insurance Company of America (the "trustee") is the custodian of the Plan, except for the self-directed account which is held by Charles Schwab.

**Forfeitures**

The Plan will use forfeitures to reduce plan expenses and future Company contributions. As of December 31, 2024 and 2023, forfeited balances were approximately \$16,000 and \$13,800, respectively.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fixed annuity contract which is valued at contract value. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Reclassifications**

Certain minor reclassifications have been made to the 2023 financial statements in order to conform to the classifications used in 2024.

**4. FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

*Self-Directed Account:* Investments held within the self-directed account are common stock and money market funds which are valued based upon quoted market prices.

*Pooled Separate Accounts:* Pooled separate accounts are based upon net asset value (NAV) as a practical expedient. The NAV of a pooled separate account is based on the market value of its underlying investments. The pooled separate account's NAV is not a publicly-quoted price in an active market. There are no redemption restrictions on the pooled separate accounts. The pooled separate account also files a Form 5500.

**5. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan holds an investment contract with Empower Annuity Insurance Company of America (EAICA). Under this contract, the EAICA maintains the contributions in a general account. The accounts are credited with the earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Under the group annuity insurance contract that supports this product, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account at contract value within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

EAICA announces in advance the prevailing interest rates it will credit to participant account balances. When establishing interest crediting rates, the trustee considers many factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the issuer's general account. The rates are established without use of a specific formula. These rates are reviewed on a semiannual basis for resetting.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and which require the Company to settle at an amount different than contract value paid either within 90 days or over time.

**6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan. Certain administrative expenses for the Plan are paid directly by the Sponsor.

Certain plan investments are units of pooled separate accounts and a group annuity contract managed by the trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by plan participants for the investment management services are included as a reduction of the return earned on each investment.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their Sponsor contributions.

**8. TAX STATUS**

The Plan uses a volume submitter document sponsored by the trustee. The volume submitter plan document received an advisory letter from the Internal Revenue Service (IRS) dated March 31, 2014, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The prototype plan document has been amended since receiving the opinion letter. However, the trustee and the Company believe that the prototype plan document is currently designed and operated in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter from the IRS; however, plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**10. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 2, 2025, the date on which the financial statements were available to be issued.
