**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of International Wines, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

#### Note 1 – Description of Plan

The following description of International Wines, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a contributory, defined contribution 401(k) plan available to substantially all qualifying employees of International Wines, Inc. (the Company). The Plan originated on July 1, 1985. Prior to June 1, 2022, to be eligible to participate in the Plan and to receive the employer matching contribution, the employee must complete one year of service and be at least twenty-one years of age. Effective June 1, 2022, a participant must have completed three months of service to be eligible to participate in the Plan and one year of service to be eligible for employer contributions. An eligible employee may enter the Plan on the first day of the first month or seventh month of the Plan year after meeting service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions – Participants may contribute up to the maximum amount allowed by law, as defined by the Plan, with the contributions and earnings thereon being nontaxable until withdrawn from the Plan. Effective June 1, 2022, participants could also contribute their after-tax annual compensation for Roth elective deferral purposes, subject to certain limitations, with the contributions and earnings thereon being nontaxable when withdrawn from the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Such transfers from other qualified plans are reported as rollover contributions.

The Company makes a safe-harbor matching contribution to participants in an amount equal to 100% of the first 3% of eligible compensation and 50% of the next 2% of eligible compensation contributed to the Plan as deferral contributions. The Company may also decide to make a discretionary, non-safe harbor matching contribution and/or a non-elective, discretionary profit-sharing contribution. The Company did not make a discretionary, non-safe harbor matching contribution and/or a non-elective, discretionary profit-sharing contribution to the Plan during the year-ended December 31, 2024.

Participant Accounts – Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution Plan earnings. The benefit to which a participant is entitled is based on the participant's vested balance. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Vesting – Participants are vested immediately in their contributions and discretionary employer matching contributions plus actual earnings thereon. Participants' interest in nonelective employer contributions will vest based on years of services in accordance with the following schedule:

Participants will become fully (100%) vested upon attainment of normal retirement age while an employee, death while an employee, or becoming disabled while an employee.

Notes Receivable From Participants – Active participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (1) \$50,000 reduced by the excess (if any) of the highest outstanding balance of plan loans during the one-year period ending on the day before the loan is made over the outstanding balance of plan loans on the date the loan is made, or (2) one-half the present value of the participant's vested interest in his account.

The loans are secured by the balance in the participant's account. The loan interest rate is set at a reasonable rate of interest as determined by the plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans, which would be made under similar circumstances. Principal and interest are paid ratably through regular payroll deductions.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or systematic installments. The Plan also permits withdrawals from the Plan due to circumstances of financial hardship in accordance with provisions specified in the Plan document. If a terminated participant's vested interest in his or her account is less than \$5,000 and he or she does not elect to receive a distribution, benefits will be paid in a single, lump-sum distribution as soon as administratively feasible.

Forfeited Accounts – The nonvested portion of a terminated employee's account balance shall be forfeited and used to reduce administrative expenses or employer contributions otherwise payable for the Plan year in which such forfeitures arise or for any succeeding Plan year. There were no unallocated forfeiture balances for the Plan years ended December 31, 2024 and 2023. For the year ended December 31, 2024, no forfeitures were used to reduce employer contributions or plan expenses.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation of fair value of investments. The Company pays the administrative costs of the Plan associated with any professional services provided to the Plan and the cost of communications to the participants. Administrative expenses recorded in the Plan represent trustee fees, investment advisor fees and other recordkeeping fees paid directly from the Plan to the Plan's trustee and other third parties. Loan fees are deducted directly from the participant's account.

#### Note 2 – Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Cash and Cash Equivalents – The Plan considers all highly liquid debt instruments purchased with a maturity date of three months or less to be cash equivalents.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses incurred maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

#### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

##### *Mutual Funds*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

##### *Cash and cash equivalents*

Valued at amortized cost which approximates fair value.

The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.
