Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Foghorn Therapeutics 401(k) Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution 401(k) and profit sharing plan covering substantially all employees of Foghorn Therapeutics Inc. (the Employer or the Company) and was established as of January 1, 2017.

The Plan covers all employees of the Company upon attaining the age of 21, except non-resident aliens and residents of Puerto Rico and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by an administrative committee appointed by the Employer. The administrator has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Through December 31, 2023, ADP Retirement Services was the Plan's recordkeeper and Reliance Trust Company was the appointed trustee of the Plan.

Effective January 1, 2024, the Plan Sponsor entered into an agreement with Fidelity Investments Institutional and Fidelity Management Trust Company (together Fidelity) replacing ADP Retirement Services as the Plan's recordkeeper and Reliance Trust Company as the Plan's trustee, respectively. Fidelity acts at the direction of the Plan Administrator. In conjunction with the change in trustee, on January 1, 2024, total net assets available for the plan benefits were transferred into Fidelity.

The Plan was amended and restated effective January 1, 2024.

Contributions

Participants may elect to contribute up to 90% of their annual pretax compensation, as limited by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (Rollovers). The Plan also provides for participant catch-up and Roth contributions. Participants must be 21 years of age to make elective deferrals. However, there is no minimum service requirement for a participant to make elective deferrals.

The Plan includes an automatic enrollment provision whereby all newly eligible employees will be enrolled in the Plan unless they affirmatively elect not to participate. An initial pretax deferral election of 3% beginning with the first pay period of the month following the participant's hire date will be made for eligible employees. The deferral will be invested in a designated balanced fund until changed by the participant.

The Company contributes a fixed matching contribution equal to 50% of the first 6% of participants eligible compensation deferred into the Plan, not to exceed \$3,000 per participant. Fixed matching contributions are allocated to contributing participants at the end of each payroll period. For the year ended December 31, 2024, the total fixed matching contribution was \$329,618.

The Company may decide to make a discretionary profit-sharing contribution to the Plan, although the Company is not required to do so. The discretionary profit-sharing contribution will be allocated to all employees eligible to participate in the Plan.

Eligible employees' share of the discretionary profit-sharing contribution is integrated with the Company's contributions to Social Security. A certain amount is contributed to the Plan based upon eligible earnings not in excess of the Taxable Wage Base under Social Security, and a different amount is contributed to the Plan if in excess of the Taxable Wage Base. The discretionary profit-sharing contribution will be determined by the Company and allocated to participants at the end of the Plan year based on eligible earnings within the computation period. The Company has not made any discretionary profit-sharing contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, as well as their portion of Employer fixed matching and discretionary profit-sharing contributions, if any, and their allocation of Plan earnings/losses and any expenses incurred. Allocations are based on participant compensation or individual participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus the allocation of Plan earnings on those contributions, at the time of allocation. Participants also become immediately vested in the Employer's fixed matching and discretionary profit-sharing contributions along with the allocation of Plan earnings on those contributions at the time of allocation.

Participant Notes Receivable

Effective May 1, 2023, participants may borrow from their account a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one month to sixty months, or up to thirty years for the purchase of a principal residence, with only one note outstanding at any one time. The notes are secured by the vested balance in the participant's account. Through December 31, 2023 participant notes bore interest at the prime rate plus 2%. Effective January 1, 2024, participant notes bear interest at the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions or check.

Payment of Benefits

The Plan allows for in-service distributions of the participant's vested accounts upon reaching the age of 59-1/2 or due to hardship, as defined by the Plan. In-service withdrawals are also permitted for Rollover and Roth Rollover account balances at any time.

Upon termination of employment for any reason, a participant or beneficiary will be entitled to the value in their vested account balance. If a participant's vested balance is equal to or less than \$1,000, the participant will receive an immediate cash-out of their vested account balance. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$5,000, the amount will be rolled over to an individual retirement plan designated by the trustee, unless otherwise directed by the participant. Participants with vested balances exceeding \$5,000 may choose lump sum, direct rollover, installment payments, partial withdrawal, or to defer receiving payments. The Plan also provides for mandatory distribution to participants upon reaching age 73.

Effective January 1, 2025, the Plan adopted the provision of the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE) Act 2.0 to increase the limit for involuntary automatic lump sum distribution for account balances from \$5,000 to \$7,000.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 3). The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the trustee.

At December 31, 2023, the Plan invested in the Invesco Stable Asset Fund – ADPZ Class, a bank collective trust fund. The Plan's interest in the bank collective trust fund was valued at the net asset value (NAV) practical expedient of the underlying investments reported by the issuer of the bank collective trust at year-end. The Plan liquidated its investment in the Invesco Stable Asset Fund – ADPZ Class during the year ended December 31, 2024.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms.

Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

Contributions

Participant contributions and Employer fixed matching contributions are recorded bi-weekly and semi-monthly, as applicable, when the Employer remits the contributions for investment into the Plan. Employer discretionary profit-sharing contributions are recorded as a receivable at year end and are remitted to the Plan during the following year, if applicable.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their accounts and are included in administrative expenses. Investment management fees for certain investments, if applicable, are paid by the Plan as a reduction of investment income (net appreciation) and are not reflected separately in the Statement of Changes in Net Assets Available for Plan Benefits.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan held four mutual funds that accounted for approximately 56% and 61% of total Plan investments as of December 31, 2024 and 2023, respectively.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Subsequent Events

Management has evaluated subsequent events through September 22, 2025, which is the date these financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Money Market Fund: The money market fund is valued at the daily closing price as reported by the fund, which is required to publish its NAV and transact at that price.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: The Plan invested in the Invesco Stable Asset Fund – ADPZ Class of Invesco Trust Company, a bank collective trust fund that invests primarily in U.S. treasury securities, corporate bonds, mortgage-backed securities and other asset backed securities. The fund was valued at the NAV of units of a collective trust. The NAV, as provided by Invesco Trust Company, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient was not used when it was determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) could have occurred daily. Unit values were determined daily by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. There were no unfunded commitments or redemption restrictions for the individual participants within the Plan.

As of December 31, 2024 and 2023, the Plan’s investments in money market funds and mutual funds are reported at level 1 within the fair value hierarchy.

4. Plan Termination

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants become fully vested and entitled to receive all amounts credited to their accounts.

5. Income Tax Status

The Plan is operating under a non-standardized pre-approved plan sponsored by Fidelity, which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Summary of Financial Data Certified by the Trustee

The following is a summary of financial information and data certified by the trustee, Fidelity:

7. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

8. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held and managed by Fidelity, the trustee of the Plan. Therefore, transactions qualify as party-in-interest transactions. The Plan made direct payments to Fidelity for recordkeeper fees totaling \$16,498 for the year ended December 31, 2024. The Plan also made direct payments to its independent investment advisor of \$19,606 for the year ended December 31, 2024.

Participant notes receivable also qualify as party-in-interest transactions.
