Independent Auditor's Report

Opinion

We have audited the accompanying financial statements of CoServ Electric Group Health Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of the CoServ Electric Group Health Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General – The Plan provides health benefits including major medical and dental coverage, as well as prescription drug services covering all eligible employees of Denton County Electric Cooperative, Inc., d/b/a CoServ Electric (the Sponsor), and CoServ Gas, Ltd. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits – The Plan provides health benefits described above to full-time employees and all part-time employees working at least 30 hours a week and to their covered dependents. The Plan also covers certain members of the Board of Directors and their covered dependents. Retired employees and Directors are entitled to similar health benefits provided they are at least 62 years of age and have completed 10 years of service with the Sponsor. Retirees age 65 and over receive health benefits under a fully insured policy with a separate insurance carrier. Directors elected or appointed on or after November 16, 2017 are not entitled to retiree health benefits. Employees hired after April 1, 2020 are not entitled to retiree health benefits.

Contributions – The Sponsor has established specific amounts which will be contributed on behalf of the covered employee. Any amounts required to be contributed to the Plan in excess of these specific amounts as determined by the Plan's actuaries are the responsibility of the covered employee.

The Plan has contracted with an insurance carrier to provide specific and aggregate stop loss coverage. This coverage has been considered in calculating the actuarial determined premiums.

Administrative Expenses – A portion of administrative expenses are absorbed by the Sponsor. These costs are a portion of the payroll costs of Human Resources and Accounting personnel.

Tax Status – The Plan has been granted tax exempt status under the Internal Revenue Code Section 501(c)(9). The Plan has obtained a favorable tax determination letter from the Internal Revenue Service, and the Sponsor believes that the Plan, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

Tax exempt organizations are required to pay tax on any income that is considered to be unrelated business. This includes interest income. Unrelated business income tax on interest income was \$65,712 and \$58,586 for the year ended December 31, 2024 and 2023, respectively.

The Plan has adopted the "uncertain tax positions" provisions of accounting principles generally accepted in the United States of America. The primary tax position of the Plan is its filing status as a tax exempt entity. The Plan determined that it is more likely than not that its tax positions will be sustained upon examination by the Internal Revenue Service (IRS), or other State taxing authorities. The Plan is no longer subject to examinations by federal taxing authorities for years before 2021.

NOTES TO FINANCIAL STATEMENTS

There were no penalties or interest recognized during the years ended December 31, 2024 and 2023.

Termination – In the event of the termination of the Plan, the Sponsor shall determine the value of any assets of the Plan remaining after providing for a reserve to cover any expenses incident to such termination and claims in progress. Distribution of such net amount shall be made in accordance with the Plan agreement.

2. Summary of Accounting Policies

Basis of Accounting – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the period. Actual results could differ from those estimates.

Credit Risks – Concentrations of credit risk exist if a number of investments are engaged in similar activities and have similar economic characteristics that could cause their ability to meet contractual obligations to be similarly affected by changes in economic or other conditions. Although the financial institutions, in which the Plan has deposits, are insured by agencies of the federal government, deposits at times exceed insured amounts.

Post-Retirement Benefits – The post-retirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31, 2024. Post-retirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the post-retirement benefit obligation is the portion of the expected post-retirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected post-retirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual claims costs to be incurred per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a 6.90% annual rate of increase in the per capita cost of covered pre-medicare health care benefits is assumed for 2025, declining to an ultimate level of 4.60% in 2050 and remaining at that level thereafter. The weighted average discount rate used was 5.50% and 4.80% in 2024 and 2023, respectively. Mortality improvements was based on a generational projection using the MP-2021 rates.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the post-retirement benefit obligation.

Other Plan Benefits – The Plan’s obligations at year end for health claims incurred by active participants but not reported at that date are estimated by the Plan’s actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in the accompanying statement of the Plan’s Benefit Obligations at present value. Health claims incurred by retired participants but not reported at year end are included in the post-retirement benefit obligation.

3. Benefit Obligations

The Plan’s deficiency of net assets under benefit obligations at December 31, 2024 relates primarily to the post-retirement benefit obligation, the funding of which is not covered by the current contribution rate. It is expected that the deficiency will be funded through future contributions.
