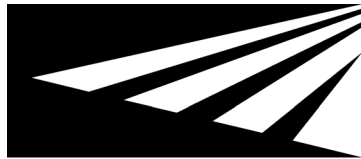

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the
Tax Deferred Annuity Plan of Mental Health Providers of Western Queens, Inc.:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Tax Deferred Annuity Plan of Mental Health Providers of Western Queens, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS**

(1) Plan Description:

The following description of the Tax Deferred Annuity Plan of Mental Health Providers of Western Queens, Inc. (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Background -

Mental Health Providers of Western Queens, Inc. (the "Organization" or the "Plan Administrator") established the Plan on July 1, 1995. All permissible employees of the Organization, as defined in accordance with the universal availability standards, are eligible to enroll on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Plan assets are held by Mutual of America (the "Trustee").

Plan Contributions -

Participants may contribute pre-tax compensation, as defined in the Plan, subject to Internal Revenue Service ("IRS") statutory limitations, by means of payroll deductions. Participants who attain age 50 by the end of a plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of contributions into various investment options offered by the Plan.

The Plan provides for no contributions by the Organization.

Participant Accounts -

Each participant's account is credited with the participant's contributions, Plan gains or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

Vesting -

Participants are immediately vested in their contributions and actual earnings, thereon. Rollover contributions are always 100% vested.

Payment of Benefits -

If a participant terminates employment with the Organization for any reason other than death, the participant can elect to leave the vested account balance in the Plan until the normal retirement date or receive the vested account balance in one lump sum amount if the account balance is greater than \$1,000. If the account balance is less than \$1,000, the participant will receive a cash out payment in the form of a lump sum distribution. Upon retirement, the total value of a participant's account may be applied to purchase an annuity to provide retirement income or result in a single-sum payment equal to the total value of the participant's account. Participants are required to begin distributions when the age of 72 is attained. In the case of death of a participant, the beneficiary designated by the participant shall be paid the deceased employee's vested account balance immediately, or in payments for up to five years from the anniversary of the date of death. If the beneficiary is the participant's spouse, payment of benefits may be deferred until they reach the age of 72. Participants who reached the age of 73 during the year ended December 31, 2023 were required to begin distributions during 2024 in accordance with the SECURE 2.0 Act.

Notes Receivable From Participants -

Each participant can borrow up to 50% of their vested account balance subject to a maximum of \$50,000 and a minimum of \$1,000. Each loan is for a period of one to five years, unless it is for the purchase of a principal residence, in which case the loan may be for a period of ten years. The initial interest rate on loans is at the rate of interest declared by Mutual of America. The rate is equal to the greater of the credited Interest Account rate plus 1% or Moody's Corporate Yield Average for the month ending two months prior to the date the rate is determined (5.53% and 5.33% for the years ended December 31, 2024 and 2023, respectively). Loans are secured by the participant's account.

(2) Summary Of Significant Accounting Policies:

Basis of Presentation -

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

Use of Accounting Estimates -

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, the actual amounts could differ from those estimates.

Investment Valuation and Income Recognition -

Investments are reported at fair value. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Net appreciation in fair value of investments includes realized and unrealized gains and losses on the fair value of investments held by the Plan. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis.

Notes Receivable From Participants -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit loss has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payments of Benefits -

Benefits are recorded when paid.

Expenses -

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment income.

(3) Fair Value Measurements And Investments

U.S. generally accepted accounting principles establish a fair value hierarchy which require an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the reported entity has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs to the valuation are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts: Consist solely of investments in mutual funds registered with the Securities and Exchange Commission and are carried at the net asset value at which the mutual funds shares are actively traded.

Investment contract with insurance company: Valued at contract value which is deemed to be fair value. There are no deferred sales charges, load assessments or interest rate adjustments that would affect the value as a result of a withdrawal request.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

(6) Income Tax Status

The Plan has not obtained a determination letter from the IRS stating that the Plan is in compliance with the applicable requirements of the Internal Revenue Code (the "IRC"). The Plan is relying on the IRS approval of the standardized prototype plan that it is utilizing. The IRS has determined and informed the Trustee by a letter dated March 31, 2017, that the prototype plan document was designed in accordance with applicable standards of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. generally accepted accounting principles require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator believes there are no such positions, and therefore, no provision for income tax has been included in the Plan's financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(7) Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

(8) Transactions With Parties-In-Interest

The Plan invests in insurance contracts and mutual funds sponsored by the Trustee, and therefore, these transactions qualify as party-in-interest transactions. Administrative fees related to the administration of the Plan are paid by the Plan. Other administrative fees are paid by the Organization on behalf of the Plan. Fees paid by the Plan for investment management services amounted to \$886 for the year ended December 31, 2024.

(9) Subsequent Events

Management of the Plan has evaluated subsequent events through August 4, 2025, which is the date these financial statements were available to be issued, noting no matters requiring adjustment or further disclosure.
