Notes to Financial Statements

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Answers In Genesis, Inc. 401(k) Salary Reduction Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Answers In Genesis, Inc. (the "Company"). Employees who are twenty-one years of age are eligible to participate in the Plan for elective deferrals and employer matching contributions. Employees must complete one year of service for discretionary profit-sharing contributions. Upon satisfying the eligibility requirements, employees are eligible to participate in the Plan on the first day of each plan quarter. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

A participant may contribute up to 100% of eligible compensation, as defined by the Plan, on a pre-tax or after-tax basis. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500. The Company makes employer matching contributions of 25% of employee deferrals up to 4% of compensation. Additionally, each year, the Company can make a discretionary profit-sharing contribution at the end of each plan year. Participants must perform 1,000 hours of service to be eligible for the profit-sharing contribution. The Company did not elect to make a profit-sharing contribution in 2024.

The participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds on a pre-tax basis or a Roth basis. A participant may change the amount of his or her elective deferred contributions anytime.

Rollover Contributions

Participants may rollover the taxable portion of funds previously held in their account in another employee benefit plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings and charged with an allocation of administrative expenses. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan. All contributions are invested as directed by the participants. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year.

NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Effective January 1, 2018, participants are immediately vested in the Company's matching and profit-sharing contribution portion of their accounts, plus actual earnings thereon. Non-vested portions of participant accounts that are forfeited upon payment of benefits are retained in the Plan and used to reduce Company contributions or plan expenses. The balance of unallocated forfeitures was \$522 and \$138 as of December 31, 2024 and 2023, respectively. There were no applied forfeitures against Company contributions in 2024.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance. The vested account balance is reduced by the highest outstanding balance of loans in the participant's account during the prior twelve month period for the calculation of the maximum loan allowed. The loans are secured by the vested balance in the participant's account. The interest rate on all loans will be a fixed rate calculated at Prime plus 2% at the time of the loan. All loans are required to be repaid in equal installments and within a five-year period unless it is for the purchase of a principal residence. Then the loan will be repaid within a reasonable time determined at the time the loan is made. For participants employed by the Company, principal and interest is paid ratably through payroll deductions. Upon termination of employment for any reason, the loan will become payable in full on the termination of employment. Participants may only have one loan outstanding at any given time.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company or termination of the Plan, the participant's account is distributed in the form of a lump sum payment. Death benefits are also eligible for installment payments. If a participant's vested interest is \$5,000 or less, the payment can be involuntarily distributed upon termination in the form of a lump sum payment, payable as soon as administratively feasible.

In-service distributions are permissible from the Plan for participants that have attained the age 55, completed five years of service or who have incurred a disability. Participants who qualify to take in-service distributions are permitted to do so from all sources, provided they are fully vested. Lastly, participants may take a distribution from their rollover account at any time. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits in a lump sum payment.

Hardship distributions are not permitted by the Plan.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of American (GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and changes therein, and disclosures of contingent assets. Accordingly, actual results may differ from those estimates.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based upon the terms of the plan document.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by Answers in Genesis, Inc. (the "Plan sponsor") and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in the net appreciation of fair value of investments.

Related-Party Transactions

Certain Plan investments were invested in accounts maintained by TD Ameritrade Trust Company, which is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Ascensus, LLC serves as the record keeper as defined by the Plan and, therefore, some transactions qualify as party-in-interest. Fees paid by the Plan for the investment management services are included in the net appreciation in fair value of investments.

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

Subsequent Events

The Company has evaluated events subsequent to the balance sheet date of December 31, 2024 through September 30, 2025, the date these financial statements were available to be issued.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels base on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds and money market: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Security and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 TAX STATUS

The Plan Sponsor has adopted a prototype plan which has received an opinion letter from the Internal Revenue Service dated November 30, 2020, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all amounts credited to their accounts.
