We have performed audits of the accompanying financial statements of the **Ohio District 5 Area Agency on Aging 403(b) Retirement Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 - DESCRIPTION OF THE PLAN**

***General***

The Ohio District 5 Area Agency on Aging 403(b) Retirement Plan (the “Plan”) was formed January 1, 1993. The Plan is a defined contribution plan covering all employees who have met certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and is administered by the Ohio District 5 Area Agency on Aging (the “Organization”). The Plan’s assets are held by Lincoln Financial Group and Nationwide Trust Company, the custodians of the Plan (the “Custodians”).

***Eligibility***

All employees who are scheduled to work at least 1,000 hours of service each year are eligible to participate in the Plan as soon as it is administratively practicable after their date of employment. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

***Contributions***

Participants can contribute up to 100 percent of eligible compensation through pre-tax and Roth deferrals. However, contributions may not exceed limitations established under section 402(g) of the Internal Revenue Code of 1986 (“IRC”), as amended. The Plan permits catch-up elective deferrals for participants over 50 years of age subject to IRC limitations. Participants may also make rollover contributions to the Plan from other qualified plans. Participants with at least 15 years of service with the same qualified employer (e.g., certain educational organizations, hospitals, health and welfare service agencies and church-related organizations) are allowed to make additional elective deferrals. These eligible participants may make up to an additional \$3,000 in elective deferrals annually, subject to a lifetime aggregate limit of \$15,000 per employer.

If a participant meets certain Plan criteria, the Organization, at its option, can make discretionary non-elective contributions to the Plan. A participant needs to have completed at least 1 year of service in order to receive this non-elective contribution. The Organization made discretionary non-elective contributions to eligible participants for the 2024 and 2023 Plan years.

***Investments***

Participants direct the investments of their contributions and the discretionary non-elective contributions into the investment options offered by the Plan. The Plan currently offers a variety of mutual funds, variable annuity accounts, and fixed annuity contracts.

***Participant Accounts***

Each participant’s account is credited with the participant’s contributions and an allocation of the Organization’s discretionary non-elective contribution, earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

***Vesting***

Participants are immediately vested in their contributions, rollover contributions, and any actual earnings thereon.

***Notes Receivables from Participants***

Participants may borrow from their accounts a minimum of \$1,000 limited to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and are generally due in installment payments of principal plus interest, at an interest rate of prime, with maturity dates ranging from one to five years. The term of the loan may exceed five years if the loan is for the purchase of the participant’s principal residence. Principal and interest is paid ratably through payroll deductions or self-pay.

***Plan Loans***

Plan loans are only permitted for those participants with a fixed annuity account with Lincoln Financial Group. These loans are issued directly from funds owned by Lincoln Financial Group and not from a participant’s account. Adequate security is required and a portion of the participant’s account is reserved, or held in collateral, to cover the outstanding loan in case of default. The collateral is held in the Lincoln Financial Group fixed investment contract. The loan interest rate for these plan loans may be fixed or variable and the initial rate is determined by Lincoln Financial Group. The related collateral for these Plan loans is reported under “Investments” on the Statements of Net Assets Available for Benefits.

***Payment of Benefits***

The full value of a participant’s account becomes payable upon retirement age of 65, disability or death. Upon termination of employment for any other reason, a participant’s account becomes payable. All benefits will be paid as a lump-sum distribution. In addition, the Plan includes a provision for participants to make withdrawals from their account under certain “hardship” circumstances. The Plan also provides for participants who have attained the age of 59 ½ to make a withdrawal from their account, subject to certain restrictions. On termination of service, if a participant’s account is less than \$1,000, the participant must receive a lump-sum amount equal to the value of his or her account balance.

***Forfeitures***

Employees who terminate prior to complete vesting forfeit the unvested portion of their employer contribution account balances. The Plan provides that forfeitures first be used to pay Plan administrative expenses and any remaining balance shall be applied to reduce employer contributions. There were no unused forfeitures in the Plan at December 31, 2024 and 2023.

***Amounts allocated to participants withdrawn from the Plan***

There are no amounts allocated, but not yet paid, to participants withdrawn from the Plan as of December 31, 2024 and 2023.

***Administrative Expenses***

Currently, the Organization pays the administrative expenses of the Plan with the exception of the expenses charged for participant-directed transactions, such as loan processing fees, distribution fees, and participant set-up fees. The Plan may also pay certain investment management fees, where these expenses are allocated to participant's accounts based on the participant's current fair value. These expenses are reflected in the accompanying statement of changes in net assets available for benefits as administrative expenses.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Presentation***

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Income Recognition***

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivables from Participants***

Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

***Payment of Benefits***

Benefits are recorded when paid.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

ASC No. 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC No. 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Unobservable inputs for which there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual funds***

Valued based on quoted prices in an active market (Level 1).

***Bank of America fixed contract – non benefit-responsive***

The Bank of America Fixed Contract is a fixed return product with annual interest rate guarantees (after the first period). Deposits are guaranteed in both principal and interest by Nationwide Life Insurance Company. Amounts are held in Nationwide Life Insurance Company's general account and are credited on a net daily basis at annual effective rates. This contract is not fully benefit responsive. Fixed fund unit values for this fixed contract is assigned daily, based on the funds' guaranteed interest rates/periods. On day one of a guaranteed period, the crediting rate is reset to match market rates and the fixed fund's unit value is set to 1.0. The fixed fund's unit value is a product of the crediting interest rate and will increase incrementally to reflect interest that is earned daily.

The fair market value is equal to the contract value less any Contingent Deferred Sales Charge (CDSC), if applicable, and Market Value Adjustment. While transactions involving the purchases/sales of individual contracts are not observable (Level 3) in a public marketplace, Nationwide has represented that contract value approximates fair value.

***Variable annuity accounts***

Valued at the respective net asset value ("NAV"), based on the fair value per accumulation unit held by the Plan. The NAV is used as a practical expedient to estimate fair value. The accounts are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments including matrix pricing. The Plan does not have any contractual obligations to further invest in the accounts. These investments are not classified within the valuation hierarchy, but presented for reconciliation purposes only.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

***Lincoln Financial Group Fixed Contract***

The Lincoln Financial Group Fixed Annuity contract is reported at contract value. Contract value represents the amount participants would receive if they were to initiate a transaction under the terms of the ongoing plan. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate shown on the contract specifications. The interest-crediting rate is declared on a quarterly basis. The Fixed Account is guaranteed against loss of principal, minus all withdrawals, including charges and adjustments. The guarantee is based on Lincoln's ability to meet its financial obligations from general assets. The Fixed Contract is not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable. While transactions involving the purchases/sales of individual contracts are not observable in a public marketplace, Lincoln has represented that contract value approximates fair value.

Based upon the characteristics of this contract, this Fixed Contract meets the definition of a fully benefit-responsive investment contract.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on completing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 7 - INCOME TAX STATUS**

The Plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan administrator intends to apply for a determination letter on the Plan when the government opens such program. The Plan is required to operate in conformity with the Code to maintain its tax exemption. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, and the years then ended, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 9 - PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares or units of investments managed by the Custodians. As Nationwide Trust Company and Lincoln Financial Group are the Custodians of the Plan, the related investment transactions qualify as party-in-interest transactions.

Certain participants have borrowed on their vested account balances. As the individuals are participants in the Plan, these transactions qualify as party-in-interest transactions.

**NOTE 10 - SUBSEQUENT EVENTS**

The Plan has evaluated events and transactions for potential recognition or disclosure through August 29, 2025, the date the financial statements were available to be issued.
