1. Description of Plan

General

The Plan is a defined contribution plan qualifying under Section 401(k) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was established January 1, 2011, and amended effective September 11, 2015, and amended again effective September 20, 2021, for the purpose of providing eligible employees of RevHealth (the "Company") and their beneficiaries funds for retirement.

Administration of the Plan

The general administration of the Plan and the responsibility for carrying out its provisions shall be placed on the Company. The Company is the Plan's sponsor and administrator and is responsible for the oversight of the Plan. The Company determines the appropriateness of the Plan's investment offerings and monitors the investment performance. Fidelity Investments, including Fidelity Management Trust Company ("Fidelity Investments"), is the trustee of the Plan and custodian of the Plan's assets.

Eligibility

Employees become eligible to participate in the plan once they have completed four months of eligible service. Part-time employees become eligible after completing 1,000 hours during the eligibility computation period defined in the Plan.

Contributions

Each year, participants may contribute up to the lesser of 92% of eligible compensation, as defined by the Plan or \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants are permitted to designate a portion of their deferrals as Roth 401(k) contributions that are includible in the participants gross income at the time of deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. They also direct the investment of the Company's contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

The Company has elected to make safe harbor matching contributions to all eligible participants in an amount equal to 100% of the first three percent of the participant's eligible compensation deferred into the Plan each year. The Company may also make discretionary matching contributions to the Plan. If made, the contribution can be up to 4% of eligible compensation deferred into the Plan.

The Company may also make discretionary nonelective contributions to the Plan. To qualify for discretionary nonelective contributions, a participant must complete at least 1,000 hours of service during the Plan year.

On September 20, 2021, the Plan was amended to specify the inclusion of bonuses under the compensation definition elected by the Company. Upon proper notice and approval, the Company shall allow a Participant to enter into a special salary reduction agreement to make deferral contributions from any Company paid bonuses, designated by the Company on a uniform and nondiscriminatory basis.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's matching and discretionary contributions, as well as allocations of Plan earnings. Participant's accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their rollover, qualified nonelective, deferral and safe harbor matching employer contributions plus actual earnings thereon. Vesting in the Company's matching and employer nonelective contribution portion of their accounts is based on years of continuous service as defined by the Plan. A participant is 100% vested in the Company's contributions after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and the maximum amount is the lesser of one-half of the vested account balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior twelve-month period. Up to 50% of the vested account balance may be used as collateral for any loan. The interest rate on outstanding loan balances ranges from 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

The maximum number of loans available to a participant at any given time is one loan. Terms depend on the type of loan; a general loan must be repaid within five years, while loans used to acquire a primary residence shall be repaid over a longer period.

#### Payment of Benefits

On termination of service due to death, disability or retirement, a participant or his or her beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account. The form of payment in which participants may receive benefit payments from the Plan upon termination of service, is dependent upon the balance of the participant's vested interest in his or her account. For participants with a vested account balance of \$1,000 or less on the applicable valuation date as provided under the Plan, the Company has the option to make a lump-sum distribution or a direct rollover into an IRA.

For participants with a vested account balance of more than \$5,000 on the applicable valuation date, the participant may elect a lump-sum, direct rollover distribution or a combination of non-rollover distribution and direct rollover. A participant may also elect to defer the receipt of benefits if the balance exceeds \$5,000. If payments are deferred, the participant's account will continue to be invested in the manner directed by the participant.

#### In-Service Withdrawals

An active participant may withdraw all or a portion of their vested account balance at the participants election, subject to possible administrative limitations on the frequency and timing of such distributions. They must attain the age of 59 ½. In the event a participant suffers financial hardship, as defined in the Plan, the participant may generally withdraw all or part of the vested portion of his/her account. The participant is also entitled to withdraw all or a portion of their rollover account balance, if any, at any time.

#### Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeited accounts can be used to reduce employer contributions, as well as to pay Plan expenses. On December 31, 2024 and 2023, there was \$2 and \$643 forfeited nonvested account balances, respectively.

## 2. Summary of Significant Accounting Policies

### Basis of Presentation

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by its investment advisers, custodians, and trustees. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

#### Subsequent Events

Management has reviewed subsequent events and transactions that occurred after December 31, 2024, through the date of the independent auditor's report and the date the financial statements were available to be issued, October 1, 2025. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with generally accepted accounting principles. Management has determined that there are no nonrecognized subsequent events that require additional disclosure.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market fund:* Valued at the daily closing price as reported by the fund sponsor from an actively traded exchange.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

6. Tax Status

The Plan has been designed to qualify under Section 401(K) of the Internal Revenue Code ("IRC"). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2007-71. The plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 401(K). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America, require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not, would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest

Certain Plan investments are managed by the Custodian. Fidelity Investments is the custodian as defined by the Plan, and therefore, these investments and investment transactions qualify as exempt party-in-interest transactions. Additionally, the Plan sponsor, RevHealth, is a party-in-interest to the Plan; however, there were no transactions with the Plan sponsor other than the funding of contributions to the Plan and payment of certain administrative expenses of the Plan. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

8. Risks and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
