Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Von Maur 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1. Summary of Accounting Policies

Basis of accounting: The accompanying financial statements of the Von Maur 401(k) Retirement Plan (the Plan) have been prepared under the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of benefits: Benefit payments to participants are recorded upon distribution. Amounts allocated to the accounts of participants who have elected to withdraw from the Plan, but have not yet been paid were \$10,282 and \$0 as of December 31, 2024 and 2023, respectively.

Administrative expenses: Certain costs related to the administration and operations of the Plan are paid from the assets of the Plan as provided in the Plan document and are reflected in the accompanying financial statements of the Plan.

Subsequent events: The Plan Administrator has evaluated subsequent events through September 9, 2025, the date the financial statements were available to be issued.

Note 2. Plan Description

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) covering all employees of Von Maur, Inc. and Subsidiaries (Company) who have one year with at least 1,000 hours of service and are age 21 or older. Employees may enter the Plan on the next January 1 or July 1 after eligibility requirements are met. Effective January 1, 2025, employees may enter the Plan the beginning of the next month after eligibility requirements are met.

Note 2. Plan Description (Continued)

Effective January 1, 2024, long-term part-time employees are eligible to enroll in the Plan, if the employees had more than 500 hours and less than 1,000 during the previous three calendar years. Beginning January 1, 2025, the measurement period for long-term part-time employees will be the previous two calendar years.

Effective January 1, 2025, newly eligible employees will be automatically enrolled in the Plan with a 3% deferral percentage unless the employee chooses a different percentage or chooses not to enroll in the Plan. The automatically enrolled participants' contributions will be invested in a Target Collective Investment Trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant accounts: Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's salary deferral contributions, the Company's matching contribution plus an allocation of the Plan earnings and charged with withdrawals and an allocation of Plan losses and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may choose from various funds, as listed in the financial statements, in which to invest their accounts. Participants may change their investment options at any time throughout the year via direct phone access or internet access to the Plan's third-party administrator.

Contributions: Each year, participants may contribute 100% of their pretax annual compensation, as defined in the Plan document, subject to certain IRC limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan is required to return contributions received during the plan year in excess of the IRC limits.

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Vesting: Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the remaining portion of their account is based on years of service. A participant is 100% vested after six years of credited service.

Forfeitures: As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,985 and \$4,613, respectively. These accounts will be used to reduce future Company matching contributions. Forfeitures of \$117,289 and \$91,931 were applied to reduce Company matching contributions for the years ended December 31, 2024 and 2023, respectively.

Payment of benefits: On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or certain annuity options. Hardship distributions are allowed subject to certain provisions outlined in the Plan document, and in-service distributions are allowed for active participants age 59½ and older.

Note 3. Funding Policy

Each year, at the discretion of the Company's board of directors, a percent of the employee's salary deferral is matched by the Company. For the years ended December 31, 2024 and 2023, the Company matched 50% of the first 5% of pay that the employee contributed to the Plan through salary deferral. Long-term part-time Plan participants are not eligible for the Company match.

Note 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, participants will become 100% vested in their accounts.

Note 5. Tax Status

The Plan has adopted a pre-approved plan sponsored by Principal Life Insurance Company. The pre-approved plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the IRC. The pre-approved opinion letter has been relied upon by the Plan. The Plan has been amended since the pre-approved plan received the opinion letter. The Plan's management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Information Certified by Plan Custodian

Note 7. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following are descriptions of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued using quoted prices in the active markets in which the funds are traded.

Pooled separate accounts: Pooled separate accounts invest primarily in domestic and international stocks, commercial paper or single mutual funds. Net asset value (NAV) is used as a practical expedient to determine fair value for these accounts. Investments in pooled separate accounts are not classified according to the fair value hierarchy, in accordance with the Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, as the NAV is used as a practical expedient to value the investment.

Collective investment trust funds: The unit value of these investments is determined by the sponsoring trust by dividing the fund's NAV by its units outstanding. The NAV is based on the underlying assets which are priced daily in active markets and are unadjusted quoted prices. NAV is used as a practical expedient to determine fair value for these accounts. Investments in common investment trust funds are not classified according to fair value hierarchy, in accordance with ASC 820, as the NAV is used as a practical expedient to value the investment.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 8. Investment Contract

The Plan had a traditional investment contract (Fixed Income Guaranteed Option) with Principal, which was a guaranteed investment contract. Principal was contractually obligated to repay principal and interest at a specified interest rate that is guaranteed to the Plan, which was 1.55% as of December 31, 2023. The contract met the fully benefit-responsive investment contract criteria and was, therefore, reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. During the year ended December 31, 2024, the Plan terminated its interest in the Fixed Income Guaranteed Option and transferred all amounts in the investment to the Principal Stable Value Z Fund.

Note 9. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect the amounts reported in the financial statements.

Note 10. Related-Party and Party-in-Interest Transactions

Plan investments are funds managed by Principal, the Plan custodian, and therefore, transactions with these investments are considered party-in-interest transactions.

Note 11. Prohibited Transactions

During the year ended December 31, 2024, the Company inadvertently failed to deposit \$130 of a participant's deferral within the required time frame as stated by DOL regulations. The Company corrected the late deposit, including lost earnings during the Plan year. The excise tax payment calculated for this transaction is less than \$1, thus no excise tax is due. The Company will file Form 5330 for the late deposit in 2025.
