Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Advocare, LLC 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

December 31, 2024 and 2023

(1) Description of the Plan

The following description of the Advocare, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

(a) General

The Plan is a defined contribution plan covering all full-time employees of Advocare, LLC (the “Company”) who have completed three months of service. The Plan is subject to the provisions of the Internal Revenue Code and the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligible employees may enter the Plan on the earlier of the first day of the plan year quarter coinciding with or next following the date such employee met eligibility requirements.

The Company has an agreement with John Hancock Trust Company, LLC to serve as custodian and recordkeeper.

(b) Contributions

Participants may elect to defer up to 100% of eligible compensation (up to a maximum as defined by government regulations in a calendar year) and contribute it to his/her account. The Plan also allows for “catch-up” contributions subject to Internal Revenue Service limits. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans.

The Company may contribute discretionary matching contributions, profit sharing contributions, qualified non-elective or one of three types of non-elective safe harbor contributions. Non-elective safe harbor contributions are only made to non-highly compensated employees at the option of the Company. For the year ended December 31, 2024, the Company made non-elective safe harbor contributions of 3% of compensation.

For the year ended December 31, 2024, the Company elected to make a discretionary matching contribution of 25% of the first 6% of eligible deferral contributions made by each participant. The Company also elected to make a profit-sharing contribution of approximately 11.68% of eligible earnings for each owner and .89% for non-owners.

(c) Participant Accounts

Each participant’s account is credited with the participant’s contribution, and allocations of (a) the Company’s contributions; and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Notes to Financial Statements - Continued

(1) **Description of the Plan - Continued**

(d) **Investment Options**

Participants may direct their employee and Company contributions to a variety of investment options offered by the Plan. The Plan's investment advisor also offers to direct a participant's contributions into several predetermined allocations of investments offered by the Plan in order to achieve certain investment mixes.

(e) **Vesting**

Participants are immediately vested in their contributions, Company qualified non-elective contributions and Company non-elective safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions plus actual earnings thereon is based on years of continuous service. A participant vests 20% per year starting with two years of service and is 100% vested after six years of credited service. Additionally, participants become 100% vested upon reaching the normal retirement age of 59½ or in the event of permanent disability or death. In the event of plan termination, participants became 100% vested in their employer contributions.

(f) **Payment of Benefits**

On termination of service due to death, permanent disability, retirement or other termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or in various installment payments if the distribution occurred due to death. The Plan also allows for various forms of annuities if a plan was merged from a plan that previously allowed for annuities. A participant whose vested benefit does not exceed \$1,000 will receive the benefit in a single lump sum. A participant is entitled to receive a distribution from his or her deferral contribution account without terminating employment upon attainment of age 59½.

(g) **Forfeited Accounts**

Forfeited amounts related to Company matching and profit-sharing contributions may be used to offset future discretionary matching or profit-sharing contributions of the Company or pay for plan expenses. As of December 31, 2024 and 2023, the Plan had approximately \$115,000 and \$60,000, respectively, of unallocated forfeitures available to reduce future Company contributions. During 2024, the Plan used approximately \$87,000 of forfeitures to fund Company discretionary matching and profit-sharing contributions.

(1) Description of the Plan - Continued

(h) Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years. In the event loan proceeds are used to acquire a principal residence, repayment may be extended. A participant may have up to two loans. The loans are secured by the balance in the participant's account. Interest is charged at prevailing rates as determined by the plan administrator. Interest and principal are paid ratably through payroll deductions. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments, the loan balance is reduced, and a benefit payment is recorded.

(i) Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements have been prepared on an accrual basis of accounting and present net assets available for benefits and changes in net assets available for benefits.

(b) Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The MetLife Stable Value Fund Series 25053 is a common collective trust which is valued by Reliance Trust Company, the trustee, on a daily basis. The underlying assets are fixed income investments. Participant may redeem this investment daily with no notice. There are no commitments to purchase this investment in the future.

(2) Summary of Significant Accounting Policies - Continued

(d) Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Administrative Expenses

Certain administrative and recordkeeping expenses are allocated proportionately to each participant. These expenses are allocated proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. Processing fees for items such as hardship distributions, in-service distributions, distributions at termination of employment and loans are charged against the account of the participant responsible for the expense. All other reasonable expenses are paid by the Company.

(g) Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities based upon participant requests. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

(3) Information Certified by Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company, LLC,, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income from notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in these financial statements and supplemental schedule.

(4) Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability;
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies: valued at the net asset value of shares held by the Plan at year end, based on quoted market prices in active markets.

Stable Value Fund: measured using the net asset value as a practical expedient as determined by Reliance Trust Company.

(5) Party-in-Interest Transactions

During 2024, the Plan paid approximately \$298,500 to John Hancock Trust Company, LLC, approximately \$104,000 to its third-party administrator, and approximately \$234,300 to its investment advisor. These transactions qualify as party-in-interest transactions. While these transactions qualify as party-in-interest transactions as defined in Section 3(14) of ERISA, they are expressly exempted from the prohibited transaction rules.

(6) Tax Status

The Plan has adopted the MandMarblestone Group Pre-Approved Profit Sharing Plan. The pre-approved plan obtained an opinion letter on June 30, 2020 in which the Internal Revenue Service indicated that the prototype plan is acceptable under Section 401(a) of the Internal Revenue Code, and is, therefore, not subject to tax under present income tax law. Therefore, no provision for income taxes has been included in the Plan's financial statements.

(6) **Tax Status - Continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) **Subsequent Events**

The Plan's management has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 7, 2025 the date the financial statements were available to be issued.
