Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Trantham Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Trantham Services, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. DECEMBER 31, 2024 AND 2023

Note A - Description of Plan

The following description of the Trantham Services Inc. (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Plan was established April 15, 2020 to cover all full-time employees of the Company and its affiliates. Empower has been selected by Plan management to be the investment custodian.

Eligibility. Employees become eligible to participate in the Plan upon completing one month of service. Plan entry is immediate upon meeting participation requirements.

Contributions. Each year, participants may contribute up to 100 percent of pretax annual compensation up to the maximum permitted by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Eligible employees are automatically enrolled in the Plan whereby unless elected otherwise, their deferrals will be 3%, with the percentage increased annually by 1% until it reaches 6% of compensation. The Company makes a matching contribution of 100% of participant contributions up to 1% of compensation plus 50% of contributions from 1% to 6% of compensation. Additional profit-sharing amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain IRS limitations. Employer matching contributions were \$381,343 and \$354,844 for the years ended December 31, 2024 and 2023, respectively. No profit-sharing contributions were made for 2024 or 2023.

Participant Accounts. An account is maintained for each participant in the Plan. The accounts are credited with the participants' elective and rollover contributions and their allocated portion of employer contributions and investment earnings. Distributions, withdrawals, and allocated expenses are subtracted from the account balances. Empower holds the plan assets and executes investment transactions as directed. Empower maintains the records of participant data and activity. Participants direct the investment of their account through a choice of mutual funds and a fixed income account. Participant's vested account balances represent the benefits available to the participants upon retirement, disability, death or termination from the Plan.

Note A - Description of Plan - Continued

Forfeited Accounts. Forfeitures can be used by the Plan to reduce future employer contributions. At December 31, 2024 and 2023, forfeitures of \$128,884 and \$73,753 were available to be used. No forfeitures were applied to employer contributions in 2024 or 2023.

Vesting. Vesting is based on years of vested service, as defined by the Plan. Employer profit-sharing contributions become 20% vested after one year of credited service as defined and continue to vest at the rate of 20% for each successive year of service until 100% vested after five years of service. Qualified safe harbor matching contributions vest according to the following schedule: less than one year 0%, one but less than two years 50%, two or more years 100%. Amounts not vested at the time a covered employee ceases to participate in the Plan are forfeited and will be used to reduce employer contributions. Participants are immediately vested in their deferral and rollover contributions plus actual earnings thereon.

Payment of Benefits. On termination of service, a participant receives a lump-sum amount equal to the value of the participant's vested interest in his or her account.

A participant's account becomes fully vested upon the participant's death, permanent and total disability or attaining normal retirement age.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Trantham Services Inc. 401(k) Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

Financial Statement Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investments and Investment Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note B - Summary of Significant Accounting Policies - Continued

Contributions

Employee contributions are reported in the year services are rendered to the Company by Plan participants. Employer matching contributions are recorded in the same period. Rollover contributions are recorded in the year the funds are received by the Plan.

Realized and Unrealized Gains and Losses

The Plan presents in the statement of changes in net assets available for benefits the net appreciation or depreciation in the fair value of investments, which consists of the realized gains and losses and the unrealized appreciation or depreciation on those investments. Realized gains and losses on investments represent the difference between original cost and related market price of the investments at the time of disposition. Prior to disposition, differences between the original cost and estimated fair value of the investments at the end of a period represent unrealized appreciation or depreciation. The Plan's investments (including investments bought and sold, as well as held during the year) appreciated in value by \$234,095.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Significant expenses of operating and administrating the Plan are paid by the Company.

Note C - Information Prepared and Certified by Custodians

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments as of December 31, 2024 and 2023 and for the year ended December 31, 2024:

- Investments at fair value
- Investments at contract value
- All components of income
- Net appreciation (depreciation) in fair value of investments
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note D - Fair Value Measurements

ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note E - Fully Benefit-Responsive Investment Contract

The Plan holds an investment in the Empower Fixed Account. This investment option meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and has no minimum or maximum interest rate. The crediting rate is reviewed on a quarterly basis for resetting. The crediting rates were 2.8% and 1.65% for 2024 and 2023, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include an uncured violation of the Plan's investment guidelines; a breach of material obligation under the consent of the issuer. In addition, certain events might limit the ability of the Plan to transact at contract value with the contract issuer.

Examples of such events include the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC; premature termination of the contract; Plan termination or merger; changes to the Plan's prohibition on competing investment options; or bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note F - Related Party Transactions and Party in Interest Transactions

Certain Company officers are eligible participants who have made elective deferrals to the Plan. Certain Plan investments are shares of mutual funds managed by Empower, the Custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions.

Note G - Plan Tax Status

The Plan has adopted a prototype document that was approved by the Internal Revenue Service. The Plan administrator believes the Plan is designed and operated in a manner that will continue its compliance with the Plan document and applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes is included in these financial statements.

The Plan follows accounting standards relating to uncertainty of income tax positions. The Plan administrator has assessed whether there were any uncertain tax positions that may give rise to income tax liabilities and determined that there were no such matters requiring recognition in the accompanying financial statements. The Plan files information returns under U.S. federal jurisdiction.

Note H - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

Note I - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note J - Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Note K - Evaluation of Subsequent Events

The Plan Sponsor has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued and concluded no events or transactions occurred during that period requiring recognition or disclosure.
