December 31, 2024 and 2023

1. Description of the plan

The following brief description of the Geater Machining & Manufacturing Co., Inc. Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan’s provisions.

The plan is a defined contribution plan covering all eligible employees of Geater Machining & Manufacturing Co., Inc. (the “Company”) who have completed one consecutive month of service and are eighteen years of age or older. Employees become participants on the first of the month immediately following meeting the age and service eligibility requirements. Employees become eligible for employer contributions on the first of the month immediately following meeting the age requirement and obtaining one year of service, as defined by the Plan Agreement. The Plan allows participants to designate all or a portion of their elective deferrals as Roth elective deferrals. Roth elective deferrals are accounted for separately in the respective participant’s account. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

The Plan is funded by contributions from participants, limited to the maximum amount deductible by salary reduction under the Internal Revenue Code (“IRC”). The Plan is also funded by safe harbor matching contributions equal to 100% of each participant’s elected salary deferral not to exceed 3% of the participant’s compensation plus 50% of employee deferrals in excess of 3%, up to 5% of the participant’s compensation for the Plan year. The Company may also make discretionary matching and profit sharing contributions to the Plan. Participants must be employed on the last day of the plan year to be eligible for discretionary matching and profit sharing contributions. For the years ended December 31, 2024 and 2023, the Company made discretionary profit sharing contributions of \$312,271 and \$262,551, respectively. The Company made no discretionary matching contributions in 2024 or 2023. Participants may also rollover or transfer amounts representing distributions from other qualified retirement plans.

Participant accounts

Each participant's account is credited with participant contributions, an allocation of the Company’s contributions, an allocation of Plan earnings, forfeitures of terminated participants’ nonvested accounts and is charged with an allocation of administrative expenses. Allocations are based on participants’ compensation or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of the plan, continued

Vesting

Participants are immediately vested in their elective salary deferrals, rollover contributions, and Company contributions, plus actual earnings thereon.

Investment options

Upon enrollment in the Plan, participants direct the investment of their contributions into various investment options offered by the Plan or self-directed investment options through a self-directed brokerage account. Participants may change their investment options at their discretion and changes become effective on the next business day.

During 2024, Plan management made no changes to investment options. During 2023, Plan management made three additional investment options available to participants and removed two investment options. These changes were made to provide additional diversification and replace underperforming investment options.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account and bear interest at fixed rates ranging from 5.25% to 10.50%, which is commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

Forfeited accounts and unallocated balances

During 2024 and 2023, there were no forfeited nonvested accounts as participants are vested in their entire account balance at all times. If excess funds are remitted to the plan due to errors in company contributions, these funds are moved to an unallocated account. These unallocated funds can be used to reduce future company contributions or pay plan expenses. As of December 31, 2024 and 2023 there were unallocated amounts available for future use of \$89 and \$-0-, respectively.

Payment of benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or payment of the value of the vested interest in his or her account in partial withdrawals or installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants automatically have balances rolled into an individual retirement account for accounts with a vested balance less than \$5,000 if no election form is completed. Distributions of accounts with balances in excess of \$5,000 are made at the election of the participants.

1. Description of the plan, continued

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

The Plan experienced a partial plan termination in 2020 and all affected participants became 100% vested in their accounts as of this date. The Plan paid distributions totaling \$115,519 and \$191,009 in 2024 and 2023, respectively, related to this event.

2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, changes therein, and disclosures in the financial statements. Actual results may differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Concentration of investment risk

Approximately 11% and 10% of the Plan's investments were held in one individual mutual fund as of December 31, 2024 and 2023, respectively. In addition, approximately 67% of the Plan's investments were held by two mutual fund families as of December 31, 2024 and 2023. Each of these mutual fund families and the individual mutual fund held in excess of 10% of the Plan's total investments at December 31, 2024 and 2023.

Notes receivable from participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits

Benefits are recorded when paid.

2. Summary of significant accounting policies, continued

Income tax status

The Plan is a nonstandardized prototype plan. The Internal Revenue Service (“IRS”) has determined and informed EPIC Retirement Plan Services in a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, Plan management believes the Plan is designed and currently being operated in compliance with applicable requirements of the IRC and therefore believes the Plan is qualified and related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has evaluated their material tax positions and determined there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

3. Information prepared and certified by Charles Schwab Trust Bank, a party-in-interest

Substantially all assets of the Plan were held by Charles Schwab Trust Bank, a party-in-interest, as of December 31, 2024 and 2023. All investment transactions during the years then ended were executed under formal custody agreements between the Plan and Charles Schwab Trust Bank. All securities bought, sold or exchanged were executed under these agreements. Such financial information has not been audited by independent auditors.

In accordance with the provisions of Section 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, Charles Schwab Trust Bank has certified the following unaudited financial information to be complete and accurate with respect to the Plan’s assets held by them as of December 31, 2024 and 2023, and investment activity for the years then ended:

#### 4. Risks and uncertainties

The Plan provides for investments in various securities, which in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### 5. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued at cost, which approximates fair value.

5. Fair value measurements, continued

Collective investment trust: Valued at the net asset value (“NAV”) of units of a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The trust does not have a finite life, the Plan has no unfunded commitments, and there are no participant redemption restrictions.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account: This account includes various assets self-directed by a participant and includes investments in common stock, exchange traded funds, unit investment trusts, and equity options. All of these investments are valued at the closing prices on the active market on which each security is traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fair value measurements, continued

The Plan held no investments in Levels 2 or 3 of the fair value hierarchy as of December 31, 2024 and 2023.

The Plan's policy is to recognize transfers between Levels as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers.

6. Administrative expenses

Administrative fees for the maintenance of investments, contributions and distributions records, and the processing of related transactions are paid by the Plan to EPIC Retirement Plan Services, a party-in-interest. Total fees paid by the Plan are reduced by Plan Expense Reimbursements received by the Plan based on investment balances in various investment options. Plan Expense Reimbursements received by the Plan and used to offset administrative fees totaled \$22,410 and \$23,059 for the years ended December 31, 2024 and 2023, respectively. Net administrative fees paid by the Plan for the years ended December 31, 2024 and 2023 totaled \$64,815 and \$55,699, respectively. In addition, administrative fees for certain participant directed transactions are charged to the respective participant's account balance. The plan sponsor paid audit fees totaling \$15,000 and \$14,000 for the years ended December 31, 2024 and 2023, respectively, to BGHN Associates, P.C., a party-in-interest.

7. Related party and party-in-interest transactions

The Company has agreements with Charles Schwab Trust Bank and EPIC Retirement Plan Services to provide administrative, custodial, and transaction processing services for the Plan's investments. Other related party and party-in-interest transactions are described in Notes 3 and 6.

8. Subsequent events

On March 7, 2025, the Plan Sponsor approved the transition of its existing 401(k) retirement plan into the Accelerated Retirement Advantage Pooled Employer Plan (“PEP”), effective March 28, 2025. A PEP is a retirement plan structure authorized under the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act of 2019, which allows unrelated employers to participate in a professionally managed, pooled 401(k) plan.

The Plan Sponsor elected to join the Accelerated Retirement Advantage PEP to simplify plan administration, reduce fiduciary risk, and potentially lower administrative and investment costs for plan participants. Under the PEP structure, the Pooled Plan Provider assumes key administrative and fiduciary responsibilities, including plan operation, compliance, and Form 5500 filing. The change is expected to enhance the overall efficiency and governance of the Company’s retirement plan.

There is no impact on the financial statements presented related to this transition. However, effective March 28, 2025, the Plan was terminated and all participant accounts were transferred to the PEP.

Plan management has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.
