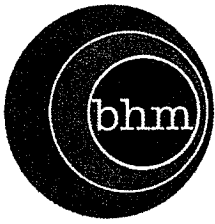

1. DESCRIPTION OF THE PLAN

The following description of the Shelly & Sands, Inc. Employees' 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement and the related amendments for a more complete description of the Plan's provisions. The Investment Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

General

The Plan is a defined contribution plan covering all full-time employees of Shelly & Sands, Inc. (the "Company") who have thirty days of service and are age 18. Employees represented by a bargaining union which has bargained in good faith with the employer are not eligible to participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may voluntarily contribute from 1% up to 100% of pre-tax and/or after-tax annual compensation, as defined in the Plan. Participants are automatically enrolled to defer 4% of pre-tax annual compensation unless they choose otherwise. The maximum salary deferral permitted by the Internal Revenue Code (the "IRC") for 2024 and 2023 was \$23,000 and \$22,500, respectively. Additional amounts may be deferred for participants meeting certain age requirements. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 50% of the first 4% of compensation that a participant contributes to the Plan. The matching Employer contribution is invested as directed by the participant. Additional amounts may be contributed at the option of the Company's board of directors and are also invested in a portfolio of investments as directed by the participant.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution and allocation of the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the following investment options. As of December 31, 2024, the options were:

Participant's voluntary contributions and rollover contributions are 100% vested.

Forfeited Accounts

The Plan can use forfeited non-vested accounts to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 for both years. Employer contributions were reduced from forfeited non-vested accounts by \$89,257 and \$21,410 for the years ended December 31, 2024 and 2023, respectively.

Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or monthly, quarterly, semiannual or annual cash installments over a period certain not to exceed the participant's (and his or her designated beneficiary's) life expectancy. A participant may also withdraw all or part of his or her account once they reach age 59 1/2 or older, early retirement date at age 55 or older with 5 years of vesting service, or due to hardship. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum. Upon termination or retirement if the participant's vested balance is \$5,000 or less, it will be paid in a single sum.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting applied consistently with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is also provided using the net asset value practical expedient. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Trustee fees for the Plan are waived each year. The Company sponsor also provides other accounting and administrative services to the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The excess contribution payable was \$11,552 and \$0 for 2024 and 2023, respectively.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities at the date of the financial statements, and the reported amounts of investment income and expenses during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

3. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

4. PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer matching and non-elective contributions.

5. INCOME TAX STATUS

The Plan is designated to constitute a qualified trust under Section 401(a) of the IRC and is exempt from federal income taxes under Section 501(a) of the IRC. A favorable determination letter has not yet been obtained from the Internal Revenue Service in accordance with DOL Reg. 2520.103-1(b)(3). However, the Trustee has obtained a positive determination letter dated June 30, 2020, on the prototype plan that this Plan is based upon. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. TRUSTEE CERTIFICATION

The Principal Trust Company, trustee of the plan, has certified with respect to investment assets, transactions and income for the periods from January 1, 2023 through December 31, 2024. This information was not audited for these financial statements, as allowed by DOL Reg. 2520.103-8.

7. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan maintains a fully benefit-responsive guaranteed investment contract, Principal Fixed Income Guaranteed Option (Principal) totaling \$7,398,908 for 2024 and \$7,081,363 for 2023. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. Such interest rates are reset on a semiannual basis. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

8. RELATED - PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by the Principal Trust Company and its related affiliates. Principal Trust Company is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

9. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 –Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 –Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means;
- if the asset or liability has specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts – Fair values of the underlying assets are used in determining the net asset value (NAV) of the account, which is not publicly quoted. NAV per share serves as a practical expedient to estimate the fair value of the pooled separate accounts. These accounts can be redeemed at the measurement date and can be redeemed on a daily basis.
