**Note 1 – Description of Plan**

The following brief description of the Utah Youth Village, Inc. Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering qualified employees of Utah Youth Village, Inc. (the Plan Sponsor/Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan.

The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### **Eligibility**

Employees are eligible to participate in the Plan if they have completed one year of service and are at least 18 years of age. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service.

### **Entry Date**

Employees may enter the Plan on the first day of each quarter coinciding with or following the date they satisfy the Plan's eligibility requirements.

### **Contributions**

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Under safe-harbor provisions, the Plan Sponsor contributes 3% of eligible participant's annual compensation. Additional discretionary, non-elective contributions may be contributed at the discretion of the Employer's retirement plan committee. During the year ended December 31, 2024, the Plan Sponsor made a \$374,628 discretionary, non-elective contribution to the Plan, equal to 2% of the participant's annual compensation for participants with less than 10 years of service and 12% of the participant's annual compensation for participants with 10 or more years of service.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Plan Sponsor's safe harbor contributions, as well as allocations of the Plan Sponsor's discretionary contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

## Vesting

Participants are vested immediately in their contributions and employer safe harbor contributions, plus actual earnings thereon. Vesting in the Plan Sponsor's discretionary contribution portion of their accounts is based on years of continuous service, as set forth in the following table:

## Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,006 and \$7,145, respectively. These accounts will be used to reduce future employer contributions and/or offset Plan expenses. During the year ended December 31, 2024, forfeited non-vested accounts of \$29,128 were used to reduce employer matching contributions and \$4,825 were used to pay administrative expenses of the Plan.

## Payment of Benefits

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan document upon retirement, termination of service, death or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship as defined in the Plan document.

### Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer discretionary contributions.

## Note 2 – Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate

permitted transactions under the terms of the Plan. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

#### **Contributions**

Participant contributions and related Employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

#### **Payments of Benefits**

Benefit payments to participants are recorded upon distribution. Amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, were \$0 at December 31, 2024 and 2023.

#### **Expenses**

The Plan's expenses are paid by either the Plan or the Plan Sponsor, as provided by the Plan document. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

#### **Subsequent Events**

The Plan Sponsor has evaluated subsequent events through September 17, 2025, the date which the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 3 –

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective funds - Valued at fair value based on the NAV of units held of the collective fund. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(I) The core bond's objective is to seek income and capital appreciation in order to produce a high total return. To achieve this, the bond invests in U.S. investment grade corporate, government, and mortgage-backed securities with select allocations to high yield and emerging market debt securities.

(II) The fixed income's objective is to seek broad fixed income exposure while reducing volatility. To achieve this, the fund invests in a guaranteed investment contract, the Bloomberg Aggregate Bond index, and exposure to long-term credit and government indices.

(III) The large cap growth's objective is to seek long-term capital growth by investing in equity securities of large cap growth companies. To achieve this, the fund primarily investments in U.S. stocks along with non-U.S. stocks, and cash.

(IV) The large cap value's objective is to seek capital growth and current income. To achieve this, the fund employes a value-oriented approach to identify potential opportunities for revaluation or fundamental improvement and is primarily invested in the Putnam Large Cap Value Trust.

(V) The small cap growth's objective is to seek growth of capital. To achieve this, the fund is invested in the Neuberger Berman Small Cap Growth Trust which is primarily invested in stocks and cash.

(VI) The mid cap value's objective is to seek long-term capital gains and income. To achieve this, the fund invests in a diversified portfolio of equity securities to domestic and foreign companies that are under-valued at the time of purchase.

(VII) Index funds seek to achieve investment results that are similar to the price and yield performance, before fees and expenses, of index funds that include the S&P 500 Index, Bloomberg U.S. Treasury Inflation Protected

Securities, Long Term Credit Bond Index Fund, and FTSE EPRA/NAREIT Developed Index. To achieve this, the funds will invest in the related funds managed by BlackRock Institutional Trust Company, N.A that invest in domestic and foreign stocks and cash.

#### **Note 4 – Certified Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA- required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively the custodian of the Plan).

#### **Note 5 – Tax Status**

The Plan uses a pre-approved plan document sponsored by Empower Retirement LLC, which received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022, stating that the pre-approved documents satisfy the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6 – Contract with Insurance Company**

The Plan entered into a fully benefit-responsive group annuity contract (the Contract) with Great-West Life & Annuity Insurance Company (GWLAC) (now known as Empower Annuity Insurance Company). GWLAC maintains the contributions in a general account, which is credited with the earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. The Contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the Contract is fully benefit-responsive, contract value is the relevant measure for the Contract, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported by the Plan by GWLAC represents contributions made under the Contract, plus earnings, less participant withdrawals and administrative fees. Participants may ordinarily direct the withdrawal

or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2024 and 2023, was \$176,704 and \$136,930, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

#### **Note 7 – Related Party and Party-in-Interest Transactions**

Certain Plan investments consist of a mutual fund and a fully benefit responsive group annuity contract managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, collectively the custodian, as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

#### **Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
