## **Independent Auditor's Report**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Core Molding Technologies, Inc. 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ## Plan Description

### General

Core Molding Technologies, Inc. 401(k) Retirement Savings Plan (the "Plan") is a 401(k) profit sharing plan which was formed for the purpose of providing retirement benefits to certain eligible employees of Core Molding Technologies, Inc. (the "Company") except those that have attained union seniority and are covered by a collective bargaining agreement. Employees of Core Composites Cincinnati plant are also eligible to participate in the plan. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

### Eligibility

All regular domestic employees of the Company who are not independent contractors and are not covered by a collective bargaining agreement become eligible to participate in the Plan upon their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Unless they elect otherwise, employees meeting the eligibility requirements will be automatically enrolled and deemed to have elected a pre-tax deferral rate of 3% of pre-tax annual compensation.

### Contributions

Participants may contribute up to 100% of their annual compensation on a pre-tax and/or Roth basis, as defined in the plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company makes matching contributions to the Plan equal to 100% of each participant's elective deferrals not exceeding 3% of the participant's compensation plus 50% of each participant's elective deferrals in excess of 3% but not in excess of 5% of the participant's compensation. Prior to December 31, 2007, employer matching contributions were invested in the Company's common stock. Beginning on January 1, 2008, matching contributions are no longer invested in the Company's common stock but are now invested ratably to the same funds elected by the participant. The Company may also elect to make profit sharing contributions at the discretion of the Company's Board of Directors.

Contributions are subject to certain limitations.

### Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's matching contribution and age based contributions portion of their accounts plus actual earnings thereon is based on continuous years of service according to the following vesting schedule:

1	20%
2	40%
3	60%
4	80%
5 or more	100%

### Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the prime rate plus one percent on the first business day of the month during which the loan is made. Interest rates range from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

### Payment of Benefits

On termination of service due to death, disability, retirement or termination a participant may receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$123,442 and \$79,390, respectively. These accounts will be used to reduce future employer contributions or pay administrative expenses of the plan. During 2024, the plan sponsor used \$79,023 in forfeitures to reduce employer contributions. During 2023, the plan sponsor used \$0 in forfeitures to reduce employer contributions. During 2023, the plan sponsor used \$90,951 in forfeitures to reduce the 2022 employer contributions due to the Plan as of December 31, 2022. During 2024 and 2023, the plan sponsor used \$244 and \$835, respectively, in forfeitures to reduce administrative expenses.

#### SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. There was no material impact on the Plan's 2024 or 2023 financial statements.

### Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. For additional disclosure regarding fair value of investments, see the *Fair Value Measurements* footnote herein.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Expenses

The majority of the administrative expenses of the Plan are paid by the Company.

## Fair Value Measurements

GAAP established a fair value hierarchy that prioritizes the inputs to measure the fair value of the assets or liabilities being measured. Fair value is defined as the exchange value that would be received on the measurement date to sell an asset or to value the amount paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs are unadjusted quoted market prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date. Level 1 inputs provide the most reliable measure of fair value as of the measurement date.
- Level 2 Inputs are based on significant observable inputs, including unadjusted quoted market prices for similar assets or liabilities in active markets, unadjusted quoted prices for identical or similar assets or liabilities in markets that are not active, or inputs other than quoted prices that are observable for the asset or liability.
- Level 3 Inputs are significant unobservable inputs for the asset or liability.

The level of the fair value hierarchy within which a fair value measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the net asset value (NAV) of shares held by the Plan at year-end.

*Common Collective Trust:* Valued at the NAV provided by the administrator of the fund. Issues and redemptions of units are recorded upon receipt of unit holder's instructions based on the determined NAV per unit, which is determined daily. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. For these funds, there are no unfunded commitments, redemption restrictions, and participants can transact daily.

*Company Common Stock:* Valued at the NAV of shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The trustee also certified the completeness and accuracy of \$2,711,075 and 3,214,246 of net appreciation in fair value of investments and \$731,338 and \$501,669 of interest and dividend income related to the aforementioned assets for the years ended December 31, 2024 and 2023, respectively.

## Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds, managed by Alerus Financial, N.A., the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Everhart Financial Group, Inc. is the investment advisor for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for these services amounted to \$85,246 and \$89,240 for the years ended December 31, 2024 and 2023, respectively.

## Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## **Tax Status**

The Plan adopted a non-standardized pre-approved Profit Sharing Plan with a Cash or Deferral Arrangement which received a favorable opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS). The opinion letter stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) for disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying 2024 statement of net assets available for benefits.

## **Subsequent Events – Date of Management's Evaluation**

The Plan has evaluated subsequent events through the date of the Independent Auditor's Report, the date the financial statements were available to be issued.
