**1. Description of Plan**

The following description of the White Plains Hospital Medical Center 403(b) Tax Deferred Annuity Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan, which was established on January 1, 2009, is a defined contribution plan that covers certain employees of White Plains Hospital (the "Hospital" or "Employer") who were eligible to participate at the time of employment. Effective August 1, 2017, the Plan discontinued an employee's eligibility to contribute participant elective deferral contributions and to withdraw a loan from the Plan. Participants contributions representing distributions from other qualified retirement plans were not affected by the discontinuance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Other employees of the Hospital participate in the White Plains Hospital 403(b) Defined Contribution Retirement Program.

***Contributions***

Through July 31, 2017, participants were able to contribute up to 100% of their eligible compensation on a pre-tax or after-tax (Roth) basis, as defined by the Plan, up to the annual limit as determined under the Internal Revenue Code ("IRC"). Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants may also rollover or transfer amounts representing distributions from other eligible retirement plans.

Participants direct the investment of their contributions into various investment options offered by the Plan.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

***Vesting***

A participant is 100% vested in their accounts at all times.

***Payment of Benefits***

Benefits are paid upon retirement (age 65), death, age 59 1/2 or other termination of employment. Upon retirement or termination of employment, a participant may elect to receive in cash or direct rollover a lump-sum amount equal to the vested value of the participant's account.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Hospital and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

***Notes Receivable from Participants***

The Plan offered a loan feature whereby certain participants (“borrower”) enrolled in the Plan could borrow a minimum amount of \$1,000 up to a maximum amount of 50% of the vested account balance or \$50,000 (whichever is less). The interest rate is based on a reasonable rate of interest which is at least the rate of interest currently being charged by commercial lenders in the area for the use of money which they lend under similar circumstances. Loans must be repaid within five years, unless the loan is used to purchase a participant’s principal residence or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years. Principal and interest are paid ratably through payroll deductions.

***Loans to Participants/Collateralized Assets***

The Plan offered a loan feature whereby a participant (borrower) enrolled in the Plan could borrow a minimum of \$1,000 up to a maximum of 50% of his/her vested balance or \$50,000 (whichever is less). Loans to the participant were made directly from Lincoln National Life Insurance Company (“Lincoln Life”) and Metropolitan Life Insurance Company (“MLIC”). The participant’s account is not reduced by the loan amount, but serves as security for the loan, the loan amount is moved into a fixed income collateral account within the borrower’s account. The loan must be repaid directly to Lincoln Life and MLIC within a five-year period in substantially equal payments (not less frequently than quarterly). The five-year repayment period will not apply to a loan that is used to acquire a principal residence of the borrower.

If the borrower does not repay the loan and related interest due in accordance with the schedule set forth in the promissory note or other writing permitted by applicable law representing the loan, their loan will be deemed in default and the borrower is not eligible to take out any new loans. Defaults in loans are treated as a distribution at the time of default against the participant’s account.

At December 31, 2024 and 2023, there were 1 and 2 loans outstanding with principal balances due of \$9,817 and \$16,120 which represent a collateralization of participant accounts. Of these loan balances, 1 of them amounting to \$2,922 was in default as of December 31, 2023 and is treated as a distribution. At December 31, 2024 the interest rate on the loan was 2.85%. At December 31, 2023, the interest rates were 2.85% to 5.00% with maturities through 2027.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis; investment income is recognized when received and disbursements are recognized when made, except for investments which are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

***Investment Valuation and Income Recognition***

All investments of the Plan are stated at fair value, except for certain guaranteed investment contracts and a pooled separate account, which are stated at contract value.

The Transamerica Financial Life Insurance Company ("TFLIC") Fixed Fund, TFLIC Stable Fund and Fixed Account are guaranteed investment contracts that are valued at contract value, which represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The Fixed Interest Account and Empower PPSA are guaranteed investment contracts that are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

The separate accounts are valued at the NAV of units held by the Plan. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The TFLIC Government Fixed is a pooled separate account and is valued at contract value, which represents the fair value of the underlying portfolio, accrued interest on the underlying portfolio assets, the fair value of the contract, and the adjustments to contract value.

***Investment Valuation and Income Recognition (continued)***

Mutual funds are valued at fair value based on the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds are deemed to be actively traded.

Personal choice retirement accounts are considered to be self-directed accounts and are valued based on the account's underlying investments held as of the end of the plan year. The personal choice retirement accounts consist of mutual funds and money market funds.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

***Payment of Benefits***

Benefits are recorded when paid.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 11, 2025.

**3. Information Certified (Unaudited)**

**5. Pooled Separate Account - TFLIC Government Fixed Fund**

The TFLIC Government Fixed Fund is an actively managed guaranteed pooled separate account of TFLIC. Both principal and interest are guaranteed by TFLIC. Interest is declared quarterly for new deposits received during that quarter and are guaranteed for the balance of that calendar year. Renewal rates are declared annually on a calendar year basis for existing assets.

Participants are generally permitted to make benefit distributions at contract value.

No monies may be transferred from the TFLIC Government Fixed Fund by participants to fixed income funds (competing funds). Monies transferred to non-fixed income funds may not be transferred to fixed income funds or back to the TFLIC Government Fixed Fund for 90 days. Monies transferred back to the TFLIC Government Fixed Fund or withdrawn within the 90 day period are subject to a 5% charge. Monies withdrawn or transferred by the Employer and monies withdrawn by participants not due to benefit withdrawals, hardships and loans may be subject to a withdrawal charge.

Because the TFLIC Government Fixed Fund is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the TFLIC Government Fixed Fund.

**6. Guaranteed Investment Contracts**

***MLIC Fixed Interest Account, at Fair Value***

The MLIC Fixed Interest Account (the "Account") is guaranteed by MLIC and is backed by the full faith and credit of MLIC's general account. The general account invests primarily in bonds, commercial, agriculture and real estate mortgages, real estate and corporate equities. MLIC will declare and guarantee an interest rate for each new contribution. Upon renewal, MLIC will declare a new interest rate for that contribution and its accumulated earnings.

The credit risk of MLIC was evaluated by nationally recognized statistical rating agencies as follows: Standard & Poor's (AA- as of March 2025), Moody's Investors Service (Aa3 as of March 2025), A.M. Best Company (A+ as of March 2025), and Fitch Ratings (AA- as of March 2025).

The Account is non benefit-responsive and is reported at fair value on the statements of net assets available for benefits.

***Lincoln Fixed Account, at Contract Value***

The Lincoln Fixed Account provides a guarantee of principal and interest. Assets in the Fixed Account are part of the general assets of the issuing company and are subject to the claims-paying ability of that company.

***Lincoln Fixed Account, at Contract Value (continued)***

Contributions allocated to the Lincoln Fixed Account are guaranteed to be credited with a minimum interest rate, as specified in the contract. Lincoln has an internal committee that reviews and sets interest rates quarterly based on a variety of proprietary factors. Lincoln's standard crediting methodology is to apply a portfolio interest rate to the Lincoln Fixed Account. That is, a single interest rate applies to the entire balance of the participant's Lincoln Fixed Account. The declared portfolio interest rate is published quarterly in advance of the quarter for which the rate will be effective. The rate of interest actually credited to the Fixed Account will be the greater of the declared rate of interest or the guaranteed minimum interest rate specified in the contract. The standard guaranteed minimum interest rate is 3.00%. A participant may transfer or withdraw all or a portion of his or her Fixed Account balance without limitation.

The credit risk of Lincoln Life was evaluated by nationally recognized statistical rating agencies as follows: Standard & Poor's (A+ as of July 2024), Moody's Investors Service (A2 as of September 2024), A.M. Best Company (A as of February 2025), and Fitch Ratings (A+ as of July 2024).

The Lincoln Fixed Account is benefit-responsive and is reported at contract value on the statements of net assets available for benefits. The Lincoln Fixed Account represents approximately 15% and 16% of the Plan's net assets available for benefits at December 31, 2024 and 2023.

***TFLIC Fixed Fund, at Contract Value***

The TFLIC Fixed Fund ("Fixed Fund") is a fully benefit responsive investment contract, which provides participants with book value distributions at retirement and other events as described in the group annuity contract. Both principal and interest are guaranteed by TFLIC. The Fixed Fund is supported by TFLIC's general account. The general account of TFLIC invests in investment grade fixed income securities, including U.S. Government, Agency, and corporate issues; as well as individually underwritten mortgage loans, and private placements. Interest is declared quarterly for new deposits received during that quarter and are guaranteed for the balance of that calendar year. Renewal rates are declared annually on a calendar year basis for existing assets.

No monies may be transferred by participants to fixed income funds (competing funds). Funds transferred to non-fixed income funds may not be transferred to fixed income funds or back to the Fixed Fund for 90 days. Monies transferred back to the Fixed Fund or withdrawn within the 90 day period are subject to a 5% charge. Monies withdrawn or transferred by the Employer and monies withdrawn by participants not due to benefit withdrawals, hardships and loans may be subject to a withdrawal charge.

The credit risk of TFLIC was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best Company (A as of January 2025), Moody's Investors Service (A1 as of December 2024), and Standard and Poor's (A+ as of March 2025).

Because the TFLIC Fixed Fund is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Account. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Fixed Fund represents approximately 13% and 14% of the Plan's net assets available for benefits at December 31, 2024 and 2023.

***TFLIC Stable Fund, at Contract Value***

The TFLIC Stable Fund (“Stable Fund”) is a fully benefit responsive investment contract, which provides participants with book value distributions at retirement and other events as described in the group annuity contract. Both principal and interest are guaranteed by TFLIC. The Stable Fund is supported by TFLIC’s general account. The general account of TFLIC invests in investment grade fixed income securities, including U.S. Government, Agency, and corporate issues; as well as individually underwritten mortgage loans, and private placements. Interest is declared annually for new deposits received during that year and are guaranteed for the balance of that calendar year. Renewal rates are declared annually on a calendar year basis for existing assets. The underlying guaranteed rate is in effect through segment maturity date.

No monies may be transferred by participants to fixed income funds (competing funds) except at a segment maturity date. Monies transferred to non-fixed income funds may not be transferred to fixed income funds or back to the Stable Fund for three months. Monies withdrawn or transferred from the Stable Fund by the Employer at any time and/or by participants during the 6 month period preceding contract suspension may be subject to restriction and/or adjustment in accordance with contract provisions.

Because the TFLIC Stable Fund is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Account. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

***Empower PPSA, at Fair Value***

The Plan invested in a non-benefit responsive guaranteed investment contract with Empower Annuity Insurance Company called the Principal Preservation Separate Account (the “PPSA”). The PPSA is a stable value product that provides protection from Empower’s general account and guarantees principal and accumulated interest. The PPSA invests in a broadly diversified portfolio of fixed income instruments (primarily in intermediate-term bonds, private placements and commercial mortgages). The interest crediting rate is announced in advance and is guaranteed for a six-month period for which a minimum rate will apply. Distributions resulting from a participant’s termination of employment, retirement, disability or death, hardship withdrawals and minimum required distributions are always paid in full without any restrictions or fees. Amounts withdrawn may not be transferred to a competing fund for 90 days after withdrawal.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to terminate the Plan subject to the provision of ERISA.

**8. Tax Status**

The Hospital has adopted a plan document effective January 1, 2019 which is intended to satisfy the Internal Revenue Service's ("IRS") final 403(b) regulations. The Plan administrator believes that the Plan is designed and currently being operated in accordance with applicable sections of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**9. Party-In-Interest Transactions**

Certain investments are managed by Lincoln Life, TFLIC or MLIC. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees could borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

**10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
