**NOTES TO FINANCIAL STATEMENTS**  
**DECEMBER 31, 2024 AND 2023**

**1. Description of Plan**

The following description of the Alecto Healthcare Services 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan originally established February 2, 2015. The Plan covers substantially all employees of Alecto Healthcare Services LLC (the “Company”, “Employer”, or “Plan Sponsor”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Company serves as the Plan Administrator.

The Plan was amended and restated effective July 15, 2022.

b. Administration

The Plan Administrator is responsible for the day-to-day administration and operation of the Plan. The Plan’s custodian was Wells Fargo Bank, N.A. (“Wells Fargo”) through April 15, 2021. Subsequent to that date, the Plan transitioned to Principal Financial Group (“Principal”) as a result of Principal Financial Group’s acquisition of Wells Fargo Company Institutional Retirement Trust Business. Principal (the “Custodian”) maintains the individual participant account balances. The Custodian has the power to administer the Plan and apply all of its provisions on behalf of the Plan Sponsor. The Plan Sponsor has the discretion to appoint or remove any trustee or agent of the Plan.

c. Eligibility

The Plan excludes leased employees, employees who are residents of Puerto Rico, employees classified as casual, per diem, and pro re nata (PRN), individuals considered to not be a common law employee, and bargaining employees. The Plan covers all eligible employees of the Company who have completed 3 months of service. Employees may enter the Plan on the first day of each payroll period subsequent to when the eligibility requirement has been met.

d. Participant Contributions

Participants may contribute to the Plan up to 100% of eligible compensation through elective, pre-tax, and Roth salary deferrals, subject to the Internal Revenue Code (“IRC”) limits of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Upon reaching the age of 50, participants may make additional catch-up contributions limited to \$7,500 for the years ended December 31, 2024 and 2023.

Participants may also make rollover contributions from other qualified defined contribution or benefit plans and certain individual retirement accounts.

e. Employer Contributions

The Company matches 75% of employee contributions, up to 3% of eligible compensation deferred to the Plan for union employees. The Company matches 100% of employee contributions, up to 4% of eligible compensation deferred to the Plan for employees in the California Nurses Association. The Company may elect to make a discretionary matching contribution to the Plan for all other employees. Participants become eligible to participate in matching contributions if they are employed on the last day of the Plan year and if they have completed at least 1,000 hours of service during the Plan year. There were no union employees or employees in the California Nurses Association for the years ending December 31, 2024 and 2023, therefore, there were no employer contributions for the years then ended.

f. Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and expenses. Participants can direct their account into a variety of investments offered by the Custodian. The benefit to which a participant is currently entitled is the benefit that can be provided from the participant's vested account.

g. Vesting

Participants are always 100% vested in their contributions, catch-up contributions, rollover contributions, and the earnings thereon. Participants vest in Employer contributions and any earnings thereon as follows:

Participants become 100% vested in their accounts if they are employed with the Company and reach normal retirement age (59 ½), become totally disabled, pass away, or if the Plan terminates.

h. Forfeitures

Participants who terminate employment forfeit the non-vested portion of their employer contributions and the earnings thereon. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$514,040 and \$340,339, respectively. Forfeitures may be used to reduce employer contributions or to pay administrative expenses. Forfeitures used to pay for employer contributions were \$0 for the years ended December 31, 2024 and 2023. Forfeitures used to pay for administrative expenses were \$45,103 and \$8,084 for the years ended December 31, 2024 and 2023, respectively.

i. Notes Receivable from Participants

Participants may borrow from their accounts the lesser of a) \$50,000, reduced by their highest outstanding note balance during the prior year, or b) 50% of their vested account balance minus any existing loan balance, subject to a \$1,000 minimum.

Notes are secured by the vested balance in the participant's account. An individual may have no more than three loans outstanding at any time.

Note payments are made through payroll deductions over periods up to five years, unless the note is used to acquire a primary residence, in which case the loan term may not exceed ten years. New notes bear interest at the prime rate plus 1% per annum, fixed at inception of the note. As of December 31, 2024, notes receivable from participants mature through 2029 and bear interest at a range from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan Administrator at the time of the note.

j. Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive an amount equal to the participant's vested account balance in a lump-sum payment, installment payments over the participant's or beneficiary's assumed life expectancy, roll the amount to an individual retirement account or other eligible transferee plan, or delay payment until the beginning date of required minimum distributions, depending on the value of the account. In addition, the Plan permits in-service distributions for participants who are age 59 ½ or older.

k. Administrative Expenses

All reasonable expenses of administration may be paid out of the Plan assets unless paid by the Company. Expenses, to the extent not paid by the Company, are paid by the Plan and allocated to participants based on their account balances. For the years ended December 31, 2024 and 2023, the Plan paid expenses of \$154,235 and \$147,287, respectively. Expenses that relate solely to a specific participant, such as fees for notes receivable or benefit payments, are assessed to the participant. Certain expenses are included in the transaction prices of investments bought and sold and cannot be separately quantified.

## 2. **Summary of Significant Accounting Policies**

a. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP") as set forth by the Financial Accounting Standards Board (the "FASB").

b. Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the amounts of net assets available for benefits, changes therein, accompanying footnote disclosures and the supplemental schedules. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Net appreciation in fair value of investments consists of the net change in unrealized gains during the year and the realized gain on investments sold during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If an active participant fails to make payments for more than 60 days after they are due, the note will be in default. Under certain circumstances, as indicated in the Plan document, a note that is in default may be treated as a taxable distribution from the Plan and will be included in the statement of changes in net assets available for benefits as a benefit payment.

e. Payment of Benefits

Benefits are recorded when paid.

f. Subsequent Events

The Plan Administrator has evaluated subsequent events through October , 2025, the date the financial statements were made available for issuance.

### **3. Information Certified by Asset Custodian (Unaudited)**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA section 103(a)(3)(c) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal.

The classification of the investments into the appropriate fair value hierarchy levels (1, 2 or 3) as disclosed in Note 5 is not certified by the trustee and is the responsibility of the Plan's management.

### **4. Investments**

All Plan investments are participant-directed and held by the Custodian as of December 31, 2024 and 2023. Participants can direct their accounts among various mutual funds and a common collective trust.

The Plan invests in the Galliard Stable Return Fund PN60 ("SRF"), formerly the Wells Fargo Stable Return Fund N60 common collective trust fund. The SRF invests all of its assets in the Galliard Stable Return Fund Core (the "Fund"), formerly the Wells Fargo Stable Return Fund G. This investment is reported at fair value, which approximates contract value. The Fund invests in fully-benefit responsive investment contracts and security-backed contracts. An investment contract is a contract issued by a financial

institution to provide a stated rate of return to the buyer of the contract for a specified period of time. A security-backed contract has similar characteristics to a traditional investment contract and is comprised of two parts: the first part is a fixed-income security or portfolio of fixed-income securities; the second part is a contract value guarantee (wrapper) provided by a third party. Wrappers provide contract value payments for certain participant-initiated withdrawals and transfers, a floor crediting rate, and return of fully accrued contract value at maturity. The Fund contains several redemption restrictions including the right to require a 12-month notice for withdrawal of assets from the Fund initiated by the Company. Withdrawals initiated by participants of the Plan will be honored when received. There are no unfunded commitments or reserves as of December 31, 2024 and 2023.

## 5. Fair Value Measurements

### a. Fair Value Hierarchy

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets,
  - Quoted prices for identical or similar assets or liabilities in inactive markets,
  - Inputs other than quoted prices that are observable for the asset or liability, and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
  - If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments held in the Plan primarily consist of mutual funds and a common collective trust. These assets are recorded at fair value on a recurring basis. The common collective trust is measured at fair value using the Net Asset Value (“NAV”) per share (or its equivalent) as a practical expedient.

The following is a description of the valuation methodologies used for the Plan's investments at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

The mutual funds are valued at quoted market prices which are available on active markets and, therefore, are classified as Level 1 within the valuation hierarchy.

Common Collective Trust

Valued at the NAV of units of a bank collective trust. The NAV is used as the practical expedient to estimate fair value and it is based on the fair value of the underlying investments. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. See discussion at Note 4.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes these valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**b. Investments Calculated at Net Asset Value per Share**

The common collective trust is a stable return fund whose primary objective is to provide investors with a moderate level of stable income without principal volatility. There were no unfunded commitments as of December 31, 2024 and 2023.

**6. Party-in-Interest Transactions**

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or a relative of such persons mentioned.

Certain Plan investments were managed by the Custodian during the years ended December 31, 2024 and 2023. Therefore, any investment transaction executed with the custodian qualifies as a party-in-interest transaction.

The Company is a party-in-interest to the Plan. However, there were no transactions with the Company other than the funding of contributions to the Plan and the payment of certain administrative expenses.

## **7. Partial Plan Termination**

As a result of a reduction of the Plan Sponsor's workforce in 2024, the Plan experienced a partial plan termination. Under ERISA, a partial plan termination may occur if a significant percentage of the Plan participants are terminated due to an action taken by the Plan Sponsor. As a result of this partial plan termination, all affected participants of the Plan were fully vested in their account balances. The remaining participants' vesting continues to be determined according to the Plan provisions.

## **8. Tax Status**

The Plan utilizes a Volume Submitter Profit Sharing Plan Document which received an opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that as of that date the Plan document was designed in compliance with the applicable IRC requirements. The Plan has been amended since receiving the opinion letter. However, Plan management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, Plan management believes that the Plan is qualified and the related trust is tax exempt as of December 31, 2024 and 2023 and for the years then ended.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **9. Risks and Uncertainties**

The Plan invests in various investment securities, including mutual funds and a common collective trust. Investment securities, in general, are exposed to various risks such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**10. Non-exempt Transactions**

During 2024, the Company failed to timely remit participant contributions totaling \$2,072 to the Plan as required by the Department of Labor. The Company is in the process of funding these amounts and restoring the lost earnings under the IRS's Self Correction Program.
