Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Pandi Capital LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Pandi Capital LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General – The Plan was established September 24, 2021. The following employers (collectively the “Company” or “Sponsor”) participate in this Plan:

- BlueRoof Entertainment, LLC
- Excolo LLC
- FanThreeSixty, LLC
- FiveStar Lifestyles, LLC
- Grand Lakes Holdings, LLC
- Hospitality Kansas City, LLC
- Maple Ranch Properties, LLC
- Novation iQ, LLC
- OnGoal, LLC
- Pandi Capital, LLC
- Sporting Club USL, LLC
- The Illig Household
- TIFEC, LLC
- VanBrock, LLC

The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (“ERISA”). Empower Trust Company, LLC serves as the Plan’s custodian and trustee, Empower Retirement, LLC serves as the Plan’s recordkeeper.

Eligibility – Regular employees at least 21 years of age who have completed 3 months of service, may enter the Plan on the first day of the month coinciding with or next following the date the eligibility requirements have been satisfied.

Employees who are classified as union employees, interns, leased, part-time, temporary, or seasonal employees (employees whose regularly scheduled service is less than one year of service) are excluded from the Plan. However, if part-time, temporary, or seasonal employees complete a year of service, they shall enter the Plan on the first day of the following month.

Contributions – Participants may elect to contribute any percentage or dollar amount of their annual compensation up to 70%, as defined by the Plan, subject to certain Internal Revenue Code (“IRC”) limitations. Participants may elect to make pre-tax contributions, or Roth contributions. Participants who are at least 50 years or older may make catch-up contributions.

When a participant has met the eligibility requirements, automatic deferrals equal to 3% of compensation will be made to the Plan, unless the participant states in writing otherwise. Additionally, the deferral rate automatically increases over time, unless the participant elects otherwise, according to the following schedule: 1-2 years - 3%, 3 years – 4%, 4 years – 5%, 5 or more years – 6%. In addition, participants over age 50 are permitted to make catch-up contributions, as defined in the Plan. Participants who affirmatively make a deferral election are not subject to the deferral escalation clauses.

The Company makes a QACA safe-harbor matching contribution equal to 100% of each participant’s salary reduction contributions up to 1% of eligible compensation, and 50% of such participant’s salary reduction contribution from 1% to 6% of compensation. The matching contribution is paid into the Plan each payroll, however, the determination period for the matching contribution is the Plan year. Therefore, it may be necessary to make a true-up contribution to certain Plan participants after the Plan’s year end.

Additionally, the Plan permits the Company to make discretionary non-elective contributions. In order to receive a non-elective contribution, a participant must be employed on the last day of the Plan year. No such contributions were made for 2024.

Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings (losses). Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options – Participants direct their investments into a variety of mutual funds, variable annuities or common collective trusts ("CCT").

Vesting – Participants' contributions are fully vested at all times. The Company QACA safe-harbor matching contribution becomes 100% vested after 2 years of service. The employer non-elective contributions vest 50% after 1 year of service and become 100% vested after 2 years of service. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested. A participant must work for at least 1,000 hours in a year to earn a year of service.

Forfeitures – Forfeited balances of terminated participants' non-vested accounts may be used to reduce employer contributions or pay permitted fees of the Plan. During 2024, \$15,788 was used to pay Plan expenses and \$31,946 was used to reduce the employer contribution. As of December 31, 2024 and 2023, there was \$17,174 and \$30,567 respectively, in the forfeiture balance.

Payment of Benefits – Upon termination of service, the participant, or in the case of death, the participant's beneficiary, may elect to receive the vested value of the participant's account in a lump-sum. If the vested portion of the account balance is less than \$7,000, the participant's vested account balance will be automatically distributed if the participant does not elect to roll-over the balance to another qualified plan. Balances between \$1,000 and \$7,000 will be automatically rolled over to an IRA account.

In-Service Withdrawals – Participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants for purposes as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the portion of the participant's

Participants who have obtained the age of 59 ½ are allowed to receive a distribution of all or any portion of the vested account balance in a single lump sum payment.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans may be made from the participant's vested account balance. The maximum loan term is 5 years, unless the loan is for the purchase of the participant's principal residence, in which case the maximum term is 15 years. The loans are secured by the balance in the participant's account, and bear interest at the *Wall Street Journal* prime rate plus 1%. A participant may have one loan outstanding at a time. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses – Administrative expenses are paid by the Plan or the Company, as defined in the Plan. During 2024, administrative expenses of \$188,602 were paid by the Plan.

Termination of the Plan – Although the Plan Sponsor has not expressed any intent to do so, it has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants will become fully vested in their account balances.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest is accrued when earned. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in mutual funds, variable annuities and CCTs are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction on investment return for such investments.

Contributions – Contributions are recorded in the year that services are rendered.

Payment of Benefits – Benefit payments are reported in the year of payment.

Date of Management's Review – Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued, and there were no events that required adjustment or disclosure.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds – Valued at the closing price reported on the active market on which the individual securities are traded.

Variable Annuities – The investment advisors calculate a unit value (similar to a net asset value “NAV”) of a separate account. It is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any.

Common Collective Trusts – Empower calculates a unit value (similar to a NAV) of the CCT. It is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan’s investments are reported at fair value as follows at December 31, 2024 and 2023:

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, the trustee of the Plan, has certified that the following data included in the accompanying financial statements is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Net appreciation in fair value of investments
- Notes receivable from participants and related interest income
- Interest and dividend income

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

6. TAX STATUS

The Company adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan with a deferral arrangement which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

An investment of the Plan is issued by Putnam, which is affiliated with Empower. This is a permitted party-in-interest. The Plan pays expenses to Empower, and to the Plan's broker and auditor. These are exempt party-in-interest transactions. Notes receivable from participants are exempt party-in-interest transactions.
