**Note 1. Description of Plan**

The following description of the Troy Bank & Trust Company (Company) 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all full-time employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Upon enrollment in the Plan, a participant may direct contributions into various investment options offered by the Plan. Each year, participants may contribute up to 60% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may contribute 100% of the first 5% of base compensation, as defined in the Plan, that a participant contributes to the Plan. The matching Company contribution is invested as the participant has directed for participant contributions. Additional profit sharing amounts may be contributed at the option of the Company's board of directors and are invested as the participant has directed for participant contributions. Contributions are subject to certain limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions, Company matching contributions, and earnings on their investments, as well as allocations of the Company's profit sharing contribution. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions plus earnings thereon is based on years of continuous service. A participant vests at a rate of 20% per year beginning after two years of service until 100% vested at the end of six years.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

**Note 1. Description of Plan, Continued**

Payment of Benefits - On termination of service due to death, disability, retirement, or termination for other reasons, a participant (or designated beneficiary) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or may elect installment distributions. In-service distributions may be taken from a participant's vested account balance once the participant has attained the normal retirement age of 65.

Forfeitures - As of December 31, 2024, and 2023, forfeited nonvested accounts totaled \$0 and \$14,779, respectively. These accounts shall first be used to pay administrative expenses under the Plan, if so directed by the employer. To the extent that forfeitures are not used to reduce administrative expenses under the Plan, as directed by the employer, forfeitures will be applied to reduce the contributions of the employer. In 2024 and 2023, employer contributions were reduced by \$84,439 and \$55,869, respectively, from forfeited nonvested accounts.

**Note 2. Summary of Significant Accounting Policies**

Plan Amendments - The Plan was amended effective November 3, 2023, to allow for Roth contributions and rollover of Roth Contribution. The Plan was amended effective June 19, 2024, to allow for hardship distributions.

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, the actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Note 2. Summary of Significant Accounting Policies, Continued**

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Participant fees and fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

**Note 3. Information Certified by Custodian (Unaudited)**

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements, which was prepared by the Custodian of the Plan, and furnished to the Plan Administrator. **Note 4. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Custodian (see Note 3) as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Net fees expensed from the Plan by the service provider were \$8,361 for the year ended December 31, 2024. Net fees reimbursed to the Plan by the service provider were \$25,730 for the year ended December 31, 2023. The Company pays directly any other fees related to the Plan's operations.

**Note 5. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on December 31, 2024, and 2023:

*Interest-bearing cash:* Because of the nature of these assets, carrying amounts approximate fair value.

*Registered investment companies:* Valued primarily on the basis of market quotations or official closing prices of the underlying assets.

*Self-directed brokerage account:* Consists of interest-bearing cash, common stock, real estate investment trust, and certificates of deposit. The common stock and real estate investment trust, included as Level 1 input, are valued at the closing price reported on the active market on which the individual securities are traded. Included as a Level 2 input, the certificate of deposit investments are valued at amortized cost, which approximates fair value.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Tax Status**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan has filed Form 5500, which is the annual return for employee benefit plans, for all years through December 31, 2023. Years December 31, 2021, and subsequent remain subject to audit by taxing authorities. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
