Independent Auditor's Report

To the Board of Directors
Loud Audio, LLC 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Loud Audio, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. 1. DESCRIPTION OF PLAN

The following description of Loud Audio, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan established on January 1, 1992, covering all employees of Loud Audio, LLC (the Company). The Company is also the plan sponsor and plan administrator.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Eligibility

All employees who are at least 21 years of age are eligible to participate in the Plan immediately upon hire unless they are in an ineligible class of employees, as defined in the plan agreement.

c. Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

In addition to pre-tax salary deferral contributions, participants may make Roth post-tax contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

At its discretion, the Company may elect to make matching contributions or non-elective contributions to the Plan. During the year ended December 31, 2024, the Company matched 50% of each participant's contributions up to a maximum of \$1,000. For 2024, there were no non-elective employer contributions.

Participants direct their contributions, discretionary employer contributions, and any related earnings into a variety of investment options offered by the Plan. Participants may change their investment elections and make transfers between investment options on a daily basis.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

d. Participant accounts

Each participant's account is credited with the participant's salary deferral contribution, employer contribution, and an allocation of the Plan's earnings or losses. The allocation of the Plan's earnings or losses is based on each participant's share/unit values as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN, (Continued)

e. Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings or losses thereon.

Upon attaining the Plan's normal retirement age or if employment is terminated because of death or disability or if the participant becomes eligible for early retirement, then the participant's interest in any matching or non-elective employer contributions will become 100% vested. The Plan defines a participant's normal retirement age as 65. Participants qualify for early retirement if they have completed five years of service while a plan participant and terminate after reaching age 55 but before reaching age 65.

If employment is terminated prior to normal retirement age for any reason other than death or disability, then the participant's interest in any matching or non-elective contributions that the Company makes to the Plan will become vested in accordance with the following schedule:

Less than 1	0%
1 but less than 2	20%
2 but less than 3	40%
3 but less than 4	60%
4 but less than 5	80%
5 or more	100%

f. Notes receivable from participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms can be up to five years except loans used to purchase a primary residence can be for up to ten years. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. At December 31, 2024, the interest rate on all outstanding loans is 8.50%-9.50%. The Plan requires repayment of the loan obligation through payroll deductions; however, the participant may repay the loan at any time.

g. Payment of benefits

Upon retirement, disability, termination, or death, a participant or the stated beneficiary shall elect distribution under one, or any combination, of the following methods if the vested account balance exceeds \$7,000:

- Direct rollover to an IRA or other eligible retirement plan;
- Immediate payment in a lump sum;
- Postpone until age 70½ at which time partial distributions in installments may begin;
- A lump sum payment upon reaching age 70½.

g. Payment of benefits, (Continued)

If a participant's vested account balance is under \$7,000 but over \$1,000, then the distributions will be made as soon as administratively feasible after the participant leaves the Company. If the participant does not respond regarding method of distribution, then the distribution will be rolled automatically into an Individual Retirement Account in the name of the participant.

If the participant's account balance is under \$1,000, then the distribution will be automatically made regardless of whether the participant consents to receive it.

Participants may also withdraw funds from their account in the event of financial hardship as defined in the plan agreement.

h. Forfeited accounts

Forfeitures of terminated participants' nonvested accounts are maintained in a separate account under the Plan. Under the terms of the Plan, forfeitures that arise in any given plan year are first to be used toward the Plan's expenses and then to reduce any employer contributions.

Unallocated forfeitures of terminated participants' nonvested accounts totaled \$96 and \$94 at December 31, 2024 and 2023, respectively. During 2024, there were no forfeitures used for expenses or to reduce employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

b. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

c. Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are required to be reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

e. Payment of benefits

Benefits are recorded when paid.

f. Administrative expenses

Certain administrative expenses were paid by the Company and are not reflected in these financial statements. Administrative expenses not paid by the Company are charged to participants' accounts and are apportioned based upon their relative account values. Transaction based fees are charged directly to participants' accounts.

g. Date of the Plan's review

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

3. TRUSTEE CERTIFICATIONS UNDER ERISA SECTION 103(a)(3)(C)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the auditors' examination did not extend to the following information certified by Lincoln Financial Group Trust Company, Inc. (Lincon Trust), the trustee, as complete and accurate:

- Investments
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. GUARANTEED INVESTMENT CONTRACT

The Plan has a fully benefit-responsive guaranteed investment contract with The Lincoln National Life Insurance Company (Lincoln), the Lincoln Stable Value Account. Lincoln maintains contributions in a general account. Specific securities within the general account are not attributed to the guaranteed investment contract. The account is charged for participant withdrawals and administrative expenses. Lincoln is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

5. GUARANTEED INVESTMENT CONTRACT, (Continued)

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

- Amendments to the Plan documents (including complete or partial plan termination or merger with another plan).
- Changes to the Plan's prohibition on competing investment options.
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that causes a significant withdrawal from the Plan.
- The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
- Premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines.
- A breach of material obligation under the contract.
- A material misrepresentation.
- A material amendment to the agreement, with the consent of the issuer.

6. PARTY-IN-INTEREST TRANSACTIONS

During 2024 and 2023, the Plan held investments in fund options managed by Lincoln Trust, the Plan trustee. Transactions with the trustee are recognized as exempt party-in-interest transactions under ERISA.

For the year ended December 31, 2024, the Plan paid \$54,989 for certain expenses related to the plan operations to various service providers. These expenses are recognized as exempt party-in-interest transactions under ERISA.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

8. TAX STATUS

The Plan utilizes a non-standardized pre-approved profit-sharing plan that received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
