INDEPENDENT AUDITOR'S REPORT

To the Trustees of Compass Holding 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Compass Holding 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Compass Holding 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Compass Holding 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

COMPASS HOLDING 401(k) PLAN NOTES TO FINANCIAL STATEMENTS

NOTE 1: Description of the Plan:

General:

The following description of the Compass Holding 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan maintained for the benefit of eligible employees (as defined) of Compass Holding, LLC and related adopting employers (the "Company").

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is designed as a qualified cash deferred arrangement pursuant to Section 401(k) of the Internal Revenue Code and provides for the following contributions which are to be maintained in separate accounts.

Employee-directed contributions:

Eligible employees of the Company may elect to defer up to 90% of their annual compensation (as defined) to the Plan, not to exceed Internal Revenue Code limitations.

Employee rollover contributions:

To be made by the employee from amounts received from any other qualified plan, subject to the provisions of applicable tax law.

Employer contributions:

The Plan provides for the Company to make matching contributions. 100% of the first 1% of salary deferrals plus 50% of the salary deferrals between 1% and 6% are matched by the employer. The total employer contributions for the year ended December 31, 2024 were \$255,404.

Participant accounts:

Employees have the ability to direct their employee and employer contributions into a variety of investment options allowed by the Plan.

Investment income and the fair value appreciation or depreciation are allocated to participants and terminated participants (who have undistributed account balances) based on account balances, as defined.

NOTE 1: Description of the Plan (continued):

Participant accounts (continued):

Each participant's account is credited with participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their contributions, plus earnings thereon. Vesting in employer contributions, and earnings thereon, is based on years of continuous service. A participant is 100% vested after two years of vesting service, as defined.

Forfeitures occur when employees terminate employment with less than 100% of employer contribution vested. The Sponsor uses forfeitures to reduce administrative expenses or contributions. For the year ended December 31, 2024, there was \$40,702 available for allocation.

Hardship withdrawals:

The Plan allows for hardship withdrawals of elective deferrals. Participants that have received hardship withdrawals are allowed to continue making elective deferrals to the Plan.

Payment of benefits:

Payments of benefits are made to participants or their beneficiaries upon death, retirement, when they reach retirement age, disability or termination of employment. Benefits are payable in a lump sum or by other methods as described in the Plan.

NOTE 2: Significant accounting policies:

Basis of presentation:

The financial statements of the Compass Holding 401(k) Plan have been prepared on the accrual basis of accounting, with investments being carried at fair value. The fair value of the investment funds is determined by quoted prices in an active market.

NOTE 2: Significant accounting policies (continued):

Recognition of income:

The basis of investments held by the Plan is adjusted annually to the closing market value and unrealized gains and losses are recorded as part of this adjustment. Realized and unrealized gains and losses on investments are computed using adjusted basis (beginning of year market value) on the first-in, first-out method. Security transaction expenses are considered in computing realized gains and losses on investments.

Investments:

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits:

Payment of benefits are recorded when paid.

Expenses:

Expenses associated with Plan administration are paid either by the Plan or the Company. Investment related expenses are included in the net appreciation of fair value of investments.

Use of estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3: Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts

Pooled separate accounts invest primarily in domestic and international stocks or single mutual funds. The domestic and international stocks are valued at the closing price reported on the active market on which the individual securities are traded. The mutual funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan within the pooled separate accounts are deemed to be actively traded.

NOTE 5: Related party and parties-in-interest transactions:

The Plan includes certain investments managed by the Trustee. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan amounted to \$74,262 for the year ended December 31, 2024.

Certain administrative services, principally the maintenance of the Plan's accounting records, are performed by Compass Holding at no charge to the Plan.

All of these party-in-interest transactions are exempt for the prohibited transaction rules of ERISA.

NOTE 6: Plan termination:

The Company intends to continue the Plan indefinitely; however, it does have the right to terminate it, discontinue it, or amend it from time to time. If the Plan terminates, or there is a permanent discontinuance of contributions, all participants' accounts will become fully vested.

NOTE 7: Income tax status:

The Plan is a standardized prototype plan sponsored by Nova 401k Associates, Inc that has been adopted by the Company. The prototype plan obtained its latest opinion on June 30, 2020, which the Internal Revenue Service ("IRS") stated the prototype plan, as then designed was in compliance with the application requirements of the Internal Revenue Code ("IRC"). The Plan has not requested its own determination letter from the IRS. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

NOTE 8: Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9: Subsequent events:

Subsequent events have been evaluated through September 25, 2025, which is the date the financial statements were issued.
