Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Robindale Energy Services 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan sponsored by Robindale Energy Services, Inc. (Company) covering substantially all full-time employees of the consolidated entities under the Company, as well as employees of Carbon Direct, LP and Custom Software Solutions, Inc. who are at least 18 years of age and are full-time employees. Part-time employees are eligible after they reach 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may contribute through salary reduction up to a maximum amount that would not violate provisions of the Internal Revenue Code (IRC). Those who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). They may direct the investment of their contributions into various investment options offered by the Plan. The Company makes a mandatory 3% contribution (safe harbor contribution) of eligible employees' annual compensation earned while a participant is in the Plan. In addition, the Company contributes a discretionary matching contribution up to 3% of eligible compensation. For the years ended December 31, 2024 and 2023, the Company's discretionary matching contribution was 3%.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and the Plan's earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances or specific participant transactions as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants' voluntary contributions and all Company contributions are immediately vested upon contribution.

Notes Receivable from Participants - Participants may borrow from their fund accounts up to a maximum equal to the lesser of (1) \$50,000, less the greater of the highest outstanding balance of participant loans for the prior year or the loan balance on the date the loan was made, or (2) up to 50% of their account balance. Any loan must be repaid within five years, unless it is made for the purpose of acquiring the primary residence of the participant, in which case, the loan may be repaid over a period not to exceed 15 years. Loans are secured by the balance in the participant's account and generally bear interest at prime. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits - On termination of service due to death, disability, retirement or other reasons, a participant is entitled to the fair market value of the participant's vested interest in his or her account. Participants may elect to receive benefit payments in a single lump sum, a life annuity or a combination of partial withdrawals. In-service distributions may be made to a participant who has not separated from service provided that participant has obtained the age of 59½. The Plan requires that all participants with a vested account value of \$7,000 or less at the time of separation be distributed to the employee or another qualified account in a single lump sum.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

The Plan provides for withdrawals, other than distributions to terminated employees, based on financial hardship. The Plan administrator may determine a financial hardship exists based on several events outlined in the Plan document, including expenses for medical care, payment of tuition expenses, costs related to the purchase of a principal residence, qualified disaster relief and payments necessary to prevent the participant from being evicted from their personal residence.

Forfeited Accounts - These accounts would first be used to pay administrative expenses of the Plan and any remaining forfeitures would be used to reduce future Company contributions. Forfeitures were not significant to the Plan for the years ended December 31, 2024 and 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying statements of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements (financial statements) follows:

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value (See Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (See Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Paid to Participants - Benefits are recorded when paid, unless a situation arises where benefits are to be paid but actual disbursement does not occur until the following Plan year, in which case accrued benefits are recorded. There were no accrued benefits recorded as of December 2024. Benefits accrued at December 31, 2023, were approximately \$37,000.

Administration Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants and benefit payments are charged directly to participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events for recognition or disclosure through October 7, 2025, the date the financial statements were available to be issued.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN CUSTODIANS

Certain information related to the investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, income from interest and dividends and interest income from notes receivable from participants for the year ended December 31, 2024, were obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank and The Standard Insurance Company, the custodians of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 or 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has a fully benefit-responsive investment contract with Standard Insurance Company (The Standard), the recordkeeper and custodian. The contributions into the stable asset fund are maintained in a general account. The account is credited with earnings on the underlying interest contract. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The Plan held approximately \$8,545,000 and \$7,307,000 in the stable asset fund for the years ended December 31, 2024 and 2023, respectively.

Because the stable asset fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the stable asset fund, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

Crediting rates for the Plan's stable asset fund are set by Standard using a process similar to that used by banks or other insurance companies for similar products. The crediting rate is declared in advance and is reset quarterly. The fund's declared crediting rate will never be below 1% annually. The crediting rates for the years ended December 31, 2024 and 2023 were 3.04% and 2.78%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer, including: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) divestitures or spinoffs that cause a significant withdrawal from the Plan; (4) corporate relocations; or (5) the failure of the trust to qualify for exemption under ERISA. The Plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with participants are probable.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its operations at any time and to terminate the Plan subject to the provisions of ERISA. Upon complete or partial termination of the Plan, participants will become 100% vested in their accounts.

NOTE 7 - TAX STATUS

The underlying nonstandardized prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan is qualified under Section 401 of the IRC and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan sponsor has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. While the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions however there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for tax years prior to 2021.

NOTE 8 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Company pays certain accounting and administrative expenses, and its employees perform certain administrative functions on behalf of the Plan for which no fees are charged.

Certain Plan investments are managed by the recordkeeper, and custodians, therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included within net appreciation in fair value of investments.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in securities that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonable possible that changes in value will occur in the near term and that such changes could materially affect participants' account balance and the amounts reported in the statements of net assets available for benefits.
