Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified information with the related information presented and disclosed in the financial statements, and reading the disclosures related to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Plan Description

The following description of the Greenbaum, Rowe, Smith & Davis LLP 401(k) Plan and Trust for Partners, Key Employees and Certain Non-Lawyer Staff Employees (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is an employee elective deferral 401(k) and defined contribution plan covering eligible employees and electing partners of Greenbaum, Rowe, Smith & Davis LLP (the “Partnership”). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”).

During the year ended December 31, 2024, there was a total of \$719,368 transfers from Greenbaum, Rowe, Smith & Davis LLP 401(k) Plan and Trust for Associates and Certain Non-Lawyer Staff Employees (“GRU”).

Eligibility

All employees who are classified by the Partnership as either Partner, Non-partner who is a key employee, non-lawyer holding the position of Secretary, Para-legal professional, Timekeeping or Bookkeeping, are at least 21 years old and have completed the applicable service (as defined) are eligible for participation in the Plan. Eligible individuals will be permitted to enter the Plan on the first day of any month after one complete month of service.

Contributions

Participant contributions are made on a Roth 401(k) or pre-tax basis. Participants may elect to contribute up to 100% of their compensation, subject to Plan limits and the dollar deferred and non-discrimination limitations as prescribed by the Internal Revenue Code (“IRC”).

Employer matching contributions can be made at the discretion of the Partnership. There were no employer contributions during the year ended December 31, 2024.

Vesting

A participant is 100% vested in his or her salary deferral contributions plus earnings thereon. A participant becomes 100% vested in the contributions by the Partnership after three years of service.

Forfeitures

Forfeitures on non-vested amounts shall be applied to reduce employer contributions for the plan year in which such forfeitures occur. There were no forfeitures during 2024 and no forfeitures available for application at December 31, 2024 and 2023.

Payment of Benefits

Upon normal retirement age, all amounts credited to a participant’s account shall become distributable. Upon a participant’s termination or as soon thereafter as is practicable, the trustee shall distribute all amounts credited to such participant’s account.

Death Benefits

Upon the death of a participant before his or her retirement date, all amounts credited to such participant's account shall become fully vested. Within a reasonable period following such death, the administrator shall direct the custodian to distribute the balance of the deceased participant's account to the participant's beneficiary.

Participant Accounts

Each participant's account is credited with their deferred contributions, employer contributions and earnings thereon. Contributions are invested based on the percent allocation elected by the participant into one or more of the investment options available to the Plan.

Administrative Expenses

Administrative expenses may be paid by the Partnership or the Plan, at the Partnership's discretion.

Notes Receivable from Participants

The Plan permits participants to borrow from their vested account balances in the Plan. A participant is permitted to borrow up to the lesser of \$50,000 or 50% of his or her vested account balance. Loans are measured at their unpaid principal balance plus any accrued, but unpaid interest. A loan must bear a reasonable interest rate and is collateralized by the participant's vested account balance. As of December 31, 2024, interest rates on outstanding loans ranged from 4.25% to 9.50% per annum.

ERISA Budget Account

The Plan shares in investment related revenue, which Charles Schwab Trust Bank, the custodian, receives from mutual funds or collective trusts attributable to the Plan assets invested in such mutual funds and trusts. The Plan receives a credit for the revenue share on a quarterly basis which is deposited into an ERISA Budget Account. The Company can use the funds in the account to pay for certain approved plan related expenses. During 2024, there was no activity in the account and no funds available to pay plan related expenses as of December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities reported in the financial statements. Actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Plan investments are reflected in the accompanying statements of net assets available for benefits at fair value as determined by management (see Note 3). The sales and purchases of investment securities, and gains and losses on the sale of investments are recognized at the trade date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Note 3. Fair Value Measurement

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Common collective trusts: The fair value of the common collective trust is determined by the trustee of the common collective trust based on the underlying assets, which represents the net asset value, a practical expedient of fair value, of units held by the Plan. The common collective trusts do not have any unfunded commitments relating to their investments, or any significant restrictions or redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

Mutual funds and money market fund: Mutual funds and the money market fund are valued based on the quoted prices in an active market for each share held by the funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5. Tax Status

The IRS has determined and informed Greenbaum, Rowe, Smith & Davis LLP by a letter dated September 15, 2004, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Party-In-Interest Transactions

Charles Schwab Trust Bank, the custodian of the Plan, manages certain plan investments; therefore, these transactions qualify as party-in-interest transactions. Fees paid to the custodian by the Plan for management services amounted to \$47,738 for the year ended December 31, 2024.

Note 7. Risk and Uncertainties

The Plan's investments are concentrated in funds that invest in marketable securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

Note 8. Plan Termination

Although it has not expressed any intention to do so, the Partnership has the right to terminate the Plan subject to the provisions set forth in ERISA. Whole or partial termination of the Plan shall result in the full and immediate vesting of discretionary contributions and earnings thereon. Each participant is entitled to full distributions of such amounts.

Note 9. Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.
