### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Gusmer Enterprises Inc. Employees 401(k) Savings and Profit Sharing Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### NOTE A - DESCRIPTION OF THE PLAN

The following description of the Gusmer Enterprises Inc. Employees 401(k) Savings and Profit Sharing Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### [1] General:

The Plan is a participant-directed, defined contribution plan established to provide retirement benefits to eligible employees, as defined, of Gusmer Enterprises Inc. (the "Employer" or the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### [2] Eligibility:

An employee is eligible to participate in the Plan immediately after beginning service. Newly eligible employees are automatically enrolled into the Plan within 30 days of beginning service unless the employee explicitly opts out of participation in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation. The Plan also has an escalation feature whereby the deferral rate will increase each year by 1% up to a maximum of 15%.

#### [3] Contributions:

Participants in the Plan may elect to contribute up to 60% of pre-tax and/or post-tax annual compensation, as defined in the Plan, subject to an annual limitation set forth in the Internal Revenue Code (the "Code"). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. For employees, the Plan provides for the Employer to match an amount equal to 50% of that portion of the participant's contributions which does not exceed 5% of the participant's eligible earnings.

For non-union and "Compensation-Based" union employees, the profit-sharing contribution allocation to the participant's account is principally determined based upon a percentage of the participant's eligible compensation, the participant's start date and other factors as outlined in the Plan. For union employees using the "Unit-Based Method", the allocation shall be equal to employees accumulated units multiplied by a dollar multiplier set forth in the collective bargaining agreement between the Employer and the union.

The Employer also may make discretionary matching contributions of a percent, if any, to be determined annually based on a percentage of employee pre-tax contributions. The Employer may also make an annual Discretionary Employer Profit Sharing Contribution in such amount as the Employer, at its absolute discretion, may determine. The profit-sharing contribution allocation to the participant's account is principally determined based upon a percent of the participant's eligible compensation, the participant's participation start date, and other factors as outlined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. For the year ended December 31, 2024, the Employer made discretionary matching contributions totaling \$222,454. These contributions were deposited into the Plan in 2025 and were fully funded from the forfeiture account. The Employer did not make a discretionary profit-sharing contribution for the 2024 Plan year.

**NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)**

**[4] Participant accounts:**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's matching contributions, allocations of other Company contributions, if any, and Plan earnings (losses), and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**[5] Administration:**

The assets of the Plan are held by Fidelity Management Trust Company ("Fidelity" or the "Trustee"). Fidelity acts as the trustee and custodian for the Plan.

**[6] Investments:**

Participants direct the investment of their contributions into various investment options offered by the Plan. Company contributions are automatically invested in the funds as the employee directs. The Plan currently offers various mutual funds and four common collective trusts as investment options for participants.

**[7] Vesting:**

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts, plus actual earnings thereon, is as follows:

**[8] Notes receivable from participants:**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator, ranging from 4.25% to 9.50% at December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

#### [9] Payment of benefits:

On termination of service, a participant receives a benefit equal to the vested value of his or her account as a lump-sum, installment payments or partial withdrawals. Withdrawals by participants during their employment are permitted with certain restrictions.

#### [10] Forfeitures:

Forfeited non-vested accounts are used to reduce future Company contributions and pay Plan expenses. During the year ended December 31, 2024, forfeitures of approximately \$256,000 were used to fully fund the 2023 employer discretionary matching contributions and forfeitures of approximately \$83,000 were reinstated to participant accounts for corrections related to the partial plan termination (see Note F). Forfeited non-vested accounts available at December 31, 2024 and 2023 were approximately \$222,000 and \$339,000, respectively.

#### [11] Retirement age:

Normal retirement is the date on which the participant has attained age 65. By mutual consent, a participant may be permitted to continue to engage in the business and his or her retirement date shall be deferred. Participants become 100% vested in their account balance when they attain retirement age. Early retirement distributions are permitted after the participant has attained age 60 and has no service requirement.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### [1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting.

#### [2] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### [3] Payment of benefits:

Benefits are recorded when paid.

#### [4] Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized/unrealized appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### [5] Plan expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Fidelity, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants, and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2* – Inputs to the valuation methodology include; (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)**

*Collective trust funds* – Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

**NOTE E - RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan were \$76,170 for the year ended December 31, 2024.

The Trustee provides certain administrative services to the Plan and receives revenue from mutual fund providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative services to the Plan. If the revenue received by the Trustee from such mutual fund service providers exceeds the amounts owed, the Trustee remits the excess to the Plan pursuant to the service agreement. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants, depending on the Plan's provisions. During 2024, \$141,701 was received from the Trustee and is reflected as other income in the statement of changes in net assets available for benefits, \$76,170 was used to pay Plan expenses and \$65,531 was allocated to participant accounts. The account balance as of December 31, 2024 and 2023 was \$19,588 and \$0, respectively.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their Company contributions.

During the year ended December 31, 2024, the Plan Sponsor determined that the Plan experienced a partial termination. As a result of the partial termination, the affected participants became fully vested upon their termination date.

### **NOTE G - TAX STATUS**

The Plan has adopted a Non-Standardized Pre-Approved Defined Contribution Plan sponsored by FMR LLC. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Code. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in process.

### **NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

### **NOTE I - MUTUAL FUND FEES**

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

### **NOTE J - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.
