**Note 1. Plan Description**

The following description of the AgriVision, Inc. 401(k) Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:**

The Plan is a defined contribution plan covering all employees of AgriVision, Inc. (the Company) who are age 21 and have met the service requirement of one year of service in which the employee works at least 1,000 hours. Employees enter the Plan on the first January 1 or July 1 that occurs after the employee has completed the eligibility service period. In addition, long-term part-time employees who do not satisfy the standard service requirements of the Plan are eligible to make employee contributions into the Plan after completing 500 hours of service during each of three consecutive years of service (two consecutive years starting January 1, 2025) under the long-term part-time rules. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan administration:**

The Company is the Plan sponsor and Plan administrator. The Plan administrator is responsible for carrying out the duties imposed under ERISA, including oversight of the Plan, appropriateness of investment offerings, and monitoring investment performance.

The Company contracts with John Hancock Life Insurance Company (U.S.A.) to act as recordkeeper and the custodian of the participant directed investments of the Plan.

Hicks Pension Services serves as the third-party administrator to maintain records of the participant data.

**Contributions:**

Participants may elect to contribute into the Plan a percentage of their annual compensation as defined in the plan document, which is withheld from employee's pay through payroll deductions. Participants may also designate a portion or all of the deferral contributions as Roth 401(k). Elective contributions may not exceed the maximum deferral limit per section 402(g) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a safe harbor contribution in the amount of up to 4% of each eligible participant's compensation. The safe harbor contribution for the year ended December 31, 2024, was \$407,620.

The Company may, in its discretion, make employer profit sharing contributions and employer matching contributions to the Plan. There were no such contributions for the year ended December 31, 2024. Discretionary employer profit sharing contributions, if any, are allocated to participants who worked at least 1,000 hours during the Plan year and are employed on the last day of the Plan year.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

***Participant accounts:***

Each participant's account is credited with the participant's contributions and safe harbor matching contributions, as well as allocations of the Company's matching contribution and profit sharing contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. All amounts in participant accounts are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting:***

Participants are vested immediately in their contributions plus actual earnings thereon. A participant's vested interest in their safe harbor contributions plus actual earnings thereon are immediately vested regardless of the number of years of service. Vesting in the Company's discretionary matching contribution and discretionary profit sharing contribution portions of their account balance, if any, is based on years of service as follows:

***Notes receivable from participants:***

The Plan does not permit participant loans.

***Benefit payments and withdrawals:***

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account, or installments. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump sum amount.

Upon termination for any reason, if the terminated participant's vested and non-forfeitable balance is less than \$1,000 the participant's balance may be distributed in the form of a cash distribution. If the terminated participant's vested and non-forfeitable balance is over \$1,000 but less than \$7,000, the participant's balance may be distributed as a direct rollover to a default IRA, without authorization from the participant.

***Forfeited accounts:***

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees or adjustments, if any. At December 31, 2024 and 2023, the forfeiture balance was \$0. At the discretion of the Plan administrator, forfeitures may be applied to offset Plan expenses and employer contributions. There were no forfeitures used during the year ended December 31, 2024.

***Note 2. Significant Accounting Policies***

***Basis of accounting:***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of estimates:***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment valuation and income recognition:***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan sponsor's management determines the Plan's valuation policies utilizing information provided by the custodian and investment advisors.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Excess contributions payable:***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions, if any.

***Payment of benefits:***

Benefits are recorded when paid.

*Administrative expenses:*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in administrative expenses or net appreciation of fair value of investments.

**Note 3. Certified Investments**

The following information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.).

**Note 4. Investments and Fair Value Measurements**

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or by other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Sub-account values are measured at the NAV per share of the underlying fund held in the sub-account on a daily basis, and the values are readily determinable.

**Note 5. Related Party and Party-in-Interest Transactions**

John Hancock Life Insurance Company (U.S.A.) is the custodian and recordkeeper as defined by the Plan, and therefore, the transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Hicks Pension Services provides third party administrative services to the Plan, and therefore, fees paid for these services (if any) qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

***Note 7. Tax Status***

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Including any applicable amendments, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan as of December 31, 2024, and is not aware of any uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***Note 8. Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.

***Note 9. Reconciliation of the Plan Financial Statements to the Form 5500***

Certain amounts included on Schedule H Part I and II on the Annual Return/Report of Employee Benefits Plan (Form 5500) have been grouped differently for purposes of presentation in the financial statements.

There were no reconciling items between the financial statements and Form 5500 as of December 31, 2024 and 2023.

***Note 10. Subsequent Events***

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.
