Management has obtained certifications from qualified institutions as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the 2024 Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the 2024 financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our 2024 audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — 2024 Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in



accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

NOTE 1 – PLAN DESCRIPTION

The following brief description of the Gear Up Sports, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Gear Up Sports, Inc. (the Company), who meet the eligibility requirements. Employees are generally eligible to participate in the Plan after completing three consecutive months of service and attaining 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Amendment - Effective January 1, 2023, the Plan was amended to update the Eligible Automatic Contribution Arrangement (EACA) to update the initial deferral rate from 1% to 2% of the compensation of newly enrolled and previously enrolled participants. Further, the amendment included an automatic increase in the deferral rate of 1% each year, up to a 5% maximum deferral rate, unless the participant elects differently. Participants can elect out of the provision or otherwise change their deferral rate.

Effective November 1, 2023, the Plan was amended and restated through the adoption of a non-standardized defined contribution pre-approved plan document sponsored by Standard Retirement Services, Inc. The new Plan document incorporated all existing amendments and regulatory updates in order to continue to qualify under Section 401(k) of the Internal Revenue Code (IRC). The amendment also increased the contribution maximum from 92% of eligible wages to 100% of eligible wages, up to the maximum amount allowed by law. This amendment and restatement was adopted as part of a transition in recordkeeper and custodian providers. As part of this transition, most of the funds in the Plan were transferred near year end, and as such were in the process of being allocated from non-interest-bearing cash to participant-directed investment options. The majority of this allocation occurred in early 2024.

Contributions - Contributions consist of pre-tax and Roth elective deferrals, employer matching contributions and discretionary nonelective contributions. Employee contributions and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Employees may voluntarily contribute up to 100% of their compensation, not to exceed the maximum annual limits of \$23,000 and \$22,500 for 2024 and 2023, respectively, as prescribed by the IRC. Participants aged 50 and older may elect to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company makes matching contributions to the Plan equal to 100% of each participant's contributions up to a maximum of 2% of the participant's eligible compensation. The Company made employer matching contributions of \$162,787 and \$149,336 in 2024 and 2023, respectively. There were no discretionary nonelective contributions made in 2024 or 2023. In addition, contributions are subject to other limits under the IRC.

Participant Accounts - A separate account is maintained for each participant, which is credited with the participant's contributions, the Company's contributions and an allocation of Plan earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions and employer matching contributions, plus actual earnings thereon. Participants are vested in employer discretionary nonelective contributions, plus actual earnings thereon at a rate of 20% after two years of service and increases by 20% annually thereafter, until 100% vested. Participants are also 100% vested upon death, total and permanent disability, or retirement.

Payment of Benefits - Upon termination of service or upon reaching retirement age, disability or death, or upon attainment of age 59½, a participant may elect to receive a lump-sum amount, installments, or partial payments. Additionally, prior to termination under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. Account balances of terminated participants that are under \$7,000 may be automatically paid out at the discretion of the Company.

Expenses - Certain administrative expenses may be paid by the Company. Expenses not paid by the Company are deducted from participants' accounts. In addition, certain expenses of Plan administration, including computer services, professional fees, office supplies, and payroll expenses of administrative and clerical personnel, are provided by the Company without charge to the Plan.

Forfeitures - Forfeitures may be used to pay Plan expenses or reduce employer discretionary nonelective contributions. There were no forfeited amounts at December 31, 2024 or 2023. Forfeitures in the amount of \$0 and \$66 were used to pay Plan expenses in 2024 and 2023, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition - Investments are reported at fair value except for benefit-responsive investment contracts, which are carried at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefit Payments - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Subsequent Events - The Plan's management has performed an evaluation of subsequent events through October 3, 2025, which is the date these financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC No. 820 are described as follows:

Basis of Fair Value Measurement

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and Money Market Mutual fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – GROUP ANNUITY CONTRACT WITH STANDARD INSURANCE COMPANY

The Plan is invested in a traditional fully benefit-responsive, group annuity contract with Standard Insurance Company (Standard), The Standard Stable Asset Fund D. Standard maintains the contributions in a general account. The group annuity contract provides for preservation of principal, maintains a stable interest rate, and provides daily liquidity at contract value for participant withdrawals and transfers in accordance with the provisions of the Plan. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There were no reserves against contract value for credit risk of a contract issuer or otherwise. The contract value of the group annuity contract at December 31, 2024 and 2023, respectively, was \$123,526 and \$1,050. The crediting interest rate is based on a formula agreed upon with the issuer. The average yield was 2.09% and 0.05% for the years ended December 31, 2024 and 2023, respectively. On a quarterly basis, Standard declares a credit rate for financial activity in the coming quarter.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) termination of the contract, (2) spin-offs, (3) divestitures, (4) layoffs, (5) corporate relocation, (6) partial or total Plan termination, (7) retirement incentive programs, and (8) the liberalization of plan withdrawal or transfer rules. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

The Plan may terminate the contract at any time with 30 days advance written notice to Standard. Standard may terminate the contract with 30 days advance written notice to the Plan for reasonable cause, which includes the Plan’s failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, Plan disqualification, and failure to adopt the Plan in a reasonable period of time. Upon termination by either party, the payout value may be subject to adjustment, either in a lump sum payment or in installment payments.

NOTE 5 – INFORMATION CERTIFIED BY THE CUSTODIANS OF THE PLAN

The following is a summary of the unaudited information regarding the Plan, included in the Plan’s financial statements and supplemental schedule, that was certified by the custodians of the Plan, Reliance Trust Company, and Standard Insurance Company, as of and for the year ended December 31, 2024, and furnished to the plan administrator. The plan administrator has obtained certifications from the custodians that such information is complete and accurate.

NOTE 6 – NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at any given time. The loans are secured by the vested balance in the participant’s account. Loan repayments are made ratably through payroll deductions over a period not to exceed five years unless the loans were used to purchase a primary residence in which case the loan terms may not extend beyond 10 years from the date of the loan origination. Interest is fixed at the time of the loan at a rate commensurate with the rate of interest charged on similar commercial loans and ranges from 8.50% to 9.50% with various maturities through June 2028 on loans outstanding at December 31, 2024.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

NOTE 8 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Standard Insurance Company. Standard Insurance Company is the current recordkeeper and custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions.

The former recordkeeper, Paychex Inc., provided certain administrative services to the Plan pursuant to an agreement between the Company and Paychex Inc. Such fees were charged by the recordkeeper and are included in administrative expenses for the year.

NOTE 9 – CONCENTRATIONS, RISKS AND UNCERTAINTIES

The Plan holds investments that are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. There were four investments that individually represented more than 10% of the investments held as of December 31, 2024 and 2023. See the supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

NOTE 10 – TAX STATUS

The Plan is an adoption of a non-standardized pre-approved profit sharing plan sponsored by Standard Retirement Services, Inc. The Plan document obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since the opinion letter was issued, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
