Opinion

We have audited the financial statements of the Lutron S.M. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Lutron S.M. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for further details of the Plan's provisions.

General: The Plan is a defined contribution plan established by Lutron S.M., Inc. (the Plan Sponsor) under the provisions of Sections 1081.01(a) and (d) of the Puerto Rico Internal Revenue Code of 2011, as amended (the PR Code), for the benefit of eligible employees. There is no minimum age or service requirement, however, employees must be full-time in order to be eligible. The Lutron S.M. Retirement Committee is responsible for oversight of the Plan. The Lutron S.M. Investment Advisory Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance inclusive of investment fees. The Lutron S.M. Investment Advisory Committee also monitors the appropriateness of all Plan administration fees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Auto-enrollment: The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their salary deferral rate set at 6% of eligible compensation and their contributions invested in an age-appropriate target date retirement trust, which serves as the Plan's Qualified Default Investment Alternative (QDIA) unless changed by the participant.

Auto-increase: The Plan also includes an auto-increase provision, whereby participants are subjected to an annual automatic deferral rate increase of 1% until their deferral rate reaches 10% of eligible compensation. Participants may elect to discontinue their participation in the auto-increase at any time.

Contributions: Participants may elect to contribute any amount of their eligible compensation on a pretax basis in 1% increments, subject to certain limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). No profit sharing contribution feature exists.

Participant accounts: Each participant's account is credited with the participant's contributions and the Plan Sponsor's matching contribution, as well as allocation of any investment earnings. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and employer matching contributions, plus actual earnings thereon.

Participant investment options: Participants must direct their salary deferral contributions and employer matching contributions to selected investments as made available by the Plan Administrator and determined by the Investment Advisory Committee of the Plan or be defaulted to the age appropriate QDIA.

Payment of benefits: Upon termination of service due to death, disability or reaching retirement age (65), a participant may receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. The Plan also provides for special distributions under certain conditions.

Forfeited accounts: Forfeitures are used to reduce future employer contributions or to pay Plan expenses. Forfeited nonvested accounts totaled \$12 and \$2,610 at December 31, 2024 and 2023, respectively. During 2024, \$2,702 of forfeited matching contributions were used to reduce employer contributions.

Notes to Financial Statements

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Contributions: Contributions from Plan participants and matching contributions from the Plan Sponsor are recorded in the year in which participant compensation is earned.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Lutron S.M. Investment Advisory Committee determines the Plan's valuation policies utilizing information provided by the investment recordkeeper. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements.

Subsequent events: The Plan has evaluated subsequent events (events occurring after December 31, 2024) through October 1, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Cash, cash equivalents and money market fund: Valued at cost that equals fair value.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3. Fair Value Measurements (Continued)

Common investment trusts: Valued based on the NAV of units of the common investment trust. The NAV is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

Note 4. Related-Party and Party-in-Interest Transactions

The Plan Sponsor pays for all administrative expenses of the Plan, including those paid to Banco Popular de Puerto Rico, the Plan's trustee and recordkeeper.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 6. Tax Status

The Plan was accepted as part of the Banco Popular de Puerto Rico Master Defined Contribution Retirement Plan (the Master Plan) effective January 1, 2005. The Plan was resubmitted for requalification under the PR Code with respect to certain qualifications amendments and, on June 12, 2020, a new determination letter was obtained from Hacienda, Puerto Rico as to its qualified status under the PR Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the PR Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
