Notes to Financial Statements

Note 1: Description of Plan

The following description of The Hiebing Group, Inc. Retirement Savings and Profit Sharing Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of The Hiebing Group, Inc. (the Employer). An employee becomes eligible to participate in the Plan after reaching the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants are allowed to make pretax, aftertax, or a combination of pretax/aftertax contributions to the Plan up to their full eligible compensation as defined by the Plan, subject to certain Internal Revenue Service (IRS) limitations. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan, including a self-directed brokerage account option. The Employer may make a discretionary matching contribution equal to a uniform percentage or dollar amount of participants' elective deferrals (not including catch-up deferrals) each Plan Year. Each year the Employer will determine the formula for the discretionary matching contribution. In addition to the discretionary matching contribution, the Employer may make a discretionary nonelective contribution to eligible participants. In 2024, the Employer made discretionary matching contributions of \$390,727 and discretionary nonelective contributions of \$454,564.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer discretionary matching contributions, as well as allocations of (a) the Employer's discretionary nonelective contribution, (b) reallocation of forfeited accounts (if any), and (c) plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are immediately and fully vested in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of service. A participant is 100% vested after five years of credited service (0% in the first year, 25% per year thereafter). Forfeitures may be allocated to eligible participants as an additional Employer nonelective contribution, used to reduce Employer contributions, or used to pay Plan expenses. The amount of unallocated forfeitures at December 31, 2024 and 2023 was \$127,033 and \$101,122, respectively. During 2024, \$101,122 of forfeitures were used to reduce Employer contributions. Full vesting also occurs upon normal retirement (as defined by the Plan), disability, and death.

Note 1: Description of Plan (Continued)

Payment of Benefits

Upon termination of service due to reasons other than death, a participant may elect either a lump-sum amount or installments equal to the value of the participant's vested interest in his or her account. Upon termination of service due to death, a beneficiary may elect to receive a lump sum payment or installment payments over a period not greater than the life expectancy of the beneficiary. In-service distributions are permitted for participants suffering from a disability or financial hardship or who have attained age 59 ½.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Expenses

Fees related to benefit payments and quarterly asset fees are charged directly to the participant's account and are included in administrative expenses. Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through October 1, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels; Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts consist of cash equivalents, mutual funds, exchange traded funds, and common stocks that are valued on observable market quotations for identical assets and are priced on a daily basis at the close of business.

Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Johnson Bank, the custodian of the Plan.

Note 5: Related-Party Transactions and Party-in-Interest Transactions

Johnson Financial Group is the recordkeeper of the Plan and serves as the investment advisor. Transactions with Johnson Financial Group qualify as party-in-interest. Fees incurred and paid by the Plan to Johnson Financial Group for certain investment management, brokerage, and administrative services were \$55,990 for the year ended December 31, 2024.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

Note 7: Tax Status

The Employer has adopted a prototype plan, which the IRS has determined to be qualified under Section 401(k) of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan is qualified and the related trust was tax-exempt at the financial statement date.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
