INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of
Motion Picture Laboratory Technicians & Film Editors
Local 780 Welfare Fund
Chicago, Illinois

Opinion

We have audited the accompanying financial statements of the Motion Picture Laboratory Technicians & Film Editors Local 780 Welfare Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

Motion Picture Laboratory Technicians & Film Editors Local 780 Welfare Fund (the Plan) was established during 1958 as the result of collective bargaining agreements to provide welfare benefits for eligible employees and their dependents. The current plan provides health care, death, disability and prescription drug benefits.

To become eligible for benefits, an employee must be employed by a contributing employer or employers, working within the jurisdiction of Local Union No. 780 collective bargaining agreement or participation agreement which requires contributions to the Plan. Retirees may elect to be insured for prescription drugs through Benistar. The Plan pays the premiums and the retirees who elect this benefit reimburse the Plan for the premium payment.

Participants should refer to the summary plan description and recent Plan amendments for more complete information.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Contributions Receivable - The Plan estimates amounts receivable from reporting employers at year-end based upon amounts collected subsequent to year-end. Employer records are subject to audit and additional revenue, if any, which may arise as a result of these audits is recognized when received. Based on a review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, management of the Plan has concluded that any expected credit losses on balances outstanding at year end will be immaterial.

Investment Valuation and Income Recognition - The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price).



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Purchases and sales of the investments are recognized on a trade-date basis. Dividend income is recognized on the ex-dividend date. Interest income is recognized on the accrual basis. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

Cash and cash equivalents held by custodians for investment purposes are reported as investments.

Property and Equipment - Property and equipment are carried at cost. Major additions are capitalized while maintenance and repairs which do not improve or extend the lives of the respective assets are expensed currently. Depreciation and amortization are computed by the straight-line method over the following estimated useful lives of the related assets.

Office furniture and equipment	7 years
Computer equipment	5 years
Computer software	5 years

Depreciation expense for the years ended December 31, 2024 and 2023 was \$11,008 and \$9,475, respectively.

Benefit Obligations - The estimated liabilities for benefit claims incurred but not yet reported were calculated based on experience prior to January 1, 2025. Actual amounts could differ from those estimates.

Payment of Benefits - Benefits are recorded when paid. Amounts due for claims that have yet to be paid by the Plan are recorded as claims payable in the accompanying statements of benefit obligations.

Use of Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Stop-Loss Agreement - The Plan has a stop-loss agreement with Allied Benefits Systems, Inc. The policy covers medical claims paid by the Plan in excess of \$150,000 and \$135,000 on each covered person for the years ended December 31, 2024 and 2023, respectively. There were no stop-loss claims for the years ended December 31, 2024 and 2023.

Administrative Expenses - The Plan's expenses are paid by the Plan as provided by the Plan document. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.



NOTE 3. PRIORITIES UPON TERMINATION

It is the intent of the Board of Trustees (the Trustees) to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will in the opinion of the Trustees bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

NOTE 4. LEASE

Effective July 2020, the Plan is the owner and landlord for an office building located at 6141 N. Courtenay Parkway, Merritt Island, Florida, 32953.

Total rent income from tenants totaled \$57,816 and \$57,816 for the years ended December 31, 2024 and 2023, respectively. The lease is currently on a month-to-month basis.

NOTE 5. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to the fiscal year ended December 31, 2021.

NOTE 6. FUNDING POLICY

The Plan is financed by employer contributions and contributions from retirees. Weekly employer contribution rates are specified in the collective bargaining agreements. All prescription drug benefits for retiree are fully insured through Bestco. The Plan collects the premium payments from each retiree and remits them to the insurance company monthly.

NOTE 7. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the quoted market prices of shares held by the Plan at year end as reported by the custodian of the Plan.

Money market funds: Money market funds are valued using amortized cost which approximates fair value.

Real estate - Florida: In July 2020, the Plan purchased a building and land located at 6141 N. Courtenay Parkway, Merritt Island, Florida, 32953. The investment in the real estate is valued at the purchase price. The cost of building improvements will be added to the purchase price until an independent appraisal is performed and the carrying value is adjusted. The total value of the building was \$1,033,106 and \$977,674 on December 31, 2024 and 2023, respectively.

The preceding methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amount reported in the statements of net assets available for benefits.

NOTE 9. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan shares office facilities and employees with the affiliated Motion Picture and Video Tape Laboratory Technicians, Allied Craft and Government Employees Local 780 (the Local) (a related party). The operating expenses of the combined facilities and salaries, benefits and payroll taxes of employees are paid initially by the Local and allocated monthly on a basis approved by the officers of the Local and the Trustees of the funds. The Plan has common trustees with some of the officers of the Local. The Plan reimbursed the Local \$179,921 and \$254,219 for the years ended December 31, 2024 and 2023, respectively.

As disclosed in Note 2, the Plan pays certain administrative, investment and professional fees to various service providers. These transactions are party in interest transactions under ERISA.

The Plan had a payable due \$40,316 and \$43,546 to the affiliated organization at December 31, 2024 and 2023, respectively.


