Management has obtained a certification from a qualified institution as of December 13, 2024, and for the period January 1, 2024 to December 13, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion on the 2024 Financial Statements***

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion on the 2024 Financial Statements***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of Burns & Levinson LLP Retirement Plan for Associates & Other Employees and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. ### ***Emphasis of Matters***

#### ***Basis of Accounting***

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America and, as a result, the financial statements may not be suitable for another purpose. Our opinion is not modified with respect to this matter.

#### ***Plan Termination and Liquidation Basis of Accounting***

As further discussed in Notes 1 and 7 to the financial statements, Plan management authorized the termination of the Plan on September 12, 2024 and distributed all of its assets to its participants on December 13, 2024. As a result, the Plan changed its basis of accounting from the ongoing plan basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the 2024 Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the 2024 Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Their report dated September 24, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with the modified cash basis of accounting, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

### **1. Description of Plan**

The following description of the Burns & Levinson LLP Retirement Plan for Associates & Other Employees (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution plan established effective January 1, 1982, as restated September 30, 2024. The Plan covers all employees, excluding leased employees, nonresident aliens, those persons covered by the Partners and Legal Administrative Assistants Plan, those who elect out of the Plan, and temporary employees, of Burns & Levinson LLP (the “Firm”) who have completed three months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Executive Committee is responsible for oversight of the Plan. The Plan’s investment committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Executive Committee.

#### ***Plan Termination***

The Plan was terminated effective September 30, 2024. Upon termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. As a result of the decision to terminate the Plan, and in accordance with the modified cash basis of accounting, the Plan’s financial statements as of December 13, 2024 and for the period January 1, 2024 to December 13, 2024, are presented using the liquidation basis of accounting. For periods prior to the decision to terminate the Plan, the financial statements were prepared using the ongoing basis of accounting.

#### ***Contributions***

Each year, participants were allowed to contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (“IRC”). Participants were also allowed to designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants were also allowed to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. Additional discretionary amounts may be

contributed by the Firm at the option of the Executive Committee. During the period January 1, 2024 to December 13, 2024, the Firm made a \$396,165 discretionary contribution to the Plan. The Plan required a participant to be employed as of year end to be eligible to receive employer contributions. Contributions were subject to certain Internal Revenue Service (“IRS”) limitations.

#### ***Participant Accounts***

Each participant’s account was credited with the participant’s contributions, allocations of the Firm’s discretionary contributions and an allocation of the Plan’s earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

#### ***Vesting***

Participants were vested immediately in their contributions and the Firm’s contributions plus actual earnings thereon. Due to the Plan's termination, participants were also vested immediately in the Firm's contributions plus actual earnings thereon.

#### ***Notes Receivable from Participants***

Participants were allowed to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans were secured by the balance in the participant’s account. The loan interest rate, determined annually, was set at the local prevailing rates, as defined. Principal and interest were paid ratably through payroll deductions. Terms ranged up to five years or greater for the purchase of a primary residence.

#### ***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant was permitted to elect to receive either a lump sum amount equal to the value of the participant’s vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant was permitted to receive the value of the vested interest in his or her account as a lump

sum distribution. If a terminated participant's vested balance was less than or equal to \$5,000, the amount was permitted to be automatically distributed to an individual retirement account. In addition, the Plan allowed for hardship distributions if certain criteria were met.

#### *Forfeited Accounts*

At December 13, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$11,289, respectively. These accounts were used to reduce employer contributions or to pay plan administrative expenses. During the period January 1, 2024 to December 13, 2024, plan administrative expenses were reduced by \$44,212 from forfeited nonvested accounts, in accordance with plan provisions.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements have been prepared using the modified cash basis of accounting which is a basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). Accordingly, additions are included in the year in which they are collected and deductions are included in the year in which they are disbursed; however, earnings on investments include adjustments to fair value. As a result of the decision to terminate the Plan, and in accordance with the modified cash basis of accounting, the Plan's financial statements as of December 13, 2024 and for the period January 1, 2024 to December 13, 2024 are presented using the liquidation basis of accounting. For periods prior to the decision to terminate the Plan, the financial statements were prepared using the ongoing basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determined the Plan's valuation policies utilizing information provided by the investment advisers and trustee, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Contributions***

Contributions from Plan participants were recorded in the year in which the employee contributions were withheld from compensation.

#### ***Notes Receivable from Participants***

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the modified cash basis. Related fees were recorded as administrative expenses and were expensed as incurred. No allowance for credit losses was recorded as of December 13 2024 and December 31, 2023.

#### ***Payment of Benefits***

Benefits were recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Firm. Expenses that were paid by the Firm are excluded from these modified cash basis financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

#### *Subsequent Events*

Subsequent events were evaluated through October 6, 2025, the date the modified cash basis financial statements were available to be issued.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

**Level 1** – Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 13, 2024 and December 31, 2023.

*Mutual funds and money market:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

*Investments measured at net asset value:* Consisting of common-collective trusts, valued at the net asset value ("NAV") of units of a bank collective trust. The NAV, as provided by the trustee, was used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient was not used when it was determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may have occurred daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserved the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations would be carried out in an orderly business manner.

*Self-directed brokerage accounts:* Self-directed brokerage accounts were valued based on the quoted prices of the underlying investments.

### **6. Related-Party and Party In Interest Transactions**

Certain Plan investments were managed by the Trustee, and therefore, these transactions qualified as party in interest transactions.

Fees incurred by the Plan for the investment management services were included in net appreciation in the fair value of the investment, as they were paid through revenue sharing, rather than a direct payment. Fidelity Management Trust Company received revenue from investment fund service providers for services Fidelity Management Trust Company provided to the funds. This revenue was used to offset certain amounts owed to Fidelity Management Trust Company for its administrative services to the Plan. If the revenue received by Fidelity Management Trust Company from such investment fund service providers exceeded the amount owed for its services, Fidelity Management Trust Company remitted the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to Fidelity Management Trust Company for administrative expenses not covered by revenue sharing.

Additionally, the Plan issued loans to participants, which were secured by the participant's account balances. These transactions qualified as party in interest transactions.

Certain administrative functions of the Plan were performed by partners or employees of the Firm. No such partner or employee received compensation from the Plan.

### **7. Plan Termination**

On September 12, 2024, the Executive Committee resolved to terminate the retirement plan effective September 30, 2024. The Executive Committee further authorized (a) stopping all 401(k) deferrals as of September 30, 2024; (b) vesting all plan participant accounts 100% as of September 30, 2024, and (c) taking such other actions as may be necessary and appropriate to terminate the plans as of September 30, 2024. All of the Participant accounts were liquidated as of December 13, 2024.

### **8. Tax Status**

The Plan adopted a pre-approved plan offered by FMR LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust was designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). Although the Plan was amended since receiving the IRS Opinion Letter, the plan administrator believed that the Plan was designed, and operated, in compliance with the applicable requirements of the IRC, and, therefore believed that the Plan was qualified, and the related trust was tax exempt.

### **9. Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
