INDEPENDENT AUDITOR'S REPORT

Plan Trustees

The First National Bank & Trust Company of Newtown Savings/Incentive Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of The First National Bank & Trust Company of Newtown Savings/Incentive Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023; the related statements of changes in net assets available for benefits for the years then ended; and the related notes to the financial statements (collectively, the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from qualified institutions as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of The First National Bank & Trust Company of Newtown Savings/Incentive Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more comprehensive description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all full-time and part-time employees of The First National Bank & Trust Company of Newtown (the “Company”). Eligible employees may participate on the first enrollment date following their date of hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The 401(k) Committee is responsible for oversight of the Plan. The 401(k) Committee also determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Each participant may make a pretax or Roth salary-reduction contribution deferring not more than 75 percent of total pretax compensation, subject to Internal Revenue Service (“IRS”) regulations.

The Company makes a safe harbor non elective contribution for each participant equal to a non-elective 3 percent of the participant’s compensation for the allocation period.

Effective January 1, 2020, the Company no longer makes an employer matching contribution.

Participant Accounts

Each participant’s account is credited with Plan earnings, the participant’s contribution, and allocation of the Company’s contribution, net of forfeitures. Allocations are based upon participant earnings or account balances, as defined. The benefit to which each participant is entitled is that which can be provided from the participant’s vested account.

Vesting

Participants are 100 percent vested in their salary-reduction contributions, employer safe harbor, and earnings therein. Vesting for the matching portion of their account made prior to January 1, 2020 is based on years of service. Participants are vested at a rate of 20 percent for each year of service from years one through five (fully vested after five years).

Payment of Benefits

The vested balance of a participant's account is paid to the participant in a lump sum upon termination of employment. If the balance exceeds \$1,000, the participant has the option to receive the distribution in a lump sum or defer payment to any date selected or to the age of 73 (70.5 if born before July 1, 1949), whichever is sooner. In the case of a participant's death, distribution will be made to the participant's designated beneficiary. The Plan has no limits to the number of hardship withdrawals requested during a plan year.

Forfeitures

Forfeitures attributable to contributions made after January 1, 2020, shall be used to reduce contributions that the Company is obligated to make under the terms of the Plan. At December 31, 2024 and 2023, unallocated forfeited accounts totaled \$0 and \$0, respectively. During 2024, unallocated forfeitures of \$0 were used to fund employer contributions to the Plan.

Reclassification of Comparative Amounts

Certain comparative amounts for the prior year have been reclassified to conform with current-year classifications. Such reclassifications had no effect on changes in net assets available for benefits or net assets available for benefits.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

In preparing the financial statements in conformity with U.S. generally accepted accounting principles, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan had no excess contributions at December 31, 2024 or 2023.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Fees relating to accounting, administrative record-keeping, and legal expenses are paid by the Company; see Note 6.

NOTE 3 - INCOME TAX STATUS

The Plan has received a determination letter from the IRS dated June 30, 2020, stating that it is qualified under Section 401(a) of the Internal Revenue Code ("Code") and, therefore, is exempt from federal income taxes under Section 501(a) of the Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator (the person or persons appointed by the named fiduciary to administer the Plan) and the Plan's tax council believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provisions for income tax have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability of the Plan had the Plan taken an uncertain position that more likely than not would not be sustained upon examination by the taxing jurisdictions. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 4 - INVESTMENTS

The following is a summary of the investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024. The Plan's financial statements and supplemental schedule was prepared by or derived from information provided by the Trust Department of The First National Bank & Trust Company of Newtown (a party in interest) (the "Trustee") and furnished to the Plan Administrator for the period January 1, 2024 to December 31, 2024. The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee for the period January 1, 2024 to December 5, 2024 and information provided to the Plan Administrator by Charles Schwab Trust Bank (the "Custodian") for the period December 5, 2024 to December 31, 2024 related to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information, that appears throughout the financial statements and supplemental schedule related to the following investments:

The Trustees also certified to the completeness and accuracy of \$6,067,041 of net appreciation in fair value of investments, and \$144,614 of interest and \$1,438,435 in dividends, related to the aforementioned investments for the year ended December 31, 2024.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100 percent vested in their accounts.

NOTE 6 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Company entered into a trust agreement with the Trustees. Under the terms of this agreement, the Trustee will hold, invest, and reinvest the Plan's funds, and; therefore, these transactions qualify as party-in-interest transactions. The Plan has no right or title to or interest in the trust fund maintained under this agreement. At December 31, 2024 and during the period from January 1, 2024 through December 31, 2024, the Trustee was also a division of the Company and, therefore, a related party.

The Company absorbs some costs incurred in relation to the administration of the Plan. Such costs include legal, record keeping, administrative, and accounting fees. The cost amounted to \$31,223 for the year ended December 31, 2024.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 8 – FAIR VALUE MEASUREMENTS

The following disclosures show the hierarchal disclosure framework associated with the level of pricing observations utilized in measuring assets and liabilities at fair value. The three broad levels defined by U.S. generally accepted accounting principles are as follows:

- Level I: Quoted prices are available in active markets for identical assets or liabilities as of the reported date.
- Level II: Pricing inputs are other than quoted prices in active markets, which are either directly or indirectly observable as of the reported date. The nature of these assets and liabilities includes items for which quoted prices are available but traded less frequently and items that are fair-valued using other financial instruments, the parameters of which can be directly observed.
- Level III: Valuations derived from valuation techniques in which one or more significant inputs or significant value drivers are unobservable.

The hierarchy requires the use of observable market data, when available.

Following is a description of the valuation methodologies used for assets measured at fair value.

The FNB money market fund, FNB equity fund, and FNB bond fund are the investment allocation options from which the participants of the Plan can select. These funds are all valued based on the market value of the underlying investments held by that particular fund, which may include a mix of cash equivalents, mutual funds, preferred or common stock, or municipal bonds, as determined necessary by the Trustee of the Plan in order to uphold the intent of that allocation option. The fair values of the underlying investments are determined quarterly by the Trustee, and any increases or decreases in the market values are then allocated to the fund holders proportionally. All of the underlying investments of the FNB money market fund and the FNB equity fund allocations are valued using Level I measurement techniques and are, therefore, classified as Level I within the fair value hierarchy. The FNB bond fund allocation has investments valued using both Level I and Level II techniques (primarily municipal bonds). Mutual funds are valued at fair value based on published market prices which represent the net asset value ("NAV") of the shares held by the Plan at year-end. The funds are actively traded and are considered level 1.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with our market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
