Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of AUI Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the AUI Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of AUI Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

NOTE 1 DESCRIPTION OF THE PLAN

AUI Inc. 401(k) Profit Sharing Plan (the Plan) is a profit sharing plan with a 401(k) feature which was originally formalized and adopted by AUI Inc. (AUI, the Company, or Employer) (the Plan administrator) effective January 1, 1993, and was restated effective January 1, 2021, on March 5, 2021. Effective January 1, 2013, the Plan was restated to merge the AUI Inc. Retirement Plan into this Plan as the surviving Plan. In accordance with the merger of the AUI Inc. Retirement Plan in 2013, the Plan now covers employees performing work under contracts subject to the Davis-Bacon Act, Service Contract Act, or any other federal, state, or municipal "Prevailing Wage Law." Employer prevailing wage contributions are accepted by the Plan.

The following description of the Plan provides only general information. Participants should refer to the Plan document for more complete information.

The Plan administrator is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

An employee becomes eligible to participate in the Plan on the earliest semi-annual entry date (if employed on that date) nine months after the date on which he/she becomes employed and attained the age of eighteen.

Participants rehired after 30 days of their termination will have the option of making salary deferrals again with their first payroll upon return. If they waive participation, they will again have the option to start contributing during the next open enrollment period following their rehire.

Participants who are performing work on "prevailing wage" or "service contract" jobs are eligible to participate in the Plan on the first day any such wages are set aside to be contributed to the Plan, but only for the purpose of the prevailing wage contributions the Company makes on the participant's behalf.

Participants are excluded if they are covered by a collective bargaining agreement, are non-resident alien employees, or leased employees.

Participant Accounts

Each participant's account is credited with one hundred percent (100%) of the participant's contribution, one hundred percent (100%) of the prevailing wage contribution and the allocation of Employer contributions and Plan earnings.

Employer contributions may consist of a matching contribution and/or a profit sharing contribution. Matching contributions are allocated to all Plan participants based on their respective deferral amounts, and profit sharing contributions are allocated to all AUI employees based on their respective eligible salaries at the determination date (see also Contributions).

Participant Accounts (Continued)

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is equal to the vested portion of the participant's account (see also Vesting, Forfeitures, and Distributions).

Contributions

For each Plan year, employee contributions may be made up to maximum limits of Section 402(g) of the Internal Revenue Code, which amounted to \$23,000 for the year ending December 31, 2024. Participants who have attained age 50 by year-end may also make an additional catch-up contribution of up to \$7,500 in 2024.

Participants may also elect to make their contributions into either a Roth 401(k) or to the traditional 401(k). Roth 401(k) contributions are made from after-tax dollars. The gains received on contributions to the Roth 401(k) are tax-free if certain conditions are met.

The Plan also allows for discretionary matching and profit sharing contributions by the Employer. Effective for the 2024 Plan year, the Employer elected to adopt certain safe harbor amendments. AUI matches 100% of employee deferrals up to 4% of eligible compensation. The profit sharing contribution is a varying percentage allocated proportionately based on eligible participants categorized into the following groups: Executive Group; Administrative / Shop Group; Superintendent / Project Manager Group; Foreman Group; and Hourly Paid Group. Effective for the 2024 Plan year, the Employer did not elect to make a profit sharing contribution.

For work performed under prevailing wage contracts, the amount contributed to the Plan by the Employer on behalf of an employee is based on the wage rate and job classification of the employee and will not exceed the amount designated by the Secretary of the Treasury pursuant to the limits under Internal Revenue Code Section 415.

Vesting

A participant is fully vested at all times in his/her salary deferral contributions, and when applicable, in safe harbor matching contributions. A participant becomes fully vested in his/her accrued benefit for profit sharing contributions as follows:

Vesting (Continued)

Employees will earn their yearly Employer profit sharing contribution vesting percentage as long as they have been credited with at least 1,000 hours of service.

Employees are 100% vested in Employer safe harbor contributions in the year they are made.

A participant's interest in the Employer's prevailing wage contribution to his/her account is always fully (100%) vested.

Forfeitures

Forfeitures of Employer contributions may be applied to reduce either future Employer matching contributions or to pay Plan expenses. No forfeitures were used to reduce Employer matching contributions during the 2024 Plan year. There were no forfeitures available for use as of December 31, 2024 and 2023.

Distributions

For terminating participants with vested balances between \$1,000 and \$5,000 who have not requested another eligible form of distribution, the Plan administrator may roll the respective balance to an individual retirement account in the name of the participant. Effective January 1, 2024, the limit for involuntary distributions increased from \$5,000 to \$7,000 in accordance with the provisions of the SECURE 2.0 Act.

Participants with vested balances of \$7,000 (in 2024) and \$5,000 (in 2023) or more upon termination will receive distribution of their accrued benefit upon submission of a claim for distribution. No distributions were requested that have not been paid at December 31, 2024 and 2023.

In-service distributions from Davis-Bacon contributions are permitted. In-service distributions are permitted from all 100% vested contribution types by participants who have attained age 59.5. Hardship distributions are permitted subject to Plan provisions.

Effective October 1, 2025, the Plan was formally amended to allow in-service distributions from 100% vested employer matching contributions and non-elective contributions upon the attainment of age 40 and upon reaching 15 years of service. Participants are allowed one in-service distribution per calendar year.

Prior to January 1, 2009, the value of prevailing wage contributions in a participant's account may be paid in one or more, or any combination of methods, such as lump sum or installments. A specific provision was made to eliminate the Qualified Joint and Survivor Annuities for prevailing wage contributions made after January 1, 2009. Normal retirement is age 65.

Plan Termination

Although it has not expressed any intent to do so, the Plan administrator has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In the event of Plan termination, participants will become 100% vested in their accounts.

Notes Receivable from Participants

Participants may borrow from their fund accounts for any purpose and may have up to two loans outstanding at a time. A minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance may be borrowed. Notes receivable terms range from 1-5 years or up to 30 years for repayment of a home loan. The notes receivable are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through weekly payroll deductions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes would materially affect the amounts reported in the statements of net assets available for benefits.

Cash

Any forfeitures available for future employer matching contributions or Plan expenses, but not yet utilized by the Plan are kept in a cash account at John Hancock. The cash account is also used for stale dated checks related to forced benefit payments.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Contributions

Contributions from participants and employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Effective December 31, 2007, the Plan entered into an investment contract with John Hancock Life Insurance Company (John Hancock). John Hancock maintains the Plan's contributions in a pooled separate account and in a guaranteed interest account. The pooled separate account did not file a Form 5500 for the direct filing entity; therefore, the underlying assets have been reported on Form 5500, Schedule H. Each participating plan owns units of participation that represent rights to separate account assets. The guaranteed interest account is presented at fair value, because it is not fully benefit responsive. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by John Hancock. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Deductions for benefit distributions are recognized when paid (see also Note 1 Distributions).

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued, to determine whether such events should be recorded or disclosed in the financial statements for the year ending December 31, 2024. Management believes no material subsequent events have arisen that would require adjustment or disclosure, except as disclosed in Note 1 Distributions.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy under FASB ASC 820, *Fair Value Measurements and Disclosures* that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Pooled separate accounts invest directly in an underlying mutual fund, though they are an independent investment entity. They are valued at the close of business each day based on the total assets in the pooled separate account divided by the number of units held in the pooled separate account. Actions taken by the underlying mutual fund or the pooled separate account such as dividends, share splits or additional fees charged by the sub-account, can result in the pooled separate account unit value differing from the share price of the underlying mutual fund.

Guaranteed interest accounts: Valued at the amounts contributed plus a composite rate of interest over a guaranteed three-year term.

NOTE 4 INFORMATION CERTIFIED BY JOHN HANCOCK

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock, as complete and accurate, except for comparing such information certified by John Hancock to information included in the Plan's financial statements and supplemental schedule:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits, as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest income on notes receivable, as shown in the statement of changes in net assets available for benefits, for the year ended December 31, 2024.
- Investment information included in Note 3 and investment information and notes receivable from participants included in the supplemental schedule.

NOTE 5 RELATED PARTY TRANSACTIONS

AUI Inc. provides certain accounting and administrative services to the Plan for which no fees are charged.

Certain Plan investments are managed by John Hancock and therefore these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 TAX STATUS

The Plan obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 NONEXEMPT TRANSACTIONS

During the year ended December 31, 2024, AUI Inc. identified that participant contributions totaling \$1,610 were not remitted to the plan within the required timeframe due to an administrative oversight in the payroll process. The delinquent contributions, along with \$11 in lost earnings, were subsequently deposited into the plan in May 2024, January 2025 and September 2025 (for the lost earnings). AUI Inc. has taken steps to ensure such delays do not recur, including implementing enhanced procedures and personnel training. The Company will continue to monitor the plan's compliance and make any additional required corrections in accordance with applicable regulations.
