Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Alto Ingredients, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of Alto Ingredients, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution benefit plan covering substantially all employees of Alto Ingredients, Inc. and Subsidiaries (the Company and Plan Administrator).

To be eligible, employees must be 18 years of age and have completed 120 days of service. Participants enter the Plan on the pay date following attainment of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Partial plan termination: In 2020, the Company idled certain ethanol production facilities and sold its interests in two of its ethanol production facilities, which resulted in a partial Plan termination. Layoffs resulting from these actions affected more than 20% of the participants. All participants affected by the partial plan termination became fully vested in their accounts. Distributions related to the partial plan termination were approximately \$42,000 in 2024 while approximately \$823,000 remains payable to affected participants as of December 31, 2024.

Contributions and investment options: Upon becoming eligible to participate, participants are automatically enrolled in the Plan to have 6% deferred from their compensation pretax and contributed to the Plan. Participants may elect to decline participation or elect higher or lower pretax contributions deferred from their compensation. These contributions are subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may elect to designate all or a portion of deferred compensation as pretax or Roth contributions. The Company provides a discretionary match. For the year ended December 31, 2024, the Company matched 100% of the first 6% of the participants' deferrals. Any further discretionary amounts to be contributed by the Company are determined annually by the Plan's Retirement Plan Committee or the Company's Board of Directors. There were no additional discretionary Company contributions for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The amounts contributed by the participants and the Company are deposited into one or more of the various investments offered by the Plan, which include a collective trust fund and various mutual funds. Participants may change their investment allocation on a daily basis.

Participant accounts: Individual accounts are maintained for each participant of the Plan. Each participant's account is credited or charged with the participant's contributions and an allocation of the Company's contributions, if any, plan investment results and expenses that are paid by the Plan. Allocations are based on the participant's eligible compensation, account balance, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants vest immediately in their contributions including investment earnings or losses. Vesting in the Company's discretionary matching contributions and additional discretionary contributions, if any, including investment earnings or losses, is based on years of completed service. A participant will vest 50% after one year, 75% after two years and is 100% vested after three years of service. An employee's account will become wholly vested upon plan termination, attainment of the normal retirement age, total and permanent disability or death.

Note 1. Description of the Plan (Continued)

Payment of benefits: Upon termination of service, death, total and permanent disability, retirement, hardship (as defined in the Plan) or reaching age 59½, participants may elect to receive either a lump-sum amount equal to the value of his or her account or installment payments. Distribution of benefits upon termination becomes automatic if the participant's account balance is less than \$5,000. Participants with an account balance less than \$5,000, but greater than \$1,000, may have their account balance rolled over to an individual retirement account unless they elect to receive a lump-sum payment. Participants with an account balance less than \$1,000 will receive a lump-sum payment.

Forfeitures: Forfeitures are used to pay plan administrative expenses or offset employer discretionary matching contributions. During the year ended December 31, 2024, \$38,582 was used from the forfeitures account to pay administrative expenses and \$208,815 was used to offset employer discretionary match contributions. Forfeited nonvested accounts totaled \$28 and \$0 at December 31, 2024 and 2023, respectively.

Notes receivable from participants: Participants are eligible for up to two notes in a 12-month period, and may have two notes outstanding at a time. The minimum amount of any note is \$1,000. The maximum combined note amount is the lesser of \$50,000 or one-half of the participant's vested balance. Notes bear a reasonable interest rate based on prevailing rates and must be repaid within five years, unless the proceeds from the note are used by the participant for the purchase of a principal residence, in which case the maximum is 25 years. Principal and interest are paid ratably through payroll deductions. The existing notes are due at varying times through February 2037. The rate of interest on existing notes at December 31, 2024, ranges from 4.25% to 9.50%.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies, utilizing information provided by the Plan's investment advisors and trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses related to sales of investments are recorded on a trade-date basis, and unrealized gains and losses are recorded based on the fair value as of the end of the reporting period.

Contributions: Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payments of benefits: Benefits are recorded when paid.

Note 2. Summary of Significant Accounting Policies (Continued)

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Notes receivable have been classified as an investment asset for Form 5500 reporting purposes and accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Administrative expenses: Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities have occurred since December 31, 2024, or will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by the Plan Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information provided by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company), the trustee of the Plan. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

Accounting standards establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Shares of mutual funds are valued at the quoted market price of shares held by the Plan as of year-end.

Collective trust fund: The fund is a stable value fund, and is valued at the net asset value (NAV) as reported by the trustee, based on audited financial statements of the fund at year-end. The NAV is used as a practical expedient to estimate fair value.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 6. Tax Status

The Plan adopted a Principal Life Insurance Company pre-approved plan effective March, 15, 2022. The pre-approved plan's latest Internal Revenue Service (IRS) determination letter, dated June 30, 2020, stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. The pre-approved plan opinion letter has been relied upon by the Plan. The Plan Administrator believes that the Plan is currently being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon IRS determination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party and Party-in-Interest Transactions

Certain plan investments are shares of mutual funds and a collective trust fund managed by affiliates of Principal Trust Company, the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.
