Independent Auditor's Report

To the Board of Trustees of

Section 401 (K) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of International Alliance of Theatrical Stage Employees Local #11 Section 401 (K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Operations

The International Alliance of Theatrical Stage Employees Local #11 Section 401 (K) Plan (the Plan) is a multi-employer defined contribution plan established by collective bargaining agreements between I.A.T.S.E Local #11 and various employers. It covers substantially all members of the participating unions and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Basis of Accounting

The financial statements reflect the accrual basis of accounting in which revenue is recognized when earned or otherwise available, and expenses are recognized when incurred.

Contributions Receivable

Contributions receivable are valued at cost and are accrued based upon reports received subsequent to the year end, which include contributions due in the current year. Contributions receivable are considered fully collectible at year end, and no allowance for uncollectible accounts has been recorded.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the statements of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 PLAN DESCRIPTION

The following brief description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Funding Policy

Each year participants may, pursuant to wage reduction agreements with the employers, make contributions not to exceed amounts as specified under the Plan. Participant contributions are not to exceed 80% of compensation, as defined, and not to exceed \$23,000 and \$22,500 for the years ending December 31, 2024 and 2023, respectively, in accordance with Internal Revenue Code section 402(g). If a participant is over the age of 50, they are allowed to make up to \$7,500 in additional catch-up contributions. In addition, the employers will make contributions for each participant as set forth in the collective bargaining agreements. Currently, the employer contribution percentages range from 1.00% to 6.00% in accordance with the collective bargaining agreements.

NOTE 2 PLAN DESCRIPTION (Continued)

Vesting

Participants are immediately vested in both their contributions and the employer contributions.

Participant Accounts

Each participant account is credited with: 1) contributions made on their behalf pursuant to voluntary wage reduction agreements; 2) amounts which are required to be paid by the employers pursuant to collective bargaining agreements; 3) rollover contributions from other qualified plans or individual retirement accounts; and 4) plan earnings, net of administrative charges which include fees and expenses.

Benefits

On termination of service due to death, retirement, permanent disability, or withdrawal from the trade, a participant shall be entitled to receive the value of his or her account in the form of an annuity or a single lump sum payment under the provisions of the Plan. In-service distributions are also allowed for hardship withdrawals.

Effective April 1, 2018 the plan was amended to allow for in-service withdrawals so that active participants who have reached the age of 59 ½ may withdraw up to an aggregated total of \$50,000 until they reach age 65, at which point there is no limit placed on in-service withdrawals.

Priorities on Termination of the Plan

Although the continuation of the Plan is contingent upon the continued existence of the collective bargaining agreements, the Trustees of the Plan intend to continue the Plan indefinitely for the benefit of the participants but they reserve the right to terminate the Plan at any time. A temporary period between collective bargaining agreements shall not cause a termination or partial termination of the Plan.

Forfeitures

If a participant account, after deducting administrative expenses, has never exceeded \$100 and a distribution request was not made within 24 months of the last payment of contributions, the account will be forfeited and used to pay administrative expenses. Forfeitures available to offset future administrative expenses totaled \$462 and \$445 at December 31, 2024 and 2023, respectively. There were no forfeitures used by the Plan during 2024 and 2023.

NOTE 3 FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board authoritative guidance on fair value measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 3 FAIR VALUE MEASUREMENTS (Continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Invested Cash: Valued at cost which approximates fair value.

All assets have been valued using a market approach.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has an investment option, the SAGIC Diversified Bond Fund, with a general investment account guarantee that provides a stated rate of return and insulates participants' accounts from daily fluctuations in the market. This is considered to be a fully benefit-responsive contract. The account is credited with earnings at guaranteed crediting rates and charged for participant withdrawals and administrative expenses. The investment contract is included in the statements of net assets available for benefits at contract value, as reported to the Plan by the custodian.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events may limit the ability of the Plan to transact at contract value such as complete or partial termination of the Plan.

The average yield earned by the plan and average interest rate credited to the participants was 3.75% and 4.35% for the years ended December 31, 2024 and 2023, respectively.

The Plan obtained its latest determination letter on March 23, 2016, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

NOTE 8 PARTY IN INTEREST

A party-in-interest is defined under the Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan or an employer whose employees are covered by the Plan. The Plan pays expenses related to Plan operations and investment activity to various service providers. Therefore, payments to such service providers by the Plan qualify as party-in-interest transactions.

Certain Plan investments are mutual funds managed by Massachusetts Mutual Life Insurance Company. Massachusetts Mutual Life Insurance Company is now owned by Empower who serves as recordkeeper for the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Investments in these mutual funds represented approximately 30% and 27% of the Plan’s net assets available for benefits at December 31, 2024 and 2023, respectively.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan (through participant-directed accounts) may invest in various types of investment securities. Investment securities are exposed to various market risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 10 SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 30, 2025, the date on which the financial statements were available to be issued.
