The 2024 Form 5500 is being filed as a final return for NG DB Master Trust Equity Fund (PN:001) (the "Fund"), a Direct Filing Entity (DFE) under the Master Trust Investment Account (MTIA) structure, for the short final DFE year ended July 31, 2024 because all of its assets were transferred out in-kind to the NG DB Master Trust Global Equity Fund (PN: 016) on July 31, 2024. The Form 5500 return for the Fund is being submitted on October 7, 2025, contemporaneously with the Form 5500 returns for the applicable plans.

We respectfully request abatement of any late filing penalties due to reasonable cause. The delay in filing was unintentional and not due to willful neglect. It resulted from the following circumstance:

- **Delayed Availability of Broker Statements:** The fund has historically had a calendar DFE year. Broker statements reflecting transactions from January 1, 2024, through the date of the in-kind asset transfer out on July 31, 2024, were not made available to the Northrop Grumman Corporation (NGC) until August 2025. Additionally, our external auditors had not completed their audit procedures around the testing of plan assets until September, including the Fund, which prevented us from completing the reconciliations necessary for preparing the Form 5500s. This significantly impacted NGC's ability to prepare and file the return in a timely manner.

Upon receiving the necessary documentation to finalize our reconciliations, NGC acted promptly to prepare and submit the final return. All assets of NG DB Master Trust Equity Fund (PN: 001) were transferred out in-kind to NG DB Master Trust Global Equity Fund (PN: 016) during the short final DFE year, and this return is final. Accordingly, no Statement of Assets Held for Investment or Statement of Reportable Transactions is included.

Northrop Grumman Corporation's six defined benefit plans that held this master trust investment fund as a plan investment will be filing their respective 2024 Form 5500 returns timely, so this delay has no implications for their Form 5500 compliance. Northrop Grumman Corporation has a strong history of compliance with Form 5500 filing requirements and has implemented additional procedures to ensure future filings are made in accordance with applicable deadlines.

We appreciate your consideration of this request and respectfully ask that any penalties be waived.
