INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
the Community Auto Group 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Community Auto Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Community Auto Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Notes 5, 9, and 10 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Community Auto Group 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Community Auto Group 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. DESCRIPTION OF THE PLAN

The following description of the Community Auto Group 401(K) Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General – The Community Auto Group 401(K) Plan (the "Plan") is a defined contribution plan which includes all employees of Community Auto Group (the "Company"). The Plan is intended to comply with the Internal Revenue Code and the regulations hereunder, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The financial statements of the Plan are presented on the accrual basis of accounting.

Contributions – An employee who has attained the age of 18 and completed six (6) months of service becomes eligible to participate in the plan. Voluntary pre-tax elective deferral contributions are withheld for each pay period. However, the total of the participant's contributions may not exceed \$23,000, which is the dollar limit set by law for 2024. If the participant is 50 years or older, they may elect to contribute additional amounts, called catch-up contributions, to the plan. The maximum catch-up contribution that a participant can contribute is \$7,500 for the year ended December 31, 2024.

The Company may contribute a discretionary matching contribution each year to all eligible employees equal to a uniform percentage or dollar amount of the employee's elective deferrals each pay period. During the plan years ended December 31, 2024 and 2023, the Company contributed matching employer contributions of \$143,522 and \$135,260, respectively.

Eligible employees are also permitted to deposit into the plan distributions received from other plans and certain IRA's. These rollover contributions will enter the plan 100% vested and be affected by any investment gains or losses.

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) plan earnings, and (c) forfeitures of terminated participants' non-vested accounts. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately 100% vested in their elective deferral contributions and any rollover contributions imported to the Plan. In the event of employer contributions, vesting of participants' accounts is based on years of continuous service. A participant is 100 percent vested in employer contributions after six years of credited service. The following table represents the vesting schedule for the Plan.

Investment Options – The plan offers several investment options and participants instruct the trustees how they would like to invest funds in their individual accounts which may include rollover, employer matching, and voluntary deferral amounts. The plan administrator may establish rules for investment of participants' accounts. Participants may direct the investment of their account balance. Participants have the right to change their investment elections at any time and as often as they like. The trustee cannot be held liable for any losses participants incur due to the investment choices they make.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested balance in his or her account or annual installments over a period of time. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited Accounts – As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$28,722 and \$32,763, respectively.

Notes Receivable from Participants – Each participant may borrow from his or her fund account a minimum of \$1,000 up to a maximum of the lesser of one-half of his or her vested account balance or \$50,000 reduced by the highest outstanding loan balance in his or her account during the prior twelve-month period. The notes receivable is secured by the balance in the participant's account and bears interest at rates commensurate with prevailing rates as determined by the plan administrator. Interest rates on notes receivable from participants at December 31, 2024 were 4.75% to 8.50%. All notes must be repaid within a specific period, not to exceed five years, except those that are used for the purchase of a principal residence in which case the note can be extended for up to 30 years. In most cases, repayment of the note will be made through after-tax payroll deductions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the plan are prepared using the accrual method of accounting.

Subsequent Events – Subsequent events were evaluated through October 7, 2025, which is the date the financial statements were available to be issued. The plan is not aware of any subsequent events which require recognition or disclosure in the financial statements.

Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Income – Plan income consists of dividends, interest, realized and unrealized gains and losses, employee contributions and Company distributions. Plan earnings are allocated to participants' accounts based on a ratio derived by dividing each participant's compensation by the total compensation of all participants.

Expenses – Administrative expenses consist of legal, fiduciary, and accounting fees.

Excess Contributions – Amounts payable to participants as of December 31, 2024 and 2023 for excess contributions totaled \$65,158 and \$0, respectively.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

4. TAX STATUS

The plan has adopted the Fidelity Basic Plan Document No. 17. No provision for income taxes has been included in the plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan files an annual return and records must be retained for at least six years to support the filing.

6. ADMINISTRATION COSTS

Expenses of administration may be paid out of the plan unless paid by the Company or others. The plan may reimburse the Company for any administrative expenses incurred. Administrative fees incurred by the plan for the year ended December 31, 2024 included administrative fees, distribution fees, and investment costs.

7. RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

The plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. This hierarchy consists of three broad levels: a) Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, b) Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and c) Level 3 inputs are unobservable and have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No plan assets required Level 3 inputs for the periods presented.
