Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the CARE Hawaii, Inc. 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of Plan

The following description of the CARE Hawaii, Inc. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan effective January 1, 2000, and subsequently amended and restated by CARE Hawaii, Inc. (the Company), to provide benefits to eligible employees as defined in the plan document. Employees are eligible to participate in the Plan once they have completed at least 1,000 hours of service during 12 consecutive months of service and are age 21 or older. Effective January 1, 2024, the Plan was amended to lower the hours of service requirement for eligibility purposes from 1,000 hours to 500 hours of service. The Plan is subject to the provisions of the Internal Revenue Code (IRC) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration of Plan Assets

The Company has appointed Pension Services Corporation (Pension Services) to act as a third-party plan administrator to manage the operations and perform administrative functions pursuant to an Administrative Services Agreement between the Company and Pension Services. Empower Trust Company, LLC (Empower) serves as the Plan's custodian. Self-directed brokerage account assets are held in the custody of Morgan Stanley.

Contributions

Eligible employees of the Company are entitled to make salary deferrals to the Plan up to the lesser of 100% of the participant's eligible compensation or the maximum amount allowed by the IRC. Participants may also contribute amounts representing rollover distributions from other qualified plans or individual retirement accounts. Additionally, participants who attain age 50 before the end of the plan year may elect to make additional catch-up contributions to the Plan, not to exceed the amount allowable under current income tax regulations, which was \$7,500 for the plan year ended December 31, 2024. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company, in its sole discretion, may make matching contributions to the Plan equal to a percentage of the elective deferrals made by eligible participants during that plan year, up to an annual limit per eligible participant.

The Company may also elect to make discretionary profit sharing contributions, qualified matching employer contributions, or qualified profit sharing contributions as defined in the plan document. Participants must be employed on the last day of the plan year to be eligible for matching contributions or profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, if any, as well as allocations of the profit sharing contributions and plan earnings or losses. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms cannot exceed five years, unless the loan is used to acquire a principal residence. The loans are secured by the participants' vested interest in plan assets and bear interest at a rate commensurate with prevailing rates for loans under similar circumstances at the date of the loan. Current interest rates range from 5.00% to 9.50%. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are vested immediately in their contributions plus actual earnings or losses thereon. Vesting in the Company's discretionary contributions plus earnings or losses thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. While still employed at the Company, a participant will automatically become 100% vested upon reaching normal retirement age under the Plan or in the event of a participant's death or permanent disability.

Payment of Benefits

Distributions may be made upon attainment of 59 ½ years, hardship, disability, severance of employment, or death. The participant (or, in the event of the participant's death, the participant's beneficiary) is entitled to receive the vested amounts credited to the participant's account in either a lump-sum distribution, in periodic installments over a fixed period, or a rollover to an IRA or another qualified retirement plan.

Forfeited Accounts

Forfeitures are retained in the Plan and may be used to restore forfeiture accounts, to reduce the amount of the Company contributions to the Plan, or to pay for plan administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts amounted to \$8,006 and \$6,714, respectively. For the year ended December 31, 2024, \$8,006 of forfeitures will be used to pay administrative expenses. No forfeitures were used to reduce company contributions.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees related to notes receivable from participants and distributions are charged directly to the respective participant's account and are included in administrative expenses. Participants are allocated a portion of participant fees as stated in the fee agreements. Fees paid by the Plan for investment management services are netted against investment income in the accompanying statement of changes in net assets available for benefits. Administrative expenses recorded in the Plan during the year ended December 31, 2024 totaled \$9,089.

(2) **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments of the Plan are invested based upon instructions received from participants. The Plan's investments are stated at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, the plan custodian, and third party administrators. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Realized and unrealized appreciation (depreciation) in the fair value of investments is based on the difference between the fair value of assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributed on the basis of the terms of the plan agreement.

Excess Contributions Payable

Excess contributions payable to participants amounted to \$22,028 and \$11,665 at December 31, 2024 and 2023, respectively. This amount represents contributions in excess of amounts allowed by the Internal Revenue Service (IRS) and are recorded as a liability with the corresponding reduction to contributions. The Plan distributed the excess participant contributions to the applicable participants in the subsequent year.

Payment of Benefits

Benefits are recorded when paid.

(3) Information Certified by the Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower has certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024:

- All investments and notes receivable from participants contained in the statements of net assets available for benefits, except for the self-directed brokerage account held by Morgan Stanley totaling \$38,137 at December 31, 2023.
- All investment-related information (e.g. investment income) and interest income on notes receivable from participants contained in the statement of changes in net assets available for benefits, except for the net increase of investments held by Morgan Stanley for the year ended December 31, 2024 of \$2.
- All information presented in the supplemental schedule of assets (held at end of year).

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

(4) Fair Value Measurements

The accounting guidance for fair value measurements establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account: Account primarily consists of interest-bearing cash that is valued at carrying amount which is equivalent to fair value due to the short-term nature.

The preceding measurements described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Fully Benefit-Responsive Investment Contract

The Plan holds an investment in the Invesco Stable Value Trust – Class V (the Trust). The Trust may invest in bank, insurance company, and other financial institution investment contracts. The Trust holds synthetic guaranteed investment contracts which include portfolios of securities (debt securities or units of collective trusts), owned by the Trust with wrap contracts associated with the portfolios.

The Trust is fully benefit-responsive and thus held at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2024 and 2023 was \$477,719 and \$414,949, respectively. The interest rates in wrapper contracts are reset monthly or quarterly based on the terms of the contract.

Certain events limit the ability of the Trust to transact with participants. These events include plant closings, layoffs, plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of a trust or other events. The occurrence of one or more employer initiated events, if material, could limit the Trust's ability to transact at contract value with participants. As of December 31, 2024 and 2023, the plan administrator believes the occurrence of an event that would limit the ability of the Trust to transact with the participants in the Trust is not probable.

(6) Risks and Uncertainties

The Plan invests in various types of investment securities. Investments in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(7) Tax Status

The Plan is based on the non-standardized pre-approved profit sharing plan with CODA sponsored by Cades Schutte A LLLP LLP (Cades Schutte). The IRS informed Cades Schutte by a letter dated June 30, 2020, that the non-standardized pre-approved profit sharing plan upon which the Plan is based is designed in accordance with the provisions of the IRC. The Plan has not yet applied for its own determination letter; however, in the opinion of the plan administrator, the Plan is currently being operated in compliance with the applicable requirements of the IRC and thus qualifies the Plan for tax exempt status.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions, if any, at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.

(9) Late Remittances

During the years ended December 31, 2023, 2022, and 2021, the Company failed to remit employee deferrals and loan payments to the Plan amounting \$53,864, \$31,706, and \$23,221, respectively, on a timely basis, according to DOL regulations. All of the late deferrals and loan repayments have been remitted to the Plan. The Company calculated lost earnings amounting to \$132, \$828, and \$1,942 on the 2021, 2022, and 2023 late deferrals and loan repayments, respectively, and remitted them to the Plan in 2024.

(10) Related Party Transactions

Notes receivable from participants are considered party-in-interest transactions. Certain plan investments represent interest-bearing cash managed by Morgan Stanley. Morgan Stanley is one of the custodians as defined by the Plan and therefore, these transactions qualify as related party transactions. Administrative fees paid to Morgan Stanley were \$120 for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.
