We have performed audits of the accompanying financial statements of Today's HR 401(k) Plan, formerly CPE HR Corporate 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Today's HR 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTES TO FINANCIAL STATEMENTS**

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Today's HR 401(k) Plan (the Plan), formerly CPE HR Corporate 401(k) Plan, provides only general information. Participants should refer to the Plan's adoption agreement (the Adoption Agreement) for more complete information on the Plan's provisions.

**General**

The Plan is a defined contribution plan established effective January 1, 2008. The Plan covered substantially all corporate employees of CPE HR, Inc. Effective January 1, 2016, CPE HR, Inc. was restructured, and all corporate employees became employees of Today's HR, Inc. Consequently, the Plan was amended and restated effective January 1, 2016 to cover substantially all employees of Today's HR, Inc. (the Company), with the Company becoming the new Plan sponsor. Effective April 5, 2022, the Plan's employer status was changed from Single Employer to Controlled Group by adding Modern HiRes, Inc., a related party through common ownership, as a participating employer.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the Internal Revenue Code (IRC), and has been amended at various dates through December 31, 2024 to comply with applicable laws and regulations.

**Plan Administration**

The Company is the plan administrator and is responsible for managing the day-to-day operations of the Plan. Transamerica Life Insurance Company (Transamerica) is the custodian responsible for custody and management of the Transamerica Stable Value Fund (Stable Value Fund). Reliance Trust Company (Reliance Trust) is the custodian responsible for custody and management of the Plan's all other assets. Transamerica is also the recordkeeper of the Plan and is responsible for administering all investment transactions directed by the Plan participants.

**Contributions**

Employees who are at least 18 years old are eligible to participate. All eligible employees are automatically enrolled to defer 3% of their eligible compensation as pre- and/or post-tax contributions. Employees may elect not to defer or choose a different percentage of deferral, subject to the IRC limitations, by submitting a new enrollment form. Plan participants over age 50 may defer catch-up contributions, subject to the IRC limitations. Participants may also contribute rollovers representing distributions from other qualified plans into the Plan.

**Contributions – Continued**

As defined in the Plan, the Company makes safe harbor match of the participant's pre-tax and/or Roth elective contributions, dollar for dollar, up to 3% of eligible compensation, and 50 cents for each additional dollar between 3% and 5% of eligible compensation. Total matching contributions amounted to \$553,883 for the year ended December 31, 2024.

The Company also may elect to make other matching and profit-sharing contributions to the Plan. During the year ended December 31, 2024, the Company did not make other matching and profit sharing contributions to the Plan.

Participants direct the investment of their contributions and their share of the Company's contributions into various investment options offered by the Plan, which consist primarily of mutual funds and a stable value fund.

**Vesting**

Participants are 100% vested in their salary deferral contributions and in the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's other matching and profit sharing contributions and earnings thereon is based on years of continuous service as follows:

**Participant Accounts**

Separate accounts are maintained for each participant, which are adjusted to reflect the participant's and Company's contributions, as well as the participant's share of the Plan's income and any related administrative expenses.

**Notes Receivable from Participants**

Participants are permitted to borrow from their fund accounts as defined by the Adoption Agreement, subject to certain limitations. All notes receivable are adequately secured by the participant's account balance, bear interest as defined by the Adoption Agreement, and generally repaid on an installment basis through payroll deductions over a period not to exceed five years, except when borrowed funds are used to acquire a principal residence.

NOTE 1 - DESCRIPTION OF PLAN – CONTINUED

Payment of Benefits

Upon termination of service due to death, disability or retirement, the participant or beneficiary will receive a lump-sum payment. The Plan's normal retirement age is defined by the Plan document.

If the vested account balance of a terminated participant is \$5,000 or less, the entire balance will be paid out. For mandatory distributions in excess of \$1,000, the participant may elect to either directly transfer the vested account balance to an Individual Retirement Account (IRA) or another qualified plan or receive the vested benefits in a lump-sum payment. If no election is made, vested benefits are transferred to a separate IRA established by the Plan.

Forfeitures

Forfeitures of the unvested balance of terminated participants' accounts are used to reduce the Company's future contributions. During the year ended December 31, 2024, forfeitures amounting to \$1,064 were used to reduce the Company's contributions. At December 31, 2024 and 2023, the balance of available forfeiture was \$261 and \$1,118, respectively.

Administrative Expenses

All reasonable expenses related to Plan administration are paid from Plan assets, except to the extent expenses are paid by the Company.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements, and the reported amounts of additions and deductions during the reporting period. The most important of these estimates and assumptions relate to fair value measurements of the Plan's investments. These and other estimates and assumptions are based on the best available information but actual results could be materially different from those estimates.

Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Valuation of Investments

Plan assets invested in mutual funds are stated at aggregate fair value based upon quoted market prices.

The Plan's investment in stable value fund, which is considered to be fully benefit-responsive, is required to be reported at contract value because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less plan withdrawals and administrative expenses.

Stable Value Fund

The Plan has entered into a traditional group annuity contract with Transamerica through the Stable Value Fund. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their account balances at contract value. Thus, the investment contract is considered fully benefit-responsive, as defined by GAAP.

Transamerica maintains the contributions and invests them in Transamerica's general account. This investment seeks to protect against any loss of principal while providing returns in excess of money market funds and one-year U.S. Treasury bills. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis, and with no set maturity. The effective credited interest rate is set monthly and effective on the first day of the month. Contract charges may reduce this return. There are no reserves against contract value for credit risk of Transamerica or otherwise.

**Stable Value Fund – Continued**

Certain events limit the ability of the Plan to transact at contract value with Transamerica. Such events include the following: (1) the Plan is changed so as to significantly affect Transamerica's obligations to the contract, (2) the contract can no longer be treated as a pension plan contract, (3) the Plan is terminated, (4) failure to comply with the contract requirements, (5) failure to provide information, (6) the sum of the contract account values at any time equals \$20,000 or less, and (7) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events, which would limit the Plan's ability to transact at contract value with participants, are probable of occurring.

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned.

**Recognition of Income**

Sales and purchases are accounted for on a trade date basis, and interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Net Change in Fair Value of Investments**

Net change in fair value of investments includes realized and unrealized gains and losses on investments sold or held during the year.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Recent Accounting Pronouncements**

In the normal course of business, the Plan evaluates all new accounting pronouncements to determine the potential impact they may have on its financial statements. Based upon this review, the Plan does not expect any of the recently issued accounting pronouncements, which have not already been adopted by the Plan, to have a material impact on its financial statements.

Subsequent Events

The Plan evaluated for recognition or disclosure in these financial statements the subsequent events through report issuance date, and determined that no such events were identified.

**NOTE 3 - INCOME TAX STATUS**

The Company has adopted a volume submitter plan with cash or deferral arrangement that received a favorable opinion letter from the Internal Revenue Service (IRS), stating that the form of the underlying volume submitter document is qualified under Section 401 of the IRC, and that any employer adopting this form of the plan will be considered to have a plan qualified under Section 401(a) of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator believes that the Plan operates in accordance with applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

In accordance with GAAP, Plan management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken. As a result, the Plan has recognized no interest or penalties related to uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan document to amend or terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested for any portion of their accounts not fully vested previously.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

Fair value is defined as the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date (an exit price). The fair value hierarchy prioritized the inputs to valuation techniques used to measure fair value into three levels, with the highest priority given to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority given to unobservable inputs (Level 3). The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.
