Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of DTN 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate. Management has also obtained a certification from Fidelity Management Trust Company (Fidelity) as of December 31, 2024 and for the period from July 1, 2024 through December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all

material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by Principal and Fidelity agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. NOTE A – DESCRIPTION OF PLAN

The following description of the DTN 401(k) Plan (hereinafter referred to as the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established June 1, 2017 and is a defined contribution plan covering all employees (exclusive of non-resident aliens with no U.S. Income) of DTN US Holdings, LLC (the Employer, Plan Administrator, or Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is intended to qualify under the applicable sections of the Internal Revenue Code of 1986, as amended. Effective July 1, 2024, the Plan transitioned to a new custodian and record keeper, Fidelity. There were no significant changes in the Plan upon the transition.

Contributions

Each year, participants may elect to contribute a portion of their eligible compensation to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan including funds available through a self-directed brokerage account. Participant elective deferral contributions will be pre-tax elective deferral contributions unless all or a portion is designated as Roth elective deferral contributions. Participants age 50 and older by the end of the calendar year may contribute catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan is a 401(k) Safe Harbor Plan and the Employer contributes a qualified matching contribution of 100% of elective deferral contributions up to 6% of eligible compensation. Effective September 15, 2017, the Plan was amended to also allow discretionary Employer contributions.

The Plan features an automatic contribution arrangement (ACA), whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested as determined by the Plan Administrator until changed by the participants.

Participants' Accounts

Each participant's account is credited with the participant's contributions, with the participant's share of earnings and appreciation in the value of investments, and with the allocations of the Company's contributions. Each participant's account is charged with any withdrawals or distributions made to the participant and allocations of investment losses and depreciation in the value of investments and administrative fees and expenses paid out of the Plan. Allocations are based on participant earnings and account balances. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

NOTE A – DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. A participant has 100% vested interest at all times in Employer qualified matching contributions and discretionary contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Only two loans may be granted during any one-year period and only two loans may be outstanding at a time. The loans are secured by the vested balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. The interest rates for notes receivable for the year ended December 31, 2024 ranged from 4.75% to 10.50%. Principal and interest are repaid through payroll deductions, if available.

Payment of Benefits

Upon retirement, termination of service, or death, a participant (or his or her beneficiary) may elect to receive the vested portion of his or her account. At age 59 ½ or with evidence of financial hardship, a participant may elect to receive a distribution from their account. Hardship withdrawals are limited to the amount of the participant's elective deferral contributions. A participant can also withdraw any part of their vested account resulting from rollover contributions at any time.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the reported additions to and reductions from net assets. Actual results could vary from estimates used.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative fees and expenses of operating and maintaining the Plan may be paid out of the Plan's assets unless paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements.

Income Taxes

Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

Subsequent Events

The Plan Administrator has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

NOTE D – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

Mutual Funds: Valued at the daily closing price as reported by the fund on the active market.

Common Collective Trust Funds: Primarily valued at net asset value (NAV) of the underlying assets. Although the NAV is not publicly quoted, it is available to current investors through certain means and is the basis for current transactions, thus consistent with having a readily determinable fair value.

Self-Directed Brokerage: All of the holdings are publicly traded securities for which holding detail and pricing are publicly available. They are valued at the daily closing price as reported by the fund on the active market.

NOTE E – TAX STATUS

Effective July 1, 2024, the Plan adopted a pre-approved plan document sponsored by Fidelity. The pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 as to the pre-approved plan's qualified status. Prior to July 1, 2024, the Plan had adopted a pre-approved plan document sponsored by Principal. The pre-approved plan had received an opinion letter from the IRS dated June 30, 2020 as to the pre-approved plan's qualified status. The pre-approved plan opinion letters have been relied upon by this Plan. The Plan Administrator believes the Plan is designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for periods prior to December 31, 2021.

NOTE F – PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H – RELATED PARTY TRANSACTIONS

Certain plan assets can be held in investment options managed by Principal, prior trustee, and Fidelity, current trustee, and fees are paid to Principal and Fidelity directly for Plan Administration. Principal and Fidelity are trustees as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

NOTE I – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

There are various reclassification differences between the Form 5500 and the accompanying financial statements due to differences in reporting between the Form 5500 and accounting principles generally accepted in the United States of America (U.S. GAAP).

NOTE J – PROHIBITED TRANSACTIONS

As of December 31, 2024, the Plan Sponsor has inadvertently failed to deposit approximately \$15,463 of participant contributions within the required timeframe as stated by the United States Department of Labor regulations. The Plan will deposit associated earnings on the delinquent contributions in 2025. The correction will be made from the Plan Sponsor's assets and not from assets of the Plan.
