**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Hadley Products Employees' 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan, restated effective January 1, 2022, covers participants from the following entities (collectively referred to as the Company):

1. Hadley Products Corporation
2. Corvac Composites, LLC – non-union employees

The Plan is a defined contribution and profit-sharing plan subject to the Internal Revenue Code (IRC) Section 401(k) and the Employee Retirement Income Security Act of 1974 (ERISA) provisions. Effective January 1, 2022, the Plan was restated to comply with legislative and regulatory changes.

**Eligibility**

Company hourly and salary employees are eligible for participation in the Plan upon completion of one hour of service. The entry date for employees is the first administratively feasible payroll date after the employee has completed the service requirement.

**Contributions**

Plan participants may contribute a portion of their eligible compensation, up to the maximum allowed under the IRC. The Company may elect to treat the Plan as a “safe harbor” 401(k) plan and, accordingly, the accounts of eligible participants would be credited with a Company employer contribution equal to the safe harbor contribution of 100% of participant contributions up to 3% of eligible compensation plus 50% of participant contributions up to the next 2% of eligible compensation, as defined in the Plan agreement, for the Plan year. The Company may also make discretionary employer matching and/or profit-sharing contributions to the Plan as determined by its Board of Directors. In 2024, the Company elected to make safe-harbor contributions in accordance with the Plan provisions of \$488,076.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions, and investment earnings, and is charged with his or her withdrawals and any direct administrative expenses. Employer contributions are allocated either based on employee deferral contributions or eligible compensation, as defined by the Plan. Allocations of Plan earnings or losses are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

**Retirement, Death and Disability**

A participant (beneficiary) is entitled to 100% of his or her account balance upon reaching normal retirement age, death or total disability.

**Vesting**

Participants are immediately vested in their voluntary contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary employer matching and profit-sharing contributions plus earnings thereon is based upon years of service, as defined by the Plan. A participant becomes 100% vested after five years of credited service with graduated vesting beginning after two years of credited service earning 20% per year after the second, third and fourth year, increasing to 40% through the fifth year.

**Forfeitures**

The non-vested portion of discretionary employer matching and profit-sharing contributions of terminated participants are used to reduce future discretionary employer matching and profit-sharing contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$22 and \$0. No forfeitures were used to reduce the employer's contribution during the year ended December 31, 2024.

**Notes Receivable from Participants**

Participants may borrow from their account up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The minimum loan amount is \$1,000. The loans are secured by the balance in the participant’s account and bear interest at a reasonable fixed rate determined by the Loan Administrator. The loans are repaid through direct withdrawal from participant bank accounts.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement or separation, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account, installment payments or a transfer into another qualified retirement plan. Benefits are recorded by the Plan when paid.

**Administrative and Investment Management Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping, trustee fees, and Plan audit fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in net appreciation in fair value of investments by the Plan. Revenue sharing income received by the Plan is utilized to pay Plan expenses.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates in the Preparation of Financial Statements**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administration to make estimates and assumptions that affect certain reported amounts of assets and liabilities, revenues and expenses as well as disclosures provided. Future results could differ from those current estimates.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses as repayments of principal and interest are received through direct bank account deductions and the notes are collateralized by the participants’ account balances.

**Risks and Uncertainties**

The Plan provides for various investment options, including mutual funds and a guaranteed investment contract. The underlying investment securities are exposed to various risks such as liquidity, interest rate, market and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**Investment Valuation and Income Recognition**

The Plan’s investments, other than fully benefit responsive investment contracts, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan’s principal or most advantageous market for the asset or liability. The investment contract with the insurance company is reported at contract value. Contract value is the relevant measure for the Plan’s fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Subsequent Events**

For the year ended December 31, 2024, plan management has evaluated subsequent events for potential recognition and disclosure through September 30, 2025, the date the financial statements were available to be issued.

**NOTE 3 - PLAN TERMINATION**

Although there is no intent to do so, the Plan can be terminated by the sponsor at any time. In the event the Plan terminates, all accounts shall become 100% vested and the accrued benefits in an employee’s individual account will be distributed in accordance with the terms of the Plan agreement.

**NOTE 4 - INFORMATION CERTIFIED BY THE PLAN’S TRUSTEE**

Substantially all information pertaining to the Plan’s investments and notes receivable from participants included in the financial statements, including the associated investment income (loss) and interest earned on notes receivable from participants, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. This information has not been audited by independent accountants.

**NOTE 5 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

**Mutual Funds**

The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

**NOTE 6 - INVESTMENTS AT CONTRACT VALUE**

The Plan holds a traditional fully benefit-responsive investment contract with The Lincoln National Life Insurance Company (“Lincoln”; Issuer) that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. Contract value was \$1,996,880 and \$1,683,168 at December 31, 2024 and 2023, respectively.

Lincoln maintains the contributions in its general account. The Issuer guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than the guaranteed minimum interest rate, as shown on the contract specifications. Lincoln’s general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan’s investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances, which would allow the Issuer to terminate the contract, include the Plan’s uncured material breaches of responsibilities, misrepresentation of material information and the issuer discontinuing offering the contract to the public. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

**NOTE 7 - RELATED PARTY TRANSACTION**

Certain Plan investments are shares of mutual funds and a fully benefit-response investment contracts managed by Lincoln Financial Group Trust Company, Inc. Lincoln Financial Group Trust Company, Inc. is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of the investment, as they are paid through revenue sharing rather than a direct payment. The Plan made direct payments to third-party service providers of \$68,062. The Plan sponsor pays directly any other fees related to the Plan’s operation.

**NOTE 8 - INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 2, 2023 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. Plan management believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress.
