The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the 403(b) Thrift Plan of United Way, Inc. (the "Plan") is provided for general information purposes only. Participants should refer to the plan document and any amendments for more complete information.

A. General

The Plan was established to provide retirement benefits to all employees of United Way, Inc. (the "Employer" or "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended and subsequent related legislation.

B. Contributions

Participants may make voluntary contributions up to the limitations imposed by the Internal Revenue Code (the "Code"). Rollovers are also allowed. The Employer will match 50% of the first 6% of each eligible participant's compensation contributed during the Plan year. Participants are eligible for employer contributions upon reaching age 21 and completing one year of service.

C. Eligibility

All employees, except for nonresident aliens with no United States source income and employees eligible to make salary deduction contributions to another plan of the Company, are eligible to participate in the Plan. There are no age or service requirements.

D. Participant Accounts

Each participant's account is credited with the participant's contributions, employer matching contributions, rollovers and allocations of Plan earnings, and charged with withdrawals and an allocation of administrative expenses. Allocations of Plan earnings are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from his or her vested account.

E. Vesting

Participants are immediately vested in their contributions, rollovers, and earnings thereon.

Employer contributions and earnings are vested as follows:

Employer contributions and earnings shall also become 100% vested if the Plan is terminated or if the participant should:

- 1) Retire, die or become disabled; or
- 2) reach age 65 and have five years of participation while employed.

F. Investments

Participants direct the investment of their contributions among investment options offered by the Plan.

G. Forfeitures

Any portion of a participant's account that is not vested shall be forfeited as of the date of distribution of the vested portion. If the participant is re-employed within five years of the date terminated, the forfeited portion of his or her account as of the distribution date shall be restored from available forfeitures or from Employer contributions. All forfeitures will be applied to offset administrative expenses and Employer contributions to the Plan. Unapplied forfeitures totaled \$0 and \$5,038 as of December 31, 2024 and 2023, respectively. During 2024, forfeitures of \$35,636 were used to offset employer contributions.

H. Participant Loans

At the discretion of the Plan's administrator, a participant may borrow from the custodian a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. Loans are secured by the participant's vested account balance in his or her Mutual of America Interest Accumulation Fund. The loan term may generally not be longer than five years unless for the purchase of the participant's primary residence, for which the term may extend to up to ten years. Loans are repaid in periodic payments by the participants to the custodian. Loan interest is calculated using a variable rate set by Mutual of America and is subject to change at the beginning of each calendar quarter. Loan interest rates were 5.85% as of December 31, 2024.

I. Payment of Benefits

Benefit distributions under the Plan may be made in the form of a single lump sum payment or installment payments and are recorded when paid. Normal retirement age is 65 years; early retirement is allowed in this Plan at 55 years. Benefits may also be paid upon death, disability, termination of employment or termination of the Plan. Hardship withdrawals are permitted.

J. Risks and Uncertainties

The Plan provides for various investment options in any combination of investment funds offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in equity markets, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

B. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Pooled separate accounts are reported at fair value using net asset value per share ("NAV") as a practical expedient and have not been classified in the fair value hierarchy. They may be redeemed any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares. Unallocated insurance contracts are reported at contract value. Contract value represents contributions made under a contract, plus earnings, less participant withdrawals and administrative expenses.

Interest is recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis.

D. Administrative Expenses

Substantially all costs of operating the Plan are paid by the Employer.

NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company, the custodian of the Plan.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested and the funds of the Plan will be distributed based on individual participant balances.

NOTE 5 - TAX STATUS

Section 403(b) tax deferred annuity plans are not required to obtain determination letters from the Internal Revenue Service stating they are qualified under the Code. The plan administrator believes the Plan has been designed and operated to comply with applicable requirements of the Code and is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the custodian or its affiliates. Any purchases and sales of these investments, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 7 - INTEREST ACCUMULATION ACCOUNT

The Plan's Interest Accumulation Account is a fully benefit-responsive contract with Mutual of America comprising unallocated insurance contracts. Contributions to the Interest Accumulation Account are maintained in a principal general account and credited for interest and charged for participant withdrawals and administrative expenses. Mutual of America is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Interest Accumulation Account meets fully benefit-responsive investment contract criteria and is reported at contract value.

Contract value is the relevant measure for fully-benefit responsive investment contracts, because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan.

The crediting rate is based on a formula established by Mutual of America but may not be less than 2.85% percent. MOA determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year. The crediting rate for the years ended December 31, 2024 and 2023 was 2.85% and 1.60%, respectively. Interest is compounded daily to produce the stated effective annual yield.

The Plan's ability to receive amounts due is dependent on Mutual of America's ability to meet its financial obligations. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Interest Accumulation Account. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 3, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
