Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Kerr Pumps 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A--PLAN DESCRIPTION

The following description of the Kerr Pumps 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for more complete information.

General: The Plan is a defined contribution plan covering substantially all employees of Kerr Machine Co. d/b/a Kerr Pumps and Flow Valve, LLC (collectively referred to as the “Company”) who have completed one year of service, as defined in the Plan document, and are age 21 or older. Eligible employees may enroll in the Plan on January 1st or July 1st of each plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company enacted the Plan effective January 1, 2015.

Contributions: Participants may make elective deferrals to the Plan up to the annual limitations imposed by the IRS of \$23,500 for 2024. Plan participants age 50 and older were eligible to make a catch-up contribution of an additional \$7,500 to the Plan for 2024. Rollover contributions are permitted under the Plan agreement.

The Plan provides for the Company to make safe harbor and discretionary matching contributions to the Plan. During the year ended December 31, 2024, the Company made safe harbor matching contributions of 100% of a participant’s contributions up to 3% of the participant’s eligible compensation and 50% of a participant’s contribution between 3% and 5% of eligible compensation. Additionally, the Company, at its discretion, may elect to make profit-sharing or other contributions to the Plan. The Company did not make any discretionary profit sharing or other contributions to the Plan during the year ended December 31, 2024.

Vesting: Participant contributions, safe harbor match contributions and earnings thereon are fully vested at all times. Discretionary profit sharing or other contributions become 20% vested after 2 years of service and continue to vest at a rate of 20% for each successive year of service until 100% vested after 6 years of service.

Payment of Benefits: Participants who terminate employment due to death, permanent disability or normal retirement may receive all benefits in a lump-sum payment equal to the value of the participant’s vested account balance. For termination of service due to other reasons, a participant may receive the value of their vested interest as a lump-sum distribution. At December 31, 2024, net assets available for benefits included approximately \$243,000 relating to former participants who have elected, for the present time, to leave their balances intact with the Plan.

NOTE A--PLAN DESCRIPTION--Continued

Investment Options: Participant accounts are 100% participant directed. Upon enrollment, participants may direct their contributions, in any increments, to any of the investment options provided by the custodian. The investments are allocated to a selection of various mutual funds and pooled separate accounts which are registered under the Investment Company Act of 1940.

Participant Accounts: Each participant's account is credited with the participant's contributions; the Company's matching contributions and the allocation of Plan earnings. Allocations are based on the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Administration: A Company employee serves as the Plan Administrator having overall responsibility for the Plan. This includes the power to interpret the provisions of the Plan, determine questions concerning eligibility, participation and benefits, and such other powers and duties as are necessary to the operation of the Plan. The Company pays a portion of the costs of the Plan.

Income Tax Status: The IRS has ruled that the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Forfeitures: Forfeitures can be used to offset future employer contributions. As of December 31, 2024 and 2023 there were no unused forfeitures.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

Subsequent Events: Subsequent events have been evaluated through September 8, 2025, which is the date the financial statements were available to be issued. Management has determined that there were no subsequent events requiring adjustment to or disclosure in the financial statements.

NOTE C--INVESTMENT CONCENTRATION, RISKS AND UNCERTAINTIES

As of December 31, 2024 approximately 73% of Plan assets consist of five pooled separate accounts.

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE D--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820-10-35-39 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts - mutual funds: Investments represented by a unit of account whose per unit value is the result of the accumulated values of the underlying investments. The underlying investments are investment vehicles valued using net asset value (NAV) per share. The NAV is based upon the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The underlying investments consist of mutual funds that are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than a direct payment. The Company pays directly any other fees related to the Plan's operations.

During the year end December 31, 2023, the Plan had participant contributions that were withheld from participants' compensation but were not segregated from the Company's assets within seven calendar days totaling approximately \$389,000. These transactions represented loans from the Plan to the Company for the period between the seventh business day following the payroll date in which the amounts were withheld through the date that the withholdings were separated from the Company's assets, which was at the time they were remitted to the Plan. Late remittances of participant contributions constitute a prohibited transaction under ERISA Section 406. The delinquent contributions were remitted during the Plan year, and lost earnings were remitted in 2025.

During the year end December 31, 2024, the Plan had participant contributions that were withheld from participants' compensation but were not segregated from the Company's assets within seven calendar days totaling approximately \$39,000. These transactions represented loans from the Plan to the Company for the period between the seventh business day following the payroll date in which the amounts were withheld through the date that the withholdings were separated from the Company's assets, which was at the time they were remitted to the Plan. Late remittances of participant contributions constitute a prohibited transaction under ERISA Section 406. The delinquent contributions were remitted during the Plan year, and lost earnings were remitted in 2025. The Company does not believe the amount of any lost earnings, interest or penalties required to be paid by the Company will be significant.
