Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hart InterCivic, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTE A - DESCRIPTION OF PLAN

The following description of the Hart InterCivic, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Hart InterCivic, Inc. (the Company). The Plan became effective May 1, 1999, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Significant plan provisions are summarized below.

Eligibility

Employees are eligible to participate in the Plan on the date of employment. Under the enrollment provisions of the Plan, eligible employees are allowed to enter the Plan on the exact day of completion of eligibility requirements. The Plan also provides for an automatic enrollment of the employee when eligible unless they opt out.

Contributions

Participants are allowed to make voluntary salary deferral contributions to the Plan subject to limitations imposed by the Internal Revenue Service (IRS). The Company may make discretionary contributions to the Plan of amounts determined and authorized by the Company's Board of Directors up to the maximum amounts permitted by the IRS. The Company also makes safe harbor contributions into the Plan at 3% of the employee salary. In accordance with the plan requirements, forfeitures are used as employer discretionary contributions. Participants direct investment allocation of all contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and company contribution, if any. Plan earnings are allocated based on a daily valuation of each participant's individual investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Provisions

Participants are immediately vested in their contributions, the Company's safe harbor contributions, and earnings thereon. The Company's discretionary contributions vest according to a graduated schedule over four years.

Participant Loans

Participants are allowed to borrow a maximum amount of 50 percent of the participant's vested account balance up to \$50,000. Loans are amortized over a maximum of 60 months, unless the purpose of the loan is for the purchase of the principal residence of the participant, in which case the loan may be repaid over a reasonable period of time that may be longer than 60 months to a maximum of 120 months. Repayment is made through payroll deductions with equal installments made each pay period. The loans are collateralized by the vested balance in the participant's account, not to exceed 50 percent of the vested balance, and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator.

Payment of Benefits

Upon termination of service, participants or their beneficiaries are eligible for distribution of their vested benefits, or upon reaching the normal retirement date, which is 65 years of age, participants will be entitled to 100 percent of account balance.

Participant Hardship Withdrawals

Under certain conditions of financial hardship, a participant may withdraw all or any portion of their contributions during employment. Financial hardship expenses include deductible medical expenses, funds for the purchase of a principal residence, tuition and related educational expenses for a participant, spouse or dependents, and funds to prevent eviction or mortgage foreclosure on a principal residence. Once a participant receives a hardship withdrawal, their contributions will be suspended for six months.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Plan Termination - Continued

In the event of the termination of the Plan, the individual accounts of all members shall become fully vested. After deducting all charges and expenses, the balances of all individual accounts will be adjusted and the remaining assets distributed.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments

In accordance with Accounting Standard Codification (ASC) 820, *Fair Value Measurements*, issued by the Financial Accounting Standards Board (FASB), the Plan's investments are reported at fair value. FASB ASC 820 establishes a framework for measuring fair value. Purchases and sales of securities are recorded on the trade-date basis. Dividends are recorded on the ex-dividend date. Net loss or gain on pooled separate accounts include realized and unrealized gains and losses.

Distributions

Distributions to participants are recorded by the Plan when actual payment is made. Distributions not paid, as of the end of the plan year, are included in investments in the Statements of Net Assets Available for Benefits.

Expenses

Generally, all plan expenses are paid by participants of the Plan or by the Plan, itself. The plan sponsor may, at its discretion, pay any such expenses.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator and management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and schedule. Accordingly, actual results may differ from those estimates.

Fair Value Measurements

The Plan follows ASC 820, issued by the FASB. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

As permitted by the rules and regulations of the Department of Labor with respect to reporting and disclosure under ERISA, Voya Retirement Insurance and Annuity Company has certified to the Plan Administrator that the investments and participant loans, together with all other transactions which affect plan assets, are complete and accurate.

The Plan's investments and participant loans are held by Voya Retirement Insurance and Annuity Company. Investments are presented at fair value as determined by the trustees. NOTE D - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan offers plan participants the option to invest in a guaranteed interest contract with an insurance company. The insurance company maintains an unallocated fund to which it adds interest. Withdrawals are permitted at any time without penalty and the contract has been determined to be fully benefit responsive as defined in FASB ASC 962. The investment is reported at contract value on the Statements of Net Assets Available for Benefits.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (c) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE E - PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, the Plan paid various service providers administrative, accounting, and consulting fees of \$54,405 and \$46,059, respectively.

NOTE F - FORFEITURES

Forfeitures result from non-vested benefit payments remaining in the Plan for terminated employees. Forfeitures are available to offset employer contributions. For the years ended December 31, 2024 and 2023, there were no forfeitures used. As of December 31, 2024 and 2023, there were no forfeitures available for use.

NOTE G - INCOME TAX STATUS

The Plan is a qualified plan under IRS Code Section 401(a) and is not required to apply for a determination letter. The Plan obtains its reliance on an opinion letter, which has been approved by the IRS. The Plan Administrator believes that the Plan is qualified and, therefore, the related trust is exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
