- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by the qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgement and maintain professional skepticism throughout the audit.

Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion,

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the RefrigiWear, LLC Employees’ 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more detailed description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of RefrigiWear, LLC (the Company), as defined in the Plan document. The following employees are excluded from participating in the Plan: employees covered under a collective bargaining agreement, non-resident aliens, residents of Puerto Rico, and employees who work less than 20 hours per week. All employees are eligible for participation after they have attained age 21 and completed three months of service and are able to enter the Plan on the first day of the month after the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each participant may make pre-tax and/or Roth contributions of up to 100% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus an additional \$7,500 catch-up contribution for participants who have reached at least 50 years of age by the end of the year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company makes safe harbor matching contributions to the account of each eligible participant in an amount equal to the sum of 100% of the amount of the participant’s elective deferrals up to 3% of the participant’s compensation, plus 50% of the amount of the participant’s elective deferrals between 3% and 5% of the participant’s compensation.

Each year, the Company may also make discretionary matching contributions for the Plan year and on a payroll period basis. There were no discretionary matching contributions for 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, rollovers, any Company contributions and earnings and losses on the investments in their account and is charged with certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions and safe harbor matching contributions, plus actual earnings thereon. For the Company's discretionary matching contributions and earnings thereon, participants vest 20% after two years of service, then 20% per year thereafter until they are fully vested after 6 years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have one loan outstanding at any time. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest. As of December 31, 2024, loans had fixed rates ranging from 4.25% to 9.50% for the term of the note, not to exceed 5 years, or 15 years if used for the purchase of a residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

At the time of death, disability, termination of employment, or retirement, a participant or their beneficiary may elect to receive a payment of the vested interest in their account in a lump sum distribution or installment payments. Participants are eligible to receive hardship withdrawals when certain conditions are met. After attaining the age of 59½, participants may also be eligible to make a withdrawal of all or any part of their vested account.

Forfeited Accounts

Forfeited non-vested account balances totaled \$7,261 and \$7,054 as of December 31, 2024 and 2023, respectively. These accounts may be used to pay Plan administrative expenses or reduce future Company matching contributions. There were \$34 of forfeitures used to pay expenses in 2024.

Administrative Expenses

The Plan document allows for certain administrative expenses to be paid by the Plan. Expenses paid by the Plan included recordkeeping and advisory fees paid to service providers of the Plan. These expenses paid to the various service providers qualify as party-in-interest transactions. Certain account activity charges are paid from the accounts of participants that incur the charge. All other administrative Plan expenses are paid by the Company. The Company does not expect reimbursement from the Plan for these expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company safe harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. The Company discretionary matching contributions are payable to the Plan when the related participant's contributions are payable to the Plan and approved by the Company. Any unfunded participant or Company matching contributions are included as contributions receivable in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value, except for the guaranteed interest account, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments and net change in contract value of guaranteed interest account include interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make notes receivable repayments and the Plan administrator deems the participant notes receivable to be in default, the participant

notes receivable balance is reduced and a benefit payment is recorded. Notes receivable from participants qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

As of December 31, 2024, the Company had not adopted any provisions of the SECURE 2.0 Act of 2022. However, subsequent to year-end, management indicated its intent to adopt certain provisions effective January 1, 2025, in accordance with the Act’s implementation timeline. The Company is currently evaluating the impact of these changes, and formal plan amendments are expected to be made prior to the December 31, 2026 deadline.

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institutions

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants as of December 31, 2024 and 2023 and the net change in fair value and contract value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, Empower), the Plan’s qualified institutions.

4. Investments

Plan investments include shares of a guaranteed interest account (GIA) managed by service providers of the Plan. Accordingly, transactions in this investment qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in the net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include a healthcare crisis, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences,

significant cyber security attacks, or other similar events. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan holds an investment in a fully benefit-responsive GIA with MassMutual Insurance Company (MassMutual), which is managed by Great-West Investments, a subsidiary of Empower. The GIA is a stable value investment with a guaranteed rate of return and a guarantee of principal that is backed by the MassMutual general investment account. The GIA is provided through a group annuity contract issued by MassMutual to the Plan. MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Under the contract, MassMutual is contractually obligated to repay the principal and interest that is calculated on a quarterly basis, based on the agreement with the Plan. The average rate for the investment in the Plan for 2024 was 3.0%. MassMutual assumes market, credit, and interest rate risk for the assets supporting the GIA. Contract value is the relevant measure for fully-benefit

responsive contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contracts. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Participants may transact in the fund daily, and the net asset value of the fund is determined daily. Units are issued and redeemed at the latest net asset value. Contract value approximates fair value. The GIA has restrictions on withdrawals up to one year in the event the Company eliminated the investment option.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Company discretionary matching contributions.

6. Income Tax Status

The Plan has adopted a prototype plan document sponsored by Empower Retirement, LLC (Empower Retirement), an affiliate of the qualified institutions. Empower Retirement received an opinion letter from the Internal Revenue Service, dated November 14, 2022, which states that the prototype document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received an individual determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan’s income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
