Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the financial statements of Metropolitan Development Council 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion



NOTE 1 - DESCRIPTION OF PLAN

The following description of the Metropolitan Development Council 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan's sponsor is Metropolitan Development Council (the "Organization").

General

The Plan is a defined contribution plan. An eligible employee will be able to make elective deferrals beginning on the date of hire. An eligible employee will receive the employer matching contribution after one year of service, or earlier, after 120 consecutive days of employment, depending on employment status. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute the maximum allowed under Internal Revenue Code Section 402(g), which is \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans ("rollovers"). The Organization may contribute a discretionary percentage of the amount of participant elective deferrals.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Organization's contributions and earnings on the investments in their account, and is charged with administrative fees. Participants direct the investment of their account into various investment options offered by the Plan. Participants may change their investment options at any time with certain trading restrictions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their vested balance, as of the most recent valuation date. Loan repayment terms, including interest rate and length of loan are determined at the time the loan is made and range from one to five years. The loans are secured by the balance in the participant's account and bear interest at 4.25% - 10.50% at December 31, 2024, and 4.25% - 9.75% at December 31, 2023. Principal and interest are paid ratably through monthly payroll deductions.

Vesting

Participants are immediately vested in contributions from salary deferrals, plus actual earnings and the Organization's matching contribution.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Payment of Benefits

On termination of service due to retirement, death or disability, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum, an annuity or a series of payments made over a period of time not exceeding the life expectancy of the participant or the designated beneficiary. Benefits are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

Investments in bonds and mutual funds are based on quoted market prices for the identical security in an active market. Insurance contracts are based on the Plan's own assumptions of how knowledgeable parties would price assets. Participant notes receivable are carried at their outstanding balances as of the year-end. Purchases and sales of securities are recorded on the trade-date basis. Unrealized appreciation or depreciation in investments held is the adjustment to reflect fair value of investments held at year-end. Net appreciation in fair value of investments includes realized and unrealized gains and losses on those investments bought and sold, as well as held during the year.

Participant Transaction Fees

The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. However, substantially all administrative expenses of the Plan are paid by the Organization. Expenses relating to specific participant transactions are charged directly against the appropriate participant's account. Investment-related expenses are included in net appreciation in fair value of investments.

Fees incurred by the Plan for the investment management services or recordkeeping that are paid through revenue sharing rather than a direct payment are included in net appreciation in fair value of investments.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal and most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. The three levels of fair value hierarchy are as follows:

Level 1

Inputs are unadjusted quoted prices in active markets for identical assets or liabilities accessible to the reporting entity at the measurement date.

Level 2

Inputs other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly.

Level 3

Inputs are unobservable inputs that cannot be corroborated by observable market data for the asset or liability.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United State of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The Trustees of the Plan evaluated subsequent events and transactions for potential recognition and disclosure through September 9, 2025, the date the financial statements were available to be issued.

NOTE 3 - INFORMATION CERTIFIED BY PLAN TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted with this election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Plan's Trustees, ReliaStar Life Insurance Company and Advisor Trust Inc., except for comparing such information to information included in the Plan's financial statements and supplemental schedule. ReliaStar Life Insurance Company and Advisor Trust Inc. certified that the information provided is complete and accurate.

NOTE 4 - INVESTMENTS

The Plan's investments, including gains and losses on investments bought and sold, as well as held during the year, appreciated in value by \$440,208 during the year ended December 31, 2024.

NOTE 5 - TAX STATUS

The Internal Revenue Service has determined and informed the Organization that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. The plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - RELATED PARTY TRANSACTIONS

Certain Plan investments may be shares of mutual funds and money market funds managed by ReliaStar Life Insurance Company, Advisor Trust Company and American Funds, the Trustees of Plan assets. Therefore, transactions with ReliaStar Life Insurance Company, Advisor Trust Company and American Funds qualify as party-in-interest transactions. Advisor Trust Company fees totaled \$71,370, and American funds fees totaled \$40 for the year ended December 31, 2024.

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officers or employees receive compensation from the Plan.

The Organization has retained the services of a third-party administrator and investment custodian to perform other administrative functions. The Organization pays for certain fees and expenses on behalf of the Plan. Administrative expenses incurred by non-active employees are paid by the individual participant.

Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the financial statements of Metropolitan Development Council 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion



NOTE 1 - DESCRIPTION OF PLAN

The following description of the Metropolitan Development Council 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan's sponsor is Metropolitan Development Council (the "Organization").

General

The Plan is a defined contribution plan. An eligible employee will be able to make elective deferrals beginning on the date of hire. An eligible employee will receive the employer matching contribution after one year of service, or earlier, after 120 consecutive days of employment, depending on employment status. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute the maximum allowed under Internal Revenue Code Section 402(g), which is \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans ("rollovers"). The Organization may contribute a discretionary percentage of the amount of participant elective deferrals.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Organization's contributions and earnings on the investments in their account, and is charged with administrative fees. Participants direct the investment of their account into various investment options offered by the Plan. Participants may change their investment options at any time with certain trading restrictions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their vested balance, as of the most recent valuation date. Loan repayment terms, including interest rate and length of loan are determined at the time the loan is made and range from one to five years. The loans are secured by the balance in the participant's account and bear interest at 4.25% - 10.50% at December 31, 2024, and 4.25% - 9.75% at December 31, 2023. Principal and interest are paid ratably through monthly payroll deductions.

Vesting

Participants are immediately vested in contributions from salary deferrals, plus actual earnings and the Organization's matching contribution.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Payment of Benefits

On termination of service due to retirement, death or disability, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum, an annuity or a series of payments made over a period of time not exceeding the life expectancy of the participant or the designated beneficiary. Benefits are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

Investments in bonds and mutual funds are based on quoted market prices for the identical security in an active market. Insurance contracts are based on the Plan's own assumptions of how knowledgeable parties would price assets. Participant notes receivable are carried at their outstanding balances as of the year-end. Purchases and sales of securities are recorded on the trade-date basis. Unrealized appreciation or depreciation in investments held is the adjustment to reflect fair value of investments held at year-end. Net appreciation in fair value of investments includes realized and unrealized gains and losses on those investments bought and sold, as well as held during the year.

Participant Transaction Fees

The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. However, substantially all administrative expenses of the Plan are paid by the Organization. Expenses relating to specific participant transactions are charged directly against the appropriate participant's account. Investment-related expenses are included in net appreciation in fair value of investments.

Fees incurred by the Plan for the investment management services or recordkeeping that are paid through revenue sharing rather than a direct payment are included in net appreciation in fair value of investments.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal and most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. The three levels of fair value hierarchy are as follows:

Level 1

Inputs are unadjusted quoted prices in active markets for identical assets or liabilities accessible to the reporting entity at the measurement date.

Level 2

Inputs other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly.

Level 3

Inputs are unobservable inputs that cannot be corroborated by observable market data for the asset or liability.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United State of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The Trustees of the Plan evaluated subsequent events and transactions for potential recognition and disclosure through September 9, 2025, the date the financial statements were available to be issued.

NOTE 3 - INFORMATION CERTIFIED BY PLAN TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted with this election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Plan's Trustees, ReliaStar Life Insurance Company and Advisor Trust Inc., except for comparing such information to information included in the Plan's financial statements and supplemental schedule. ReliaStar Life Insurance Company and Advisor Trust Inc. certified that the information provided is complete and accurate.

NOTE 4 - INVESTMENTS

The Plan's investments, including gains and losses on investments bought and sold, as well as held during the year, appreciated in value by \$440,208 during the year ended December 31, 2024.

NOTE 5 - TAX STATUS

The Internal Revenue Service has determined and informed the Organization that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. The plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - RELATED PARTY TRANSACTIONS

Certain Plan investments may be shares of mutual funds and money market funds managed by ReliaStar Life Insurance Company, Advisor Trust Company and American Funds, the Trustees of Plan assets. Therefore, transactions with ReliaStar Life Insurance Company, Advisor Trust Company and American Funds qualify as party-in-interest transactions. Advisor Trust Company fees totaled \$71,370, and American funds fees totaled \$40 for the year ended December 31, 2024.

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officers or employees receive compensation from the Plan.

The Organization has retained the services of a third-party administrator and investment custodian to perform other administrative functions. The Organization pays for certain fees and expenses on behalf of the Plan. Administrative expenses incurred by non-active employees are paid by the individual participant.
