Independent Auditor's Report

To the Board of Trustees of

Opinion

Independent Auditor's Report

To the Board of Trustees of
Upstate Union Health and Welfare Fund

Opinion

We have audited the accompanying financial statements of Upstate Union Health and Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Upstate Union Health and Welfare Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Upstate Union Health and Welfare Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Upstate Union Health and Welfare Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.



Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Upstate Union Health and Welfare Fund's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Upstate Union Health and Welfare Fund's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Supplemental Schedules Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets (held at end of year) and the supplemental schedule of reportable transactions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The supplemental schedules of administrative expenses are presented for purposes of additional analysis and are not a required part of the financial statements. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to



prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule of assets (held at end of year) and the supplemental schedule of reportable transactions, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AND PLAN DESCRIPTION

Operations

The Upstate Union Health and Welfare Fund (the Fund) is a multi-employer collectively bargained employee benefit plan. Its purpose is to provide health care benefits to members with union agreements calling for contributions to the Fund. The Fund is located in Syracuse, New York, and covers participants in the upstate and central regions of New York State.

Description of Plan

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

This Plan is a multiemployer Plan established pursuant to collective bargaining agreements between Local Union No. 317 of the International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America (the Union) and employers who make contributions to this Plan pursuant to the terms of their collective bargaining agreements with the Union. The purpose of this Plan is to provide comprehensive welfare benefits to employees covered by collective bargaining agreements between the Union and Contributing Employers, and to the eligible dependents of such employees.

The Plan is funded entirely by employers' contributions, members' and retirees' self-pay contributions, and earnings on investments. The employers' contributions are at either a fixed rate per hour, a fixed rate per week or a fixed rate per month for employees covered by the current bargaining agreement. Members making self-pay contributions pay the entire cost of their medical coverage. Net assets available for benefits are reserved for the payment of future benefits to the eligible participants and their dependents and for the cost associated with the administration of such plan.

The Plan is administered by a Joint Trustees Committee composed of contributing employers and union trustees. While the intent of the Trustees is to continue the Plan, it may be terminated at an indefinite point in the future by the Trustees. Upon termination of this Plan, participants and beneficiaries would have no further right or vested interests in the Plan. In the event of Plan termination, the net assets will be allocated as prescribed by ERISA and regulations pursuant thereto.

Participation

A participant is any employee where contributions are made on their behalf by any of the employers contributing to the Fund. The employee must belong to a class of employees covered by this Plan. A qualified retiree or a legal spouse may participate in the Medicare Supplement Program, if the participant is a retired member of the Union and has Part A and Part B Medicare coverage.

Benefits

Health Related Benefits - The Plan provides health benefits (medical, hospital, surgical, major medical, dental, and optical) to participants and their eligible dependents. Health claims of participants and their dependents are provided under group insurance contracts with The Guardian Insurance Company, Aetna, CIGNA, Davis Vision and Excellus Blue Cross Blue Shield which are either community rated or experience rated contracts.

Insurance - The Plan provides \$25,000 of group life insurance to participants through The Guardian Insurance Company.

Legal - The participant is provided with fully covered services for real estate transactions, wills and estates, family law, debt matters, vehicle and traffic matters and consumer related matters. There are also limited coverage matters provided where the plan pays a portion of the legal fee and the balance is paid by the participant.

Health Reimbursement Account - Health Reimbursement Accounts help participants pay for certain medical costs not covered by the Plan. There are no longer contributions for active participants going into the Health Reimbursement Accounts. The only remaining Health Reimbursement Accounts are for retired participants. The Health Reimbursement Accounts are administered by a third party, UMR.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting and follow the provisions of the Financial Accounting Standards Board's, "Accounting and Reporting by Health and Welfare Benefit Plans" for reporting purposes.

Contributions Receivable

Contributions receivable from participating employers are valued at cost and are accrued based upon contribution reports received subsequent to the year-end, which include contributions due in the current year. The Fund has not recorded an allowance, as all receivables are deemed collectible. Management's policy is to write off receivables when they are determined to be uncollectible.

Investment Valuation and Income Recognition

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the statements of changes in net assets available for benefits includes the Fund's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The assets of the Fund will be used to pay all expenses of the administration of the Fund. Administrative expenses generally consist of professional fees, office, insurance and other expenses. Investment related expenses are included in net investment income.

Payment of Benefits

Benefits are recognized when due.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AND PLAN DESCRIPTION (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 2 RISKS AND UNCERTAINTIES

The Fund invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 3 FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board authoritative guidance on fair value measurement establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Fund has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 3 FAIR VALUE MEASUREMENTS (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Short-Term Investments: Comprised of money market accounts which are valued at cost which approximates fair value.

Mutual Funds and Exchange-Traded Funds: Valued at the daily closing price as reported by the fund. Mutual funds and exchange-traded products held by the Fund are open-ended mutual funds or exchange-traded products that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and exchange-traded products held by the Fund are deemed to be actively traded.

Limited Liability Company: Beacon Associates LLC II (a limited liability company) is valued at fair value as determined by the investment manager. Fair value represents the Fund's proportionate share of the net asset value of the investment company's underlying assets. The Trustees are responsible for oversight of investment valuation policies and procedures. The Trustees are provided with information sufficient to evaluate and determine fair values such as support from the investment manager, quarterly capital reports, and most importantly annual independent audits and appraisals.

All assets have been valued using a market approach, except for the limited liability company as noted above.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Fund believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) In accordance with Subtopic 820-10, certain investments that are measured at fair value using net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of the net assets available for benefits.

NOTE 4 INVESTMENTS

Beacon Associates LLC II (a limited liability company) indirectly owned assets held at Bernard Madoff Investment Securities, LLC (Madoff). On December 11, 2008, Bernard L. Madoff was charged with criminal and civil securities fraud including investment advisor fraud, money laundering, filing false statements, and theft. On March 12, 2009, Bernard Madoff admitted to eleven felony counts which stem from a Ponzi scheme he developed utilizing client assets. Investments held indirectly with Beacon were revalued based upon estimates provided by Beacon Andover Group. In September 2010, the Fund received a distribution that was approximately 75% of its capital account. In October 2013, the Fund received a distribution representing their allocation of the available non-Madoff cash in Beacon as well as a portion of the Madoff Bankruptcy Trustee Settlement proceeds approved by the District Court.

The Fund continues to receive settlement proceed distributions from Beacon as Beacon receives court ordered distributions and judgments from the Madoff Bankruptcy Trustee. The Fund received distributions from Beacon amounting to \$1,260 and \$4,710 during the years ended December 31, 2024 and 2023, respectively.

NOTE 5 TAX STATUS

The trust established under the Plan to hold the Fund's net assets is qualified pursuant to Section 501 (c) (9) of the Internal Revenue Code, and accordingly, the Trust is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6 RELATED-PARTY TRANSACTIONS

The Union Trustees of the Fund are either officers or business agents of the Union. There are no compensation arrangements between the Fund and the Union. The Union Trustees provide their time and effort to the Fund on an unpaid basis.

NOTE 7 PARTY IN INTEREST

A party-in-interest is defined under the Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan or an employer whose employees are covered by the Plan. The Plan pays expenses related to Plan operations and investment activity to various service providers. Therefore, payments to such service providers by the Plan qualify as party-in-interest transactions.

NOTE 8 FIDELITY BOND COVERAGE

The Fund presently carries Fidelity Bond Insurance in the amount of \$500,000, which is the maximum amount required.
